Sheriff Glen will be leaving office after this upcoming election. I wanted to pick his brain on some recent findings he had concerning the 2020 election in Sierra County. I have been in contact with a local guy by the name of Jack Noel and he has been working with Sheriff Glen and others and they have been meeting with our County Clerk Shelly Trujillo to see if there was fraud in our County for the 2020 election. Basically, the glaring irregularity in the 2020 election for Sierra County was the mail in votes. Normally, Sierra gets 400 mail in ballots for a general election but in 2020 it got over 1600. And they were not all verified correctly. Next to the Dominion machines mail-in ballots were the next biggest source of election corruption during the 2020 election. Under the guise of not wanting to spread or catch Covid, mail-in ballots were heavily promoted and this lead to ballot harvesting and other abuses which gave Biden a huge advantage. (See the movie 2000 Mules to see what went on.) Sheriff Glenn is a proponent of getting rid of the Dominion machines so it was good to touch base with a like minded person. Who I call a RINO, (Republican In Name Only) says the machines are not the problem. I had a talk with him at the BBQ and immediately tried to refute that machines are the main cause of corruption of the election. His big thing is early voting. “We got to get out the vote Will!” Which OK, it’s not the worst thing to promote. But here’s the deal, people who are truly against the voting machines are against early voting and here’s why. If your opposing party has access to voter rolls (note: in New Mexico they do) and you have a large turnout for early voting the opposing party will know how many people have not voted and then they can set the algerhythms for how many votes they need to flip a precinct or county. If you have a huge same day voter turnout they won’t know how much they need to set the algorithms for. I agree, there are exceptions to the rule if you are going to be out of town or starting to feel sick right before the Election Day than yes early vote. Being in the current situation that we are in with the machines and what happened in 2020 I would not make a hard push for early voting. Also, I have noticed that people who really promote early voting really are not concerned about the machine situation. They may pay lip service but their actions speak louder than words.

As I stated above, New Mexico has a left wing organization that gets access to our voter rolls. It’s called ERIC (Electronic Registration Information Center) and it was founded by a far left activist called David Becker. All under the guise of a quick and easy way to update their voter rolls. (A note on Becker, before he started ERIC, Becker worked as a lobbyist for People for the American Way, a George Soros-funded advocacy group best known for the Right Wing Watch project, a website that catalogs and attacks conservative politicians and movements.)

A final note about Sheridan, I’ve been in an email correspondence with him on the faith and as you can imagine he won’t engage me on the facts with the faith also. We gotta still pray for him he’s still alive.



I had some real good talks with Sheriff Candidate Josh Baker. We were talking about the illegal immigration problem here in Sierra County and he was telling me how he and the Sheriff Department is literally handcuffed from doing anything.
