The conference began at 9am. We arrived a little late and when we got there we were introduced to video showing the background and accomplishments of Lara Logan. I didn't know who she was before I got there. We viewed a little video highlighting of her achievements as a journalist. She is a very accomplished journalist and did a very good job in moderating the event. She had very good insights to what is happening in this country. She emphasized this issue is not about Trump, it's about you, the American people, because it is you that they (the elites) are most afraid of. If you want to truly represent your voice then you have to demand free and fair elections. In order to have free and fair elections you have to have hand counted paper ballot elections. Br. Ryan and I noticed that a couple of times when she referred to God during her talks she would make the sign of the cross. During the intermission Br. Ryan and I caught up with her and introduced ourselves and gave her an envelope The envelope contained [RJMI's Letter against the RINO's and for Donald Trump](#) and RJMI's letter [Catholics Must Vote for Trump in USA's 2016 Presidential Race](#). She was very appreciative but was in a hurry because she had to contact her sick daughter.



Couy Griffen was in the house. I just happened to be heading to the bathroom and met him as he was signing in. I told everyone at the sign in that now the forum can begin because Couy was here. He took part in a New Mexico Grassroots Panel that was talking about Election integrity in New Mexico. It had the who's who in New Mexico Election Integrity. He and Erin Clements were the big headliners of the group. Erin Clements is the wife of David Clements and does a lot of good research in regards to exposing voter fraud here in New Mexico. Couy got a standing ovation when he was introduced and gave his testimony about what happened at his trial in Santa Fe. District Court Judge Francis Matthews ruled that Couy, an Otero County commissioner, is now disqualified from holding public office because he violated Section 3 of the Fourteenth Amendment by participating in the Jan. 6 protest at the White House. He said the decision against him is under appeal and he hopes that it will make it to the US Supreme Court. After the panel, he came and sat next to our table for the rest of the day. We got to pick his brain on all sorts of New Mexico politics.



We talked to Erin Clements privately after the forum, and she knew who our County Clerk, Shelly Trujillo, is and has been to Sierra County. She said that when she presented evidence about fraud in Sierra County to Shelly it didn't register with her. When I confronted Shelly with this claim she says that there was no fraud. All I know is Shelly does not want to touch the Dominion voting machine issue at all. You'll learn more about this later in the article.

Pablo Martinez was another one on NM Grassroots panel. He and Erin represented New Mexico on Mike Lindell's Summit of Truth Event back in the 8<sup>th</sup> month. We saw him during the break and gave him an envelope. He then circled back during the Bennie Smith presentation and was asking all kinds of questions about who we are and about the faith. He agreed that the Catholic Church is more than a building or a visible hierarchy. When I told him that it was about the faith, the mystical body of Christ, he accepted that. He gave me his card and said to call him to talk more about the faith.

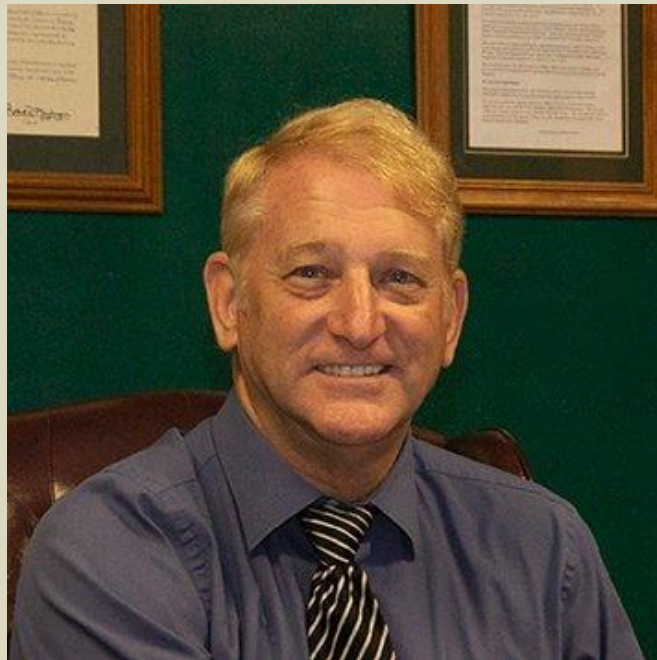


Bennie Smith is an Election Official from Shelby County TN. He's an interesting story because he is a Democrat and was given all of Bev Harris's information. Who is Bev Harris you ask? Bev Harris, in my opinion, is the first real trailblazer on this issue. Her movie "Hacking Democracy" is a 2006 Emmy nominated HBO documentary that put this issue on the map. In this video she was the first to show how these machines can flip votes. His presentation focused on Fraction Magic, which basically means a programmer writing code for software with a certain fraction percentage of votes each candidate will already get programmed into the software. So when you vote, the already programmed people will receive the percentage of votes that they were designed to get.

Clint Curtis is a Democrat, who used to be a Republican and wrote the first algorithm to flip votes back in 2000. He was on zoom, and he was the most blunt and dire person at the event:

"You wanna have fair and free elections then throw all of the machines in the ocean. Until then, you can have all the safeguards you want but the programmer is God. He can design programs that can cheat and switch votes in a nanosecond. It doesn't matter if you have a ton of poll watchers, challengers, etc. if the programmer is in your pocket then it's all over."

He was on Mike Lindell's Summit of Truth and gave a famous example by holding his fist clinched and saying I am thinking of number between 1 and 2, what is it? The person would say 1. He then says no but never shows you the evidence. Guess again. You say 2 and he says no but never shows you the evidence. He then said that when you vote there is no certainty to confirm that your vote went to the person you voted for.

Br. Ryan and I got to talk to Audrey Trujillo, and she told us how nobody wanted to run for Secretary of State. She said there are 33 clerks in New Mexico and no one wanted to run against the current Secretary of State Maggie Toulouse Oliver. She then gave us a litany of all of the corruption that Maggie has done while in office. A couple of the highlights are that she gives absentee ballots out to people that don't request them. She has been to court 42 times, more than any other New Mexico Secretary of State, for over stepping her authority in office. She does not support voter ID. The first thing that Audrey would do is clean up the voter rolls. Currently Secretary Toulouse Oliver uses ERIC, Electronic Registration Information Center to help clean rolls. It is a left wing organization that has software that was funded by George Soros. They are supposed to scrub the rolls every two years, however I witnessed a current voter roll for my precinct and it still had people from MLR that left the church five years ago and live outside the State. So obviously they are not doing their job.

Jim Marchant is running for Nevada Secretary of State and is the president of the America First Secretary of State Coalition, a group of Secretary of State Candidates who believe the 2020 Presidential election was stolen. He said that this country is over until we get rid of the machines or we won't get it back. We talked to him after the forum and asked him about his campaign and Nye County where he gathered a panel of IT experts and people who had bad experiences with the voting machines and lined them up in front of the County Commissioners and they voted 5-0 to get rid of the machine after they heard the testimonies. He claims that he is 8 points up over his opponent in the polls. He says that he's got a ton of poll watchers and challengers in place. Let's pray and hope that the software goes haywire if they try to rig his race. He would be a big fish for the Election Integrity movement and could truly put this issue on the map.

Other Secretary of States that gave good talks were Mac Warner (current secretary of State in West Virginia), Mark Finchem (SOS candidate for AZ), Rayla Campbell (SOS candidate in MA), and Kristina Karamo (SOS from Michigan).

This is Mark Cook, one of the IT experts that Jim Marchant brought into prove to the Nye County Nevada Commissioners that the voting machines are no good. He laid it out brilliantly. He also gave a presentation at the forum. Basically, he shows the many different ways in which the inside of a machine can connect to a modem or the internet by devices in the machines. I asked him if he would come to my county to look at the machines when Dominion has to do maintenance 45 days after the election. He said yes and that he was willing to fly down to do it. He also said he would speak with Shelly, our County Clerk, on a secure phone call to explain to her how the machines can be hacked and manipulated. Now I have to convince Shelly to accept the offer. Originally she told me she was ok with me having a tech guy come in with the Dominion guy and look at the machines to see what's inside; but when I got back from the forum and was trying to set up a date to talk to Mark, she weakened and said she didn't believe that the machines could be connected to the internet. This was after she watched the premiere video that exposes the vulnerability of the machines called "Hacking America's Computerized Voting Machines." ([Click here](#) to view the video.) She tried to say that she did not see a literal Dominion machine in the video henceforth she doesn't believe that Dominion machines can be hooked up to the internet. "I saw other types of machines in the video but not Dominion." She's is of bad will on this topic because all of the IT experts, programmers and politicians in this video all agree that these machines can be hacked and manipulated.

The last speaker for the Forum was Juan O. Savin. He is known in the QAnon circles for his fiery talks, and he lived up to the billing. He touched on the Military Industrial Complex and how it has influenced society. Examples he mentioned were the creation of Facebook by the CIA and how the United States has supported the spread of these electronic voting machines throughout the world in order to overthrow other governments and put in the people favorable to them.

After the event, we went out to dinner at Kentucky Fried Chicken and Br Ryan made the observation that it looks bleak for the Election Integrity issue. I agreed that it is right now, but if one or two of these guys get into office they can make a lot of waves and draw attention to this issue. Will it happen? We will see in a short time.



When I came home I went to my Sierra County Republican meeting on Monday night and gave a quick talk on Election Integrity. It went well. I had my technical advisor, Br. Ryan Gott, with me to explain how the voting machines are connected to the internet through the modems. We stressed day of the election voting so that people can't fix the algorithms to switch votes. The reasoning is that if a lot of people vote early, then it makes it easier for those who have access to the voter rolls to set the algorithms. If you have a ton of people vote on Election Day, then it's harder to set algorithms because they don't know how many people are coming out to vote. It is not that early voting is a bad thing. It is good thing as long as the machines are not used to count votes.



In closing, to be honest I don't know how much a dent we are going to make on this issue in Sierra County. People were looking at us like a deer in the headlights and early voting is strongly urged in this county due to the amount of older people who live here. My hope is that by talking about this we can make the machine issue known and educate people. However, ultimately we know as true Catholics that the voting machines are a huge ploy by the Apostate Jews, with the help of the Freemasons, to bring their Anti-Christ to power. By controlling the machines, barring miracles, they can select people they want to be their minions so that they can bring chaos to the world and from this chaos Antichrist will emerge to bring a sense of order. However, this order will come with a price because then people will have to vow allegiance to him and then take the mark of the beast in order to buy or sell.
