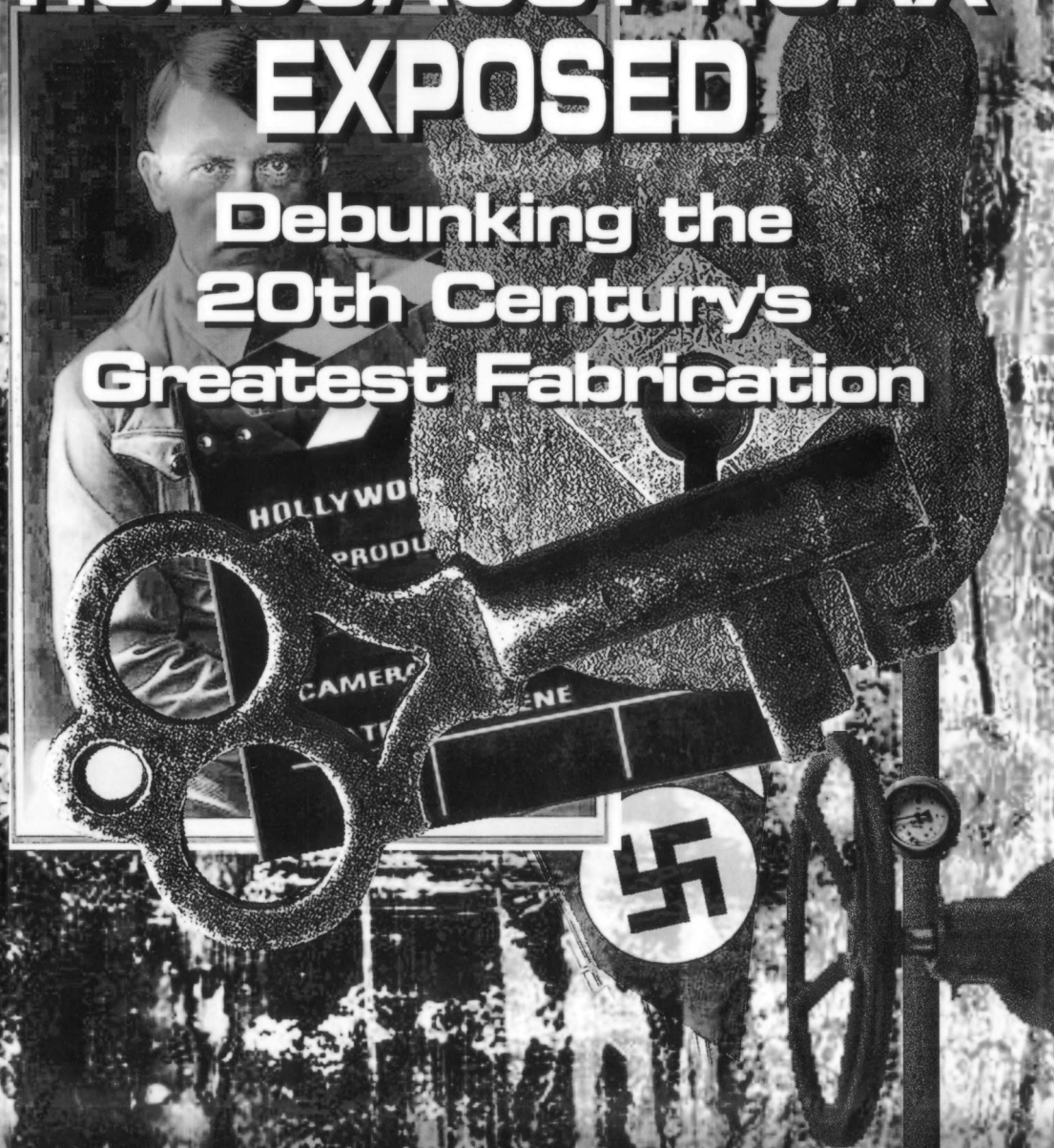

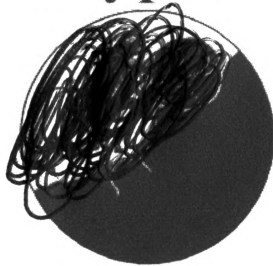

Foreword

In Aug. 2000 I was informed that the New York Stock Exchange (NYSE) was after me. The NYSE lawyers in this matter were Baker Botts L.L.P., the second oldest law firm west of the Mississippi and the namesake of the politically-connected Baker family, i.e., former U.S. Secretary of State James A. Baker III. In fact, Baker Botts is considered a proving ground of sorts for some of the country's most prominent politicians. Verbally challenged former U.S. president George W. The NYSE was incensed that I had been critical of them through an online newspaper I founded, *WallStreetJovial.com*, a play on their venerable *The Wall Street Journal*. So, they attacked from a different angle.

INTRODUCTION: **A SUSPENSION OF DISBELIEF**

It's the 20th century's most preposterous fairytale, also known as the holocaust hoax. Anyone approaching this subject with an open mind should seriously consider using the words of 1 Corinthians 13:11 as their guide. "It's time to put away childish things." So, akin to Santa Claus, the Easter Bunny and any other figment of the imagination, the tale of six million Jews being exterminated in National Socialist death camps is nothing more than a deceptive ruse.

In the following pages readers will encounter some of the most imaginative storytelling known to mankind. Or, if we call a spade a spade, the lies perpetrated by holohoax "historians" are so egregious, weakly constructed and downright ludicrous that it'd be hilarious if it weren't so pathetic. Who needs scandal-ridden Jewish satirist Lenny Bruce for chuckles when these tall tales make for more humorous comedy material?

The official story handed down for the past six generations has Nazis exterminating six million Jews in concentration camps during World War II. Of course, something can allegedly be "proven true" thousands of times, but if it's disproven on only one occasion, it can never be true again.

While keeping this important truism in mind, if any impartial researcher utilized the scientific method, they'd discover that it's literally child's play to shred, dissect and leave for dead the flimsy holocaust myth.

One of the most debauched propagandists, Deborah Lipstadt, says there can be no alternate version to the holocaust yarn other than the officially sanctioned one. However, in an open society that

Million Six Million Six Million, or else they suffer irreparable consequences.

In Europe, scores of researchers have been imprisoned for merely questioning holocaust numbers or claims. They committed absolutely no crime whatsoever other than simply *asking questions*. For such an apparent offense, they were thrown behind bars for, sometimes, years at a time. Is that what we want in the United States of America, too?

Does our First Amendment still apply, or will we bow to a dictatorial, maniacal iron fist of intolerance and suppression? Because a clandestine group of scriptwriters carefully crafted this elaborate hoax, should the rest of society be forced to unwittingly accept it without argument just because they said so?

With this book—and many published previous to it—the cat is now out of its proverbial bag and the emperor has been exposed as wearing no clothes. Santa Claus is an infantile charade, and the holocaust is laughable in its sheer absurdity.

LABOR CAMPS, **NOT DEATH FACTORIES**

To proceed in investigating this matter, the use of critical thought is crucial. At the height of WW II, the Germans had approximately eight million men fighting their various battles on all fronts; three million in Russia alone. The Germans were so desperate for soldiers by war's end that they were drafting literally every able-bodied man between the ages of 16 and 45. In essence, anyone they could get their hands on.

Let's remember: this is WW II—the biggest military operation in history. Four million Germans were eventually killed. So, considering the vast requirements needed for their war machine, who made all the tanks, bullets, uniforms, guns, boots, helmets, and scores of other necessities to maintain their armies on the battlefield?

Put another way, with all their men already fighting the war, Germany sought workers for their factories by any means necessary. In this regard, if the Jews could serve as much-needed labor, how logical would it be to then kill these workers?

Furthermore, one of the primary reasons Germany lost WW II was because Allied forces cutoff their fuel supplies. As a result, Germany was forced to create synthetic oil. Being that their massive war machine—tanks, jeeps, trains and planes—required exorbitant amounts of fuel, how is it possible that the Germans would expend (i.e. waste) the millions of gallons of fuel needed to gas six million Jews?

As will be proven later, not a single Jew was deliberately gassed to death in any German-maintained concentration camp. Thus, are we to swallow the line that Germany would squander their resources to transport six million Jews, by train, to foreign countries only to kill them abroad?

For those still clinging to the holocaust fable, it's time to start popping a few balloons. On Dec. 28, 1942 Heinrich Himmler issued a command. "The death rate in concentration camps must be reduced at all costs."

Such a demand is peculiar because weren't the Nazis supposed to be murdering their Jewish inmates, not sparing their lives? In response, camp inspector Richard Glucks wrote on Jan. 20, 1943, "Every means will be used to lower death rates."

Then, by Apr. 10, 1943 Oswald Pohl's Economic Administration Office revealed that deaths had plummeted in their work centers from 8.5 percent in July 1942 to 2.8 percent in June 1943.

These numbers make perfect sense, especially at Auschwitz, which was a sprawling industrial center

desperate for laborers. Himmler's exact words were, "Camp doctors are to see to it that working conditions at the various labor places are improved as much as possible." Himmler also inspected each camp to evaluate its efficiency . . . not in executing workers, but instead to determine how effectively they were producing war goods. If laborers died, it hampered production.

Also, Reinhard Heydrich, head of Germany's secret police and purported "Final Solution" author at the notorious Wannsee Conference, actually wrote on Jan. 20, 1942, "Under proper direction the Jews should now in the course of the Final Solution [*Endlosung*] be brought to the East in a suitable way for use as labor."

Likewise, in Apr. 1942 SS Gen. Oswald Pohl demanded, "Mobilization of the labor power of all internees primarily for war tasks must take absolute precedence."

Jews, similar to Slavs, gypsies, homosexuals and Catholics were all valuable commodities that could be put to work in factories owned by companies such as I.G. Farben. Photographs from the early-to-mid 1940s reveal that Auschwitz was an enormous industrial complex where rubber, medical supplies, weaponry and clothes were manufactured.

At Auschwitz alone, 39 different work camps existed, 19 consisting primarily of Jews. One factory—Monowitz No. 16 camp—boasted 126,000 laborers. Clearly, Jews were a vital aspect of keeping the wheels of their war machine rolling.

On Apr. 17, 1943 Adolf Hitler made a request of Adm. Milos Horthy. He wanted “100,000 Jews to work on a new pursuit plane program.” How strange, especially since we’re told that Hitler supposedly wanted each and every Jew imaginable to be exterminated. Then, in May 1944 Hitler, of his own volition, sought 200,000 more Jews to work in his war machine factories.

200,000—that’s an extremely large number, and when added to the previous 100,000—that’s plenty of Jews kept *alive*, not slaughtered.

Forced labor served as a key component of Germany’s war efforts, especially during the final years from 1943-1945. Again, at Auschwitz, almost 1,000 industrial sub-camps were spawned to provide labor. Jews, among others, also built roads and houses, picked up trash, or worked as miners in quarries.

At the risk of being repetitive, Jews were cheap labor that was exploited by the SS, I.G. Farben, and numerous German manufacturers. For example, at

Auschwitz, workers produced Buna, a synthetic rubber used to make tires.

Why would the Germans ship hundreds of thousands of slaves to factories only to kill them? Such a thought is absurd. Again, Germany was inordinately desperate for workers. Homicidal gas chambers were the furthest notion from their minds.

To document this fact, the Netherlands Red Cross released letters written by Jewish workers at Auschwitz. In their correspondences, they described their duties as “hard but tolerable,” the food as “adequate,” and their sleeping quarters as “good.”

Let’s address one simple proposition: during WW II’s most heated moments, why would the Germans transform vast industrial centers like Auschwitz—that supplied their war machine—into extermination camps? All of the resources needed to supply their troops would suddenly be diverted into ovens to cook people, particularly when they were fighting the Americans, English, French and Russians on various fronts.

A case in point: on Aug. 15, 1944 Hungarian Jews totaling 90,000 were exported to work centers. Later in that same year, Himmler stated that 40 percent more fighter planes rolled off the assembly line due to labor provided by these Hungarian Jews. Far from wanting them incinerated, Jewish labor was an asset to the Germans. The Holocaust extermination theory simply doesn’t make sense.

FUEL SHORTAGES:
ONE OF THE PRIMARY REASONS
WHY GERMANY LOST THE WAR

At the risk of letting facts interfere with a good hoax, Germany—to a great extent—lost the war because they ran out of fuel. That's a historical, military certainty. Being so desperately low on this vital resource, why would they deliberately direct fuel to alleged genocidal crematoria rather than feed tanks, jeeps, trains and fighter jets? Such a move would epitomize waste, especially when Germany actually tried to *win* WW II.

In addition, why won't the holocaust crowd tell people that during the war, U.S. reconnaissance planes snapped thousands of photos of Germany's countryside? Yet not a single one of these pictures depicts long lines of fuel trucks traveling to the supposed crematoria (including those in Poland). Obviously, to slay six million people, literally thousands of tankers would be needed to supply enough for the ovens. But not a shred of evidence exists confirming that fuel trucks were used for this purpose.

Strangely, U.S. spy planes also didn't photograph any billowing smokestacks that would have emitted exhaust from ovens operating on a 24-hour basis to kill six million people. Imagine the vastness of an operation needed to cremate six million people, yet no spewing smokestacks.

It gets even more peculiar. The Germans kept meticulous records that were seized following WW II, yet not a single book can be located documenting tens of thousands of trucks delivering fuel to any of the purported crematoria. These records don't exist because Germany required the petrol for more pressing matters, namely fighting the war.

Then there's the pesky little problem of coal that could have been used to cremate Jews. But hundreds of thousands of tons of coal was instead used to produce synthetic gasoline. In simplest terms, the Germans couldn't generate enough fuel to even keep their war machine running, let alone to cook six million Jews. That's one of the primary reasons why they lost the war.



**LOGISTICS: NOT ENOUGH TIME
OR MANPOWER TO IMPLEMENT
SUCH A MASSIVE OPERATION**

Instead of playing ring-around-the-rosie (like holocaust historians do), let's be realistic. Why would supposed genocidal Germans exert millions of man-hours transporting Jews out of their own country in order to slaughter them on foreign soil? Imagine how many trains, thousands of gallons of fuel, and personnel would be needed to undertake such a task. Why tie up the rails with millions of Jews transported hundreds of miles when these same trains could be used to carry soldiers and munitions? *

If the SS were such efficient killers, why not just shoot a single bullet on German soil into the heads of these Jews? Pardon the sarcasm, but maybe this explanation and the use of practical common sense makes the picture a little bit too clear.

Also, when viewing photos of Auschwitz and other camps, why build thousands of housing units to let Jews live in when—allegedly—they were only going to be killed anyway? Or, were all these barracks instead utilized to house valuable laborers? Plus, why were the Germans constructing water purification plants on the premises if Jews were merely going to be killed? Dead people don't need to drink water, but laborers do.

For that matter, let's slaughter another sacred cow: If Nazis solely intended to kill Jews, why waste the

energy tattooing them? Or, were these identification numbers instead a way to keep track of their workers?

SAFETY AND COMFORT:
CONCENTRATION CAMPS WERE
THE SAFEST PLACE FOR JEWS IN
EUROPE DURING WW II

Pardon the insistence on actual documentation, but footage from German-run work camps during WW II shows shopping centers on the premises, not to mention sports fields (for soccer matches), swimming pools, town squares, concert halls, libraries and post offices.

Considering war-torn Germany during the latter part of WW II, especially in the ghettos, many laborers forced into these industrial centers actually found an *improved* standard-of-living. Now, rather than relying on infantile reasoning, why would the Germans provide all these amenities if they were simply going to cremate millions of Jews?

Or, were these creature comforts instead intended to keep their workers at least relatively contented? In addition, evidence shows that productive laborers inside these camps were granted special privileges,

including nights at the orchestra.

Instead of tap dancing around the issue, the fact remains that

concentration camp money, called “Lagergeld,” was created to pay laborers for their efforts. This currency was used at Auschwitz, Buchenwald and Dachau. This payment system included Jewish employees who received “scrip” papers that they later redeemed to buy goods at stores located inside these industrial centers.

What a queer idea, don’t you think, giving Jewish slaves a paycheck . . . the same ones that the Nazis were supposedly going to execute in ovens?

Taken one step further, not only weren’t there any

execution camps operated by the Nazis, these labor facilities actually became some of the safest places in Europe by war’s end.

Because western powers had investments in camps such as I.G. Farben, they deliberately didn’t bomb the huge industrial centers (i.e. concentration camps) because it would have cost them too much money. As such, since Jews were working at these labor camps, they were, in effect, *safer* under German control than was most anyone else in the population (especially in

Dresden, which suffered an atrocious, real-life fire-bombing holocaust).

How inconvenient, don't you think, when facts illuminate a subject that had previously been so muddled by disinformation and propaganda. Whereas German families were getting decimated and killed by the thousands during Allied onslaughts, the Jews were protected and safe in their work camps.

So, let's be clear. The Jews were residing in Polish and German centers, kept safely apart from everyday

Germans that were dying horrific deaths on a daily basis. These Jews weren't being fried in gas chambers. Rather, after each workday, the Jews lounged in libraries, watched soccer matches, were attended to by doctors and nurses, and attended symphonies.

Ask yourself: why would the Germans keep Jews healthy with medical care in state-of-the-art hospitals only to expunge them later? Or, how is it possible to believe the holocaust historians' cock-and-bull stories that Jews were gassed only hours after stepping off trains carrying them to Poland? It simply isn't true.

X But once the war ended, the Jewish agenda necessitated that a fabrication called the holocaust be invented to further their aims. In such a light, this may be a good time to quote Jewish doctor Aryeh Leon Kubovy of Tel Aviv's Israeli Center for Jewish Documentation. He clearly stated, "There exists no document signed by Hitler, Himmler or Heydrich speaking of exterminating Jews . . . and, the word 'extermination' does not appear in the letter from [Hermann] Goering to Heydrich concerning the Final Solution of the Jewish question."



NUMBER OF DECEASED IN WORK CAMPS KEEPS BEING LOWERED

Since 1945, reports on the number of Jews that died during WW II kept being revised and lowered. However, as the totals continued to drop, inexplicably the fabricated figure of six million remained unchanged.

Moreover, once the Nazis rose to power in Germany, Jews began leaving that country, as they did the continent of Europe as a whole. Their destinations included Palestine, the U.S., and Russia (among others). Their movements were so staggering that it became a *de facto* second exodus.

On June 9, 1945 Freiling Foster of *Colliers* magazine pinpointed the population of Jews in German-occupied Europe at 3,450,000. This figure is interesting because how could six million Jews die in a holocaust when there weren't even that many living in Europe at the time?

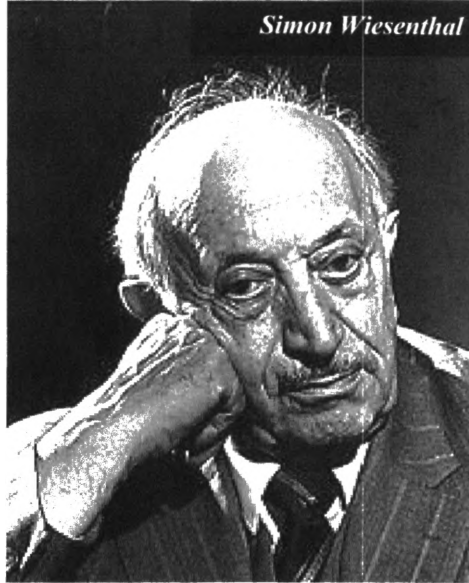
Even more telling, when the Nazis became a prominent force to be dealt with in 1933, only 560,000 Jews resided in Germany. In those regions closest to Hitler's government—specifically Germany, Czechoslovakia and Austria—only 360,000 Jews remained after 1939. Is the picture starting to become clear? There weren't even six million Jews living in Europe during the time of Hitler's reign that could have been killed.

On July 13, 1994 PBS (KENW-TV) televised an account of famed pilot Charles Lindbergh's life. During this documentary, it was claimed that Lindbergh vi-

sited one of Germany's labor camps and returned to say that only 25,000 total people perished in one-and-a-half years.

Strangely, Simon Wiesenthal—a notoriously deceptive Nazi hunter—boasted after WW II that Germany killed 10 million Jews in Poland, Latvia and Lithuania alone. Similarly, in 1943—two years before WW II ended—Rafael Lemkin, author of



Axis Rule in Occupied Europe, alleged that six million Jews had already died by 1943. He's also the man who created the term "genocide." Oddly enough, in Feb. 1943 *Reader's Digest* also stated that six million Jews had already been killed.

But did any type of genocidal extermination occur in regard to the Jews? An examination of the numbers is merited. On Mar. 24, 1933 the *Daily Express*, a Jewish newspaper, listed the total Jews worldwide at 14 million. The 1933 *World Almanac*, p. 419, estimated the number of Jews at 15,316,359.

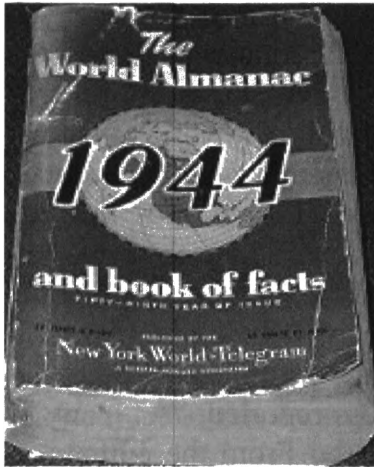
Continuing, the 1936 *World Almanac*, p. 748, had the worldwide Jewish population at 15,753,633, while in 1938 it was 15,748,091. In 1939, the American Jew-

ish Committee Bureau of the Synagogue Council cited the Jewish population at 15.6 million.

Let's pause for a moment to consider these figures. When America entered the war in 1941, Jews globally totaled 15.7 million. Supposedly, by the end of WW II in 1945, the Nazis had expunged six million Jews. Yet in 1947, the total Jewish population—according to the esteemed *World Al-*

manac—was 15.6 million—essentially no change whatsoever. How can that possibly be?

Adding more weight to this argument, on Feb. 22, 1948 the *New York Times* listed total Jews worldwide at 15.6 million, plus another 600,000-700,000 living in Palestine. The grand total equals 16.2 million—more than when WW II began.

Hanson Baldwin, a renowned war historian for the *New York Times*, likewise placed the number of Jews in the world circa 1948 at over 15 million. Curiously, in 1943 a publication called *Information Please* provided a number of 15,152,098 Jews worldwide.

In this same vein, in 1946 the Red Cross released a report with a bombshell revelation: between 270,000-300,000 registered inmates of *all nationalities* perished in German-controlled work camps. Of these, no more than half were Jews, and these individuals died primarily of typhoid and other diseases.

Even more importantly, the Red Cross made it clear that the majority of deaths occurred as the war wound down and Allied bombing campaigns obliterated all food and supply lines to the work camps.

Equally as interesting, the International Red Cross examined extremely detailed German death records and determined that a total of 150,000 workers died at Auschwitz, with only 30,000 being Jewish. Of course, holocaust historians maintained for decades that the Nazis eliminated four million Jews at Auschwitz.

The Red Cross should know because during the war, Nazi officers allowed them to make regular deliveries and inspections of their various work camps. In their own words, the Red Cross reported, "As many as 9,000 parcels were packed daily. From the autumn of 1943 until May 1945, about 1,112,000 parcels with a total weight of 4,500 tons were sent to the concentration camps."

If concentration camps were intended to be death chambers where Jews were killed by the multi-millions, why did the Nazis allow Red Cross personnel to deliver so much food, clothing and medicine?

Let's dig even deeper into their data. In June 1946, document # 9925, the Red Cross interviewed inmates freed from various Nazi-run camps at the end of WW II. These individuals were asked if they witnessed any

gassings. The Red Cross then wrote, "The detainees themselves have not spoken of them."

None of the workers confirmed rumors of "killing factories." Remember, during the entirety of WW II, the Red Cross constantly delivered supplies to these camps. Never once did they file a complaint or make any records of Auschwitz ovens used to gas human beings. Not once, not even in their 1,600-page 1946 report. Nor did they mention any shower stalls or showerheads disguised to deliver gas that was used for mass executions.

To convey the importance of this information, never once in their extensive post-war biographies did Dwight David Eisenhower, Winston Churchill, France's Charles de Gaulle or Harry Truman mention extermination camps in Germany (or countries that Germans occupied). Furthermore, during the war neither the Red Cross, other humanitarian agencies, the Vatican, or any of the Allied governments ever broach the subject of a holocaust that exterminated six million Jews.

The Red Cross claimed that at war's end, a total of 120,000 survivors of all nationalities were released or freed from concentration camps. During the war a total of 3.4 million Jews resided in German-occupied Europe. We know this figure is accurate because the World Jewish Congress published a book entitled *Unity in Dispersion* that stated on p. 377, "The majority of German Jews succeeded in leaving Germany before the war broke out."

Further, to cite Freiling Foster again in the June 9, 1945 issue of *Colliers* magazine, "2.2 million [Jews]

have migrated to the Soviet Union since 1939 to escape from the Nazis.”

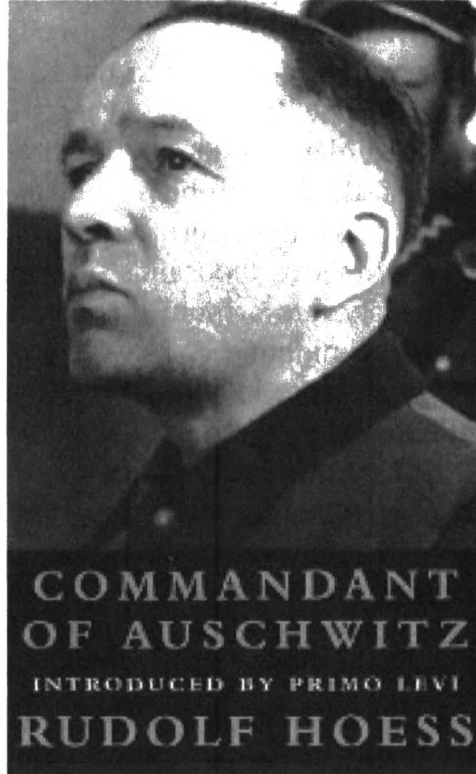
So, roughly 3.4 million Jews lived in Europe during WW II, and there were only 120,000 total concentration camp survivors. But then something strange began to happen. On Mar. 31, 1956 the German government settled claims with 400,000 concentration camp “survivors.” Then, on June 30, 1965—nearly a decade later—3,375,020 more Jews claimed to be holocaust survivors.

As stated, however, only 3.4 million Jews even resided in all of Europe during WW II. Then, amazingly, by the year 2000, the nation of Israel proclaimed a total number of holocaust survivors at 1,092,000. Now, if this is the number 55 years after the war, and considering that “survivors” naturally would have perished over the course of five decades, then conceivably the purported number of holocaust survivors in 1945 would have been—at least according to holocaust historians—over five million.

So, let’s reexamine the numbers. There were supposedly six million Jews exterminated during WW II and another five million survivors. Yet, all of Europe only had 3.4 million total Jews. Does anyone think the math is a bit fuzzy here?

THE TORTURED “CONFESSIONS” OF RUDOLF HOESS

On Apr. 6, 1946 a document purported to be the confession of former Auschwitz SS commandant Rudolf Hoess was presented to a team of U.S. prosecutors at the Nuremberg Trials. Nine days later, Hoess testified before the Nuremberg Tribunal to declare that from May 1940 to Dec. 1943 he personally witnessed, “At least 2.5 million victims [that] were executed and exterminated by gassing and burning.”

Notably, Hoess was the only person at Nuremberg that testified to personally seeing the “burning and gassing of live Jews.” According to him, in his role as an SS commandant, he visited concentration camps at Belzec and Treblinka in June 1941. But, contrary to his

words, Belzec didn't even begin operations until Mar. 1942, while Treblinka didn't open until July 1942.

Hoess also testified to witnessing exterminations at a camp known as Wolzek. Except, historians later admitted that no facility known as Wolzek ever existed. His confession was a complete fabrication.

In addition, Hoess described how 2,000 Jews at a time were crammed into the Krema II gas chamber at Auschwitz. In later years, other "eyewitnesses" claimed that 3,000-4,000 victims were packed into Krema II. The problem, however, is that this small room had a floor surface area of only 210 square meters. To shove thousands of frantic individuals simultaneously into a room this small would prove to be a logistical nightmare.

Even more ludicrous, Hoess alleged that a mere 10 minutes after thousands of men and women were exterminated in this cramped room via the use of Zyklon B, Nazi guards smoking cigarettes would open the doors and begin extracting the corpses. Yet, the manufacturers of this substance agree that Zyklon B requires a 24-hour ventilation time, while no one could possibly light cigarettes in such a flammable environment.

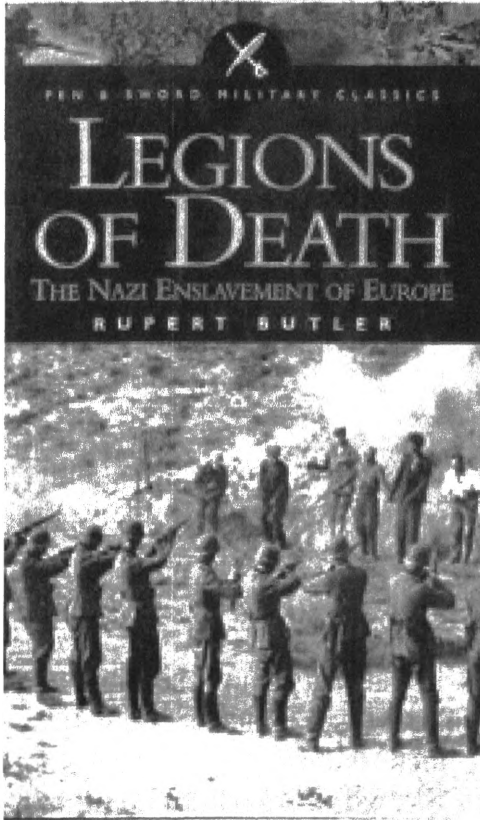
The question arises: how could Hoess make such laughably ridiculous claims that were so easily picked apart? The answer: he didn't make these confessions, at least of his own volition.

Instead, a Jewish military intelligence officer for the Brits named Bernard Clarke, along with five other English soldiers, spent three days torturing Hoess until he eventually provided a "confession." The beatings by this team of torture specialists were so extreme that

Hoess nearly died. The soldiers also threatened his wife and children.

Rupert Butler described the horrendous procedures



Legions of Death that chronicles the tortures committed by Bernard Clarke and others

in his book *Legions of Death*.

“The prisoner was torn from the top bunk, the pajamas ripped from his body. He was then dragged naked to one of the slaughter tables where it seemed to Clarke the blows and screams were endless. Eventually, the medical officer urged the captain: call them off unless you want to take back a corpse.”

Hoess later described the torture inflicted upon him. “During the first interrogation

they beat me to obtain evidence. I do not know what was in the transcript or what I said even though I signed it because they gave me liquor and beat me with a whip. It was too much even for me to bear.”

RE-EXAMINING THE ANNE FRANK FABLE



As “proof” of the holocaust, many laymen and those from academia alike will cite the touching story of a young “Jewish” woman named Anne Frank who, allegedly, wrote a diary for two years while hiding in a secret annex behind a warehouse during the Nazi occupation of the Netherlands. She and her family were later relocated to Auschwitz after being captured by soldiers.

Unfortunately for those who’ve invested so much effort into Ms. Frank’s plight, the official folklore surrounding her diary is patently false. First, Auschwitz has come to be known as the most monstrous of all supposed extermination centers used by the Nazis.

However, Anne, her father Otto, and her sister Margot were all assigned to Auschwitz, yet none was executed there. Why not? They were later reassigned to Bergen-Belsen. Only Anne's mother Edith supposedly died at Auschwitz, allegedly of starvation, not in a gas chamber.

At the Belsen facility, Anne died of typhus only months before the war ended. She wasn't gassed in an oven, nor was she shot. Instead, Anne Frank and her sister died when supply lines were cut by Allied bombings. Indeed, due to complications that worsened in conjunction with the massive onslaughts unleashed by U.S. and British forces, Anne Frank perished in Mar. 1945 from far less dramatic causes than a "final solution."

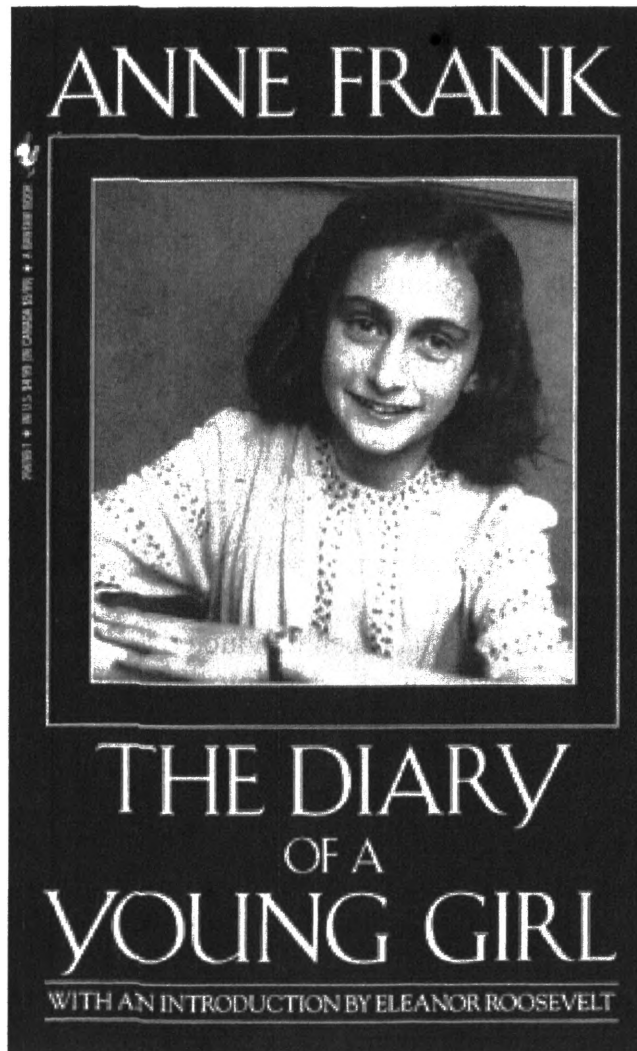
Of course, if the Nazis had simply wanted to eradicate every Jew in their possession, why didn't they immediately toss Anne Frank and her family into ovens as soon as they disembarked from trains arriving at Auschwitz? Why keep this young girl alive for two months at Auschwitz, only to transport her yet again to Bergen-Belsen where they fed and tended to her for another five months? Doesn't that seem to be an inordinate amount of effort to maintain the life of a 14-year-old girl?

But then again, what of her much-touted diary? We're told Anne Frank, then a 12-year-old from Amsterdam, fled the Nazis with her family and, while hiding in a secret annex, wrote of her travails. Eventually, her family was discovered and sent to the above-mentioned concentration camps.

Except, seven years after this book's publication, the New York Supreme Court ruled it was a hoax. Yes,

Even Jews were suspicious of the diary's legitimacy because, being raised in the Jewish faith, Miss Frank's supposed memoirs fail to mention Passover, special holidays, and most other Jewish religious issues. It appeared this "Jewish" girl had little or no concern about anything Jewish at all.





FRED LEUCHTER:
SCIENCE DEBUNKS FANTASY
AT AUSCHWITZ

In 1988 Fred Leuchter, an expert on the construction of gas chambers, traveled to Poland in order to investigate whether mass killings took place at Birkenau, Lublin, Auschwitz and Majdanek.

Leuchter meticulously collected samples from the walls and floors of the above-mentioned "gas chambers" to test them for cyanide residue, which obviously would have been evident in these structures if millions of executions had been conducted.

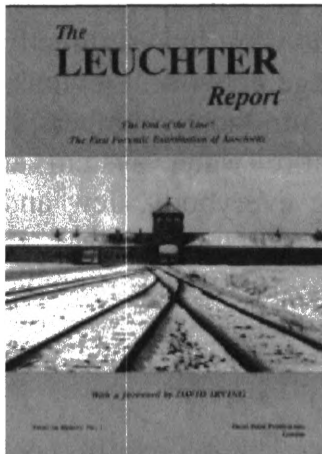
His discoveries were startling: forensic evidence exhibited very little, or no traces whatsoever, of the poisonous gas Zyklon B that holocaust historians say was used in the alleged death camps.

In contrast, cyanide levels in the Auschwitz delousing quarters (used to rid clothing of lice) were three orders of magnitude higher than they were in the "gas chambers." Stated differently, the delousing chambers were one part per thousand versus one part per million in the alleged death rooms.

This information, as will be discussed more extensively in a later chapter, is undeniably clear. The only reason Zyklon B was ever used was to remove lice from the clothing of impoverished labor camp workers. These lice, if unchecked, led to massive outbreaks of typhus and other diseases. The Nazis didn't use Zyklon B to kill Jews. Rather, they used it to improve the lives of their workers by making conditions more sanitary.

With no indication of Zyklon B embedded in the walls of these so-called gas chambers, Leuchter concluded that the entire story was a fraud. Three years after his study, the Polish government engaged in similar tests. They too found that, due to no evidence of Zyklon B in any of the "death rooms," no gassings occurred.



Another severe blow to this fable occurred when, in a private forensic examination, the Auschwitz State Museum commissioned Krakow's Institute of Forensic Research to determine the predominance of Zyklon B. Their study mirrored Fred Leuchter's analysis: a minimum, or complete lack of, Zyklon B in locales supposedly used to gas millions of Jews.

The *Leuchter Report* next confronted construction techniques used at these facilities. He discovered:

- Not one of the alleged death rooms was sealed with gaskets, a must if poison gas were utilized for murderous purposes.
- No inlets were present to inject the gas or distribute it throughout these rooms.
- Lighting fixtures were not explosion proof.
- No exhaust fans or outlets were present to release gasses from these chambers. Without such vital devices, lethal gasses would have also killed German personnel present on the scene. No exhaust stacks had ever been installed during the war.
- Remarkably, specifically at Auschwitz, floor drains in the alleged death rooms were linked directly to the work camp's storm drainage network. Obviously, if Zyklon B were introduced into these chambers, it would have permeated the entire water system at Auschwitz, consequently killing everybody, Jew and non-Jew alike.
- Lastly, all the rooms were so small that, by simple arithmetic, six million Jews could not have been exterminated in the allotted time period.

Leuchter noted in his report, "The author finds no evidence that any of the facilities normally alleged to be execution gas chambers were ever used as such and find, further, that because of the design and fabrication of these facilities, they could not have been utilized for execution gas chambers."

In other words, it was far-fetched and technically impossible for Auschwitz and other camps to be mass execution factories. Leuchter added, "We have provided definitive proof that there were no execution gas chambers utilized for genocidal purposes by the Ger-

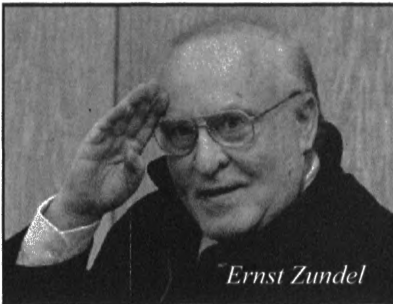

mans at these wartime camps. The simple fact is that the holocaust story is not true.”

To hammer home this point, consider once again the simple numbers. At the various “gas chambers” that were supposedly used to kill Jews, if each was maxed-out at 100 percent efficiency operating non-stop 24 hours a day, seven days a week, it would have taken 68 years to execute a total of six million Jews. Since holocaust historians claim these units were only in operation from 1942 to 1945 (i.e. three years), gassings would have continued until the year 2010 to reach the mythical figure of six million.

Then, if all the deceased bodies had been fed into crematorium ovens at maximum output—again, 24 hours a day, seven days a week—it would have taken 35 years to cremate six million Jews.

Note: Leuchter testified at the famous 1988 trial of



Ernst Zundel that lasted four months. Zundel financed Leuchter’s European fact-finding mission—at great personal expense—to inspect facilities at Auschwitz, Birkenau and Majdanek.

Leuchter concluded in his final report, “The alleged gas chambers at the inspected sites could not have then been, or now, be utilized or seriously considered to function as execution gas chambers.”



ZYKLON B USED TO SAVE
JEWISH LIVES,
NOT ERADICATE THEM

According to holocaust mythology, during the mid-1940s millions of Jews, stripped naked and screaming, were crammed by the thousands into small gas chambers where the doors were locked and then a poisonous chemical, Zyklon B, was funneled into these rooms via fake showerheads or special ceiling chutes. Then, to maximize efficiency that would have been required to reach the six million total, almost immediately thereafter piles of these exterminated Jews were removed, only to have the same room systematically crammed full with more prisoners waiting to be murdered.



Of course, fans had to remove the poisonous Zyklon B fumes before German soldiers were able to enter the gas chambers and remove the corpses. Also, as mentioned earlier, star Nuremberg witness Rudolf Hoess “confessed” that these German guards would be smoking cigarettes and eating as they yanked bodies from the chambers only minutes after they’d been killed. Therefore, the employees at this facility alle-

gedly strolled into these chambers without wearing gas masks or any protective body wear.

Another man, Dr. C.S. Bendel, said that German workers entered the gas chambers only seven minutes after Zyklon B capsules were introduced. The problem with his story is that the granules would have only emitted a small portion of their contents in seven minutes. If hundreds of people were crammed into a tiny room, there's no possibility that Zyklon B could have killed them in such a short amount of time. Plus, would the Germans be that inept to enter a room where poisonous gasses were still being released?

Famed establishment historian William Shirer ascertained that gasses were injected into these rooms via overhead fake showerheads. But again, there's a slight problem. Since Zyklon B is a gas, it's lighter than air and would subsequently rise toward the ceiling, not the floor. If those trapped inside had scurried to the ground, they would have prolonged their ability to live. Furthermore, if more Jews were more tightly packed into these small rooms, the overall process used to allegedly kill them would be obviously slowed. This quandary raises even more doubts about the total six million number. Thus, the gas story proves especially troublesome.

- Zyklon B was manufactured to slowly emit its cyanide gasses. To murder six million Jews while at the same time verifying Hoess's testimony, German guards could not have wasted even a spare second in entering the gas chambers after Jews were supposedly killed. But, how could they have shoveled out hun-

dreds of corpses piled on top of each other without these poisonous gasses also affecting them?

• Zyklon B designers went on record by saying that their product clung to clothes and skin. Now remember, Zyklon B is poisonous. They also added that it would take at least 24 hours before anyone could enter a room that had been fumigated with Zyklon B, and then only wearing the most protective clothing available, as well as filtered gas masks. One whiff of this cyanide gas trapped in clothing would have killed anyone coming into contact with it. Hoess's story must now be dismissed out-of-hand as untruthful. Further, with a 24-hour airing-out period, reaching the six million mark is impossible.

• Historians have stated that death chambers had air vents that released the Zyklon B fumes after thousands of Jews had been gassed. But when the designs of these camps were inspected, it became clear that hospitals stood adjacent to the supposed gas chamber facilities where poisonous gasses would have been released on an almost non-stop basis to kill six million people. With even one open window at the hospital or any other structure, everyone would have died from the vented poison.

• Cyanide is extremely dangerous. Corpses would have to remain untouched for at least an entire day before removal could begin. Plus, cyanide is explosive. If guards had been smoking cigarettes, as Hoess testified, they'd become instantaneously inflamed.

• With deceased bodies supposedly stacked by the hundreds inside these gas chambers, its logical to assume that hydrogen cyanide (HCN) would be trapped in countless air pockets among their bodies. Once

German guards moved any of them, the HCN would have wafted into their mouths and noses, killing them in rather short fashion.

- To further this thought of Germans entering the chambers smoking and without protective clothing to drag out dead Jews, the DuPont Company Material Safety Data Sheet said the following of HCN, the primary component of Zyklon B. "HCN is unstable with heat and extremely flammable. It is a fast-acting poison and could be fatal if inhaled, swallowed, or absorbed through the skin."

The following quotes also contradict the holocaust historians' propaganda about Zyklon B.

The American Cyanamid Company, Linden, N.J.—
"We knew of no chemical process whereby HCN (Zyklon B) may be made to become instantly gaseous upon exposure to air." How can anyone believe claims that Zyklon B was introduced through showerheads, killing Jews within seven minutes?

Chemist Germar Rudolf—"For chemical-technical reasons, the claimed mass gassing with hydrocyanic acid in the alleged gas chambers in Auschwitz did not take place. The supposed facilities for mass killings in Auschwitz and Birkenau were not suitable for this purpose." He added, "Whatever building one picks at Auschwitz, all are irreconcilable with the laws of physical science."

There is not an autopsy in existence that proves Zyklon B was the agent used to kill Jews during WW II.) In this light, Jewish holocaust historian Raul Hilberg testified under oath on Jan. 17, 1985, "There is no single scientific report that shows a gas chamber. I know of no autopsy."

Walter Luftl, president, Austrian Engineers Chamber—"Mass murder in the manner described with Zyklon B and with carbon monoxide cannot have taken place because it would violate the laws of nature and because the necessary technical and organizational prerequisites were lacking. The crematories could never have disposed of the number of victims. This may be considered proven by engineering science. Bodies are not a combustible material. Their cremation requires a great deal of time and energy."

In a Mar. 1992 report, Luftl referred to the elimination of Jews via Zyklon B as "technically impossible." He added, "Zyklon B is utterly unsuitable for the purposes of systematic mass murder."

Dr. William B. Lindsey—As a DuPont Corp. chemist for 33 years, he testified under oath in 1985, "I have come to the conclusion that no one was willfully or purposefully killed with Zyklon B [hydrocyanic acid gas] in this manner. I consider it absolutely impossible."

Dr. Charles Larson—A forensic pathologist that personally inspected war camps after WW II. After conducting over 100 autopsies at nearly two-dozen dif-

ferent locales, Larson could not identify a single body whose death had been caused by gas poisoning.

Jean-Claude Pressac—A holocaust supporter, he still admitted that 95 percent of all Zyklon B was used for pest control purposes.

It is also known that one of Zyklon B's qualities is that it clings very strongly to the surfaces it comes into contact with. Ordinary ventilation systems or fans aren't capable of removing it from walls, floors and ceilings.

However, when Fred Leuchter examined the supposed death chambers and then sent his findings to laboratories to be inspected, they found no significant residue in any of the brickwork or masonry where Jews were allegedly exterminated with Zyklon B.

Traces of Zyklon B would have remained in the walls at Auschwitz and other camps for hundreds of years, yet scientists can't find it . . . at least not in the rooms where Jews were alleged to be murdered.

On the other hand, in the delousing rooms where clothes and blankets were doused, substantial concentrations of Zyklon B were readily discovered. What conclusions can be reached from this analysis? Zyklon B wasn't utilized to gas millions of Jews in tiny concentration camp rooms. Rather, the Germans used it to *assist* Jews and save their lives by delousing their clothes and bedding materials that were infected with lice that caused typhus.

As proof, all the rooms examined after WW II that were used as delousing chambers exhibited a bluish discoloration—referred to as Iron Blue—that is known

to form after Zyklon B is used. In contrast, the supposed death rooms invariably did not show any signs of Iron Blue that results from chemical reactions via Zyklon B.

Under normal conditions, when Zyklon B is released and comes into contact with air, it takes approximately two hours for its contents to fully be exhausted. But so-called holocaust witnesses insisted that



after only 5-15 minutes Zyklon B asphyxiated hundreds of Jews, whereupon guards entered the room and dragged out the corpses—all the while these poisonous gasses continued to be released into the air.

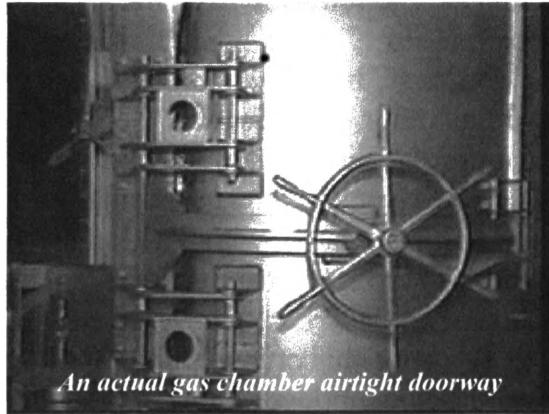
Photographs from Krematorium 1 at Auschwitz show a flimsy door that, we're told,

actually led to one of the gas chambers. Yet, this door is not airtight, not constructed with any sturdiness, and is outfitted with a keyhole. There's even a glazed window, and the door opened inward. If hundreds or thousands of corpses lay haphazardly inside this room, how

could guards have entered, especially when those inside would naturally have gravitated toward the only exit, i.e. this noticeably flimsy door?

On the contrary, gas chamber doors used to lock-in American prisoners that were executed (i.e., capital punishment) during the 1950s-'70s were constructed of especially strong metal that sealed airtight like a vault to prevent the escape of toxic fumes. Such a scenario obviously makes perfect sense.



So, to see these doors in comparison to the feeble ones at Auschwitz is startling, and their obvious differences are quite telling. None of the exhibits at Auschwitz, Birkenau and Majdanek reveals airtight doors or any semblance of proper ventilation systems compatible with the exhaust of Zyklon B after alleged victims were gassed.

At a bare minimum, it takes 20 hours to ventilate a room of Zyklon B, and only then when expert technicians monitor this highly complex process. Yet holocaust historians claim that mass murders took place at a helter-skelter pace with corpses and new victims being disposed of and ushered into these chambers at breakneck speed. To kill six million Jews, their efficiency would have had to exceed the 100 percent level.

As alluded to earlier, the primary reason for Zyklon B's use was to combat a scourge known as typhus that was transmitted via fleas, rodents and lice. Typhus occurred when large numbers of people lived in cramped, unsanitary quarters. To eradicate this outbreak of vermin, especially among soldiers, prisoners and workers, the gas Zyklon B was utilized in special delousing quarters.

Because lice often hide in human hair, Jews, as well as other captives, had their heads shaved in order to improve the hygienic process's effectiveness. Further, nearly everyone in Germany had their personal belongings treated with Zyklon B, including sailors, laborers, those in hospitals, SS soldiers and everyday citizens.

To prove this crucial point, the German Wehrmacht possessed countless invoices, especially at work camps such as Theresienstadt and Oranienburg, where even holocaust historians admit that no "homicidal gassings" occurred.

At this time, we must ask: Why would these facilities—where absolutely no accusations of mass murder were ever levied—be using as much Zyklon B as camps such as Auschwitz? Quite simply, because it had never been intended to eradicate Jews, but instead to delouse them, and just about everyone else in Germany and other Axis-occupied areas.

Princeton University's Dr. Arno Mayer called the typhus epidemic "devastating," while Jean-Claude Pressac referred to it as "catastrophic." Pressac further explained, "Everything had to be deloused immediately: personal effects, barracks, buildings and work

ships. Tons of Zyklon B was needed to save the camps.”

As previously noted, Zyklon B is a slow-acting agent that takes hours to be fully released. If the Nazis had wanted to exterminate Jews at lightning speed, there were countless other poisonous chemicals that would have been inordinately more efficient. Or, why not simply put a bullet into their heads instead of supposedly corralling hundreds of hysterical Jews into tiny, cramped rooms?

Zyklon B *protected* the Jews from disease on a large scale. It kept them alive and healthy. It was, in essence, their salvation and preserved their lives from death at the hands of a typhus epidemic. Krakow’s Institute of Forensic Research analyzed Auschwitz’s delousing chambers and boldly reported, “The result is a confirmation of the fact that in these rooms of Block 3, preparations of hydrogen cyanide such as in Zyklon B were used for disinfection.”

To reiterate an earlier point, the National Archives in Washington, D.C. confirm that equal case lots (six each) of Zyklon B were shipped to Auschwitz in Poland and the Oranienburg camp in Germany. Again, not a single historian has ever claimed that even one homicidal gassing occurred at Oranienburg. So, why would they receive the exact same amount of Zyklon B as Auschwitz, where mass murders supposedly transpired by the millions?

Because no exterminations via poison took place at Auschwitz, or anywhere else for that matter at Nazi hands, Zyklon B was an insecticide that German records clearly identified as being used to delouse clothes, mattresses and personal items. German

records also chronicle the purchase of gassing equipment needed to construct disinfecting chambers, not extermination rooms.

Now, if anyone actually inspected the various work camps, they'd quickly realize that the delousing chambers (i.e., for clothes, bedding etc.) were much too small to slaughter Jews by the thousands. These disinfection rooms—as opposed to fake death quarters—were sealed airtight before green cans containing Zyklon B were emptied inside them.

Interestingly, prior to WW II, Zyklon B had been sold on the world market as, of all things, a premier insecticide used for pest control; exactly like its function inside the German-controlled work camps. Similarly, the bureaucratic entity inside Germany's government that ordered Zyklon B was named the *Referat für Schadlingsbekämpfung*. Translated, these words mean Pest Control Office.

To continue this line of reasoning, Allied forces, including the U.S., also suffered a lice/typhus outbreak during the war. But instead of using Zyklon B as the Germans did, they implemented a new chemical called DDT.

To illustrate how ludicrous the “Zyklon B as an agent of mass extermination” story is, all one needs to do is examine the supposed gas chamber at Majdanek where photos actually show unbarred windows where Jews were allegedly killed. Similarly, the fumigation rooms at Auschwitz are never shown to visitors during their tours.

Yes, at Auschwitz, special buildings specifically designed to delouse clothes and mattresses still stand. Inside them during WW II were machines that intro-

duced and circulated Zyklon B, along with exhaust fans that then safely removed the toxic gasses once fumigations had ended.

Finally, let's be clear: Dr. William Lindsey, an esteemed chemist, stated definitively that Zyklon B was used to not only *sustain* the lives of Jewish workers, but that SS members were also subjected to the Zyklon B delousing process. Zyklon B was never, ever used to end human life. Rather, it protected people, maintained their health, and prevented them from dying horrible deaths from typhus.

Did Jews perish during WW II? Unequivocally, yes. Did they die inside homicidal death camps? Unequivocally, the answer is no. The primary cause of most deaths derived from a massive typhus epidemic that resulted from an inordinate number of people living in unsanitary conditions.

The big question is: why did so many individuals at Nazi work camps perish, especially during the final months of WW II? Quite simply, the Allied nations unleashed such an extraordinary onslaught against the Germans that supply lines were literally erased. As such, food, medicine and every other necessity for human survival never made it to installations such as Auschwitz.

Needless to say, Jews—as well as every other race or group of people residing there—died of starvation or disease. In addition, Germans

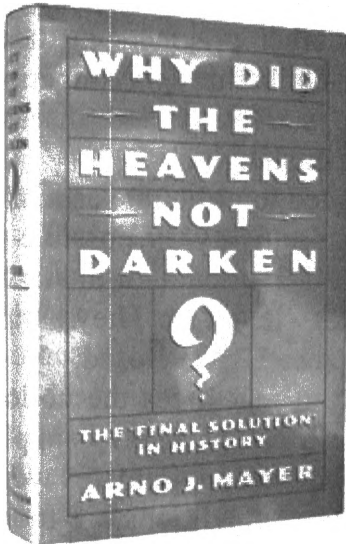

also perished for the very same reason. A 1948 Red Cross report confirmed this state of collapse. "In the chaotic condition of Germany after the invasion during the final months of the war, the camps received no food supplies at all, and starvation claimed an increasing number of victims."

To support this stance, a holocaust historian of the Jewish faith named Arno Mayer revealed in his 1988 book *Why Did the Heavens Not Darken*, "Sources for the study of gas chambers are at once rare and unreliable."



To combat massive doses of propaganda, astute investigators have presented a more accurate version of events that stands in stark contrast to an existing plethora of lies. For instance, photos

of the Bergen-Belsen camp in Germany show scores of emaciated prisoners living in horrific conditions. Historians then put forward the false notion that every person residing in all of these camps endured such hardships.

However, up until the final few months of WW II, such scenes were completely atypical of these work installations. They only deteriorated into an utter state of death after Americans and Brits wiped away nearly every supply line.

Of course, in war, the intended outcome is victory, so the Allies merely did what they deemed necessary to win. Via their widespread saturation bombings against nearly every major city in Germany, the entire logistical infrastructure broke down. Food trucks couldn't get through, nor could ambulances, while rail transport had been obliterated.

So, let's be clear: Jews, Germans, Christians, gypsies, homosexuals and many other prisoners in these work camps died *not* from a deliberate extermination campaign, but from typhus, starvation and disease caused by the Allied bombing onslaught.

Now, if the Germans intended to obliterate as many Jews as humanly possible—as quickly as possible—they never would have survived long enough to starve and walk around like emaciated skeletons. They simply would have been shot in the head, case closed.

But since many did starve, it reinforces the notion that food wasn't reaching these camps due to supply lines being cut. Ironically, since so many inmates were crammed together in unsanitary conditions, if more



Zyklon B had been on hand, more Jews (and everyone else) could have potentially survived.

Yet, as workers expired at an

alarming rate, the Nazis didn't even remotely possess enough resources to bury or cremate the disease-addled corpses. This situation then opened the door for exploitation on a tremendous scale.

Namely, gruesome photographs taken of these emaciated bodies piled in mounds were used to supposedly prove that Nazis exterminated Jews in their concentration camps.

None, however, was murdered, and all of them weren't Jews. The dead were of all nationalities, including Germans, and they perished due to diarrhea, dysentery, typhoid and a lack of food.

The lies continued because when holocaust historians used so-called evidence of Nazi atrocities at Belsen, Buchenwald or Dachau, most photos of

dead bodies stacked in piles were taken after the actual holocaust bombing of Dresden—a German city—by Allied forces on Feb. 13-14, 1945. Other photographed corpses were compiled from the firebombed cities of *Hamburg and Cologne*. *None of these bodies* were Jewish concentration camp victims.

Dresden was hardly an industrial city, and instead harbored countless refugees from the war that had no-

where else to go. Dresden posed no threat whatsoever to the Allies, yet it still faced the genocidal extermination of 135,000 innocent citizens.

At any rate, few are aware that scores of workers were actually liberated from camps such as Belsen and Dachau. News reporters filmed these individuals strolling from places like Buchenwald after Allied forces showed up. The prisoners were so overjoyed that they applauded, laughed and celebrated.

Included among the freed were Jews. Plus, when Allied doctors performed autopsies on the deceased at these camps, they found that the primary cause of death was disease. Medical technicians didn't release even one autopsy where those stacked in piles had been killed via gassing.

In all, horror films of supposed Jewish corpses piled in mounds were actually part of an extensive propaganda campaign used to mislead the world. At Dresden following the extensive air raids, German men, women and children were stacked in heaps of 400 or 500 bodies and then set ablaze. These images were later used to "prove" that Jews had been exterminated by atrocious Nazi killers.

The entire premise is an outright example of fakery. The Jews usurped these film reels and pictures and then posted them in museums to depict Germany's gruesome genocidal inhumanity. If there was any actual holocaust during WW II, it occurred in Dresden, not any concentration camp.

AUSCHWITZ (part one)

In late 1940, a prisoner-intensive work complex named Auschwitz was established in central Poland. Beginning in 1942 until mid-1944, a significant number of Jews were transported to this camp, which in actuality was a vast industrial center used to supply the Nazi war machine. Film footage from that time clearly shows a sprawling factory setting where tens of thousands of people labored. Also, these films depict acres of living quarters.

Why, if millions of Jews were to be exterminated,

would they be housed in these barracks? The answer is simple: the Jews were housed at Auschwitz so that they could work in this industrial center where shipments of coal were transformed into gasoline to support the German war economy.

Inarguably, the Germans maintained meticulous records with scores of documents relating to their industrializa-

tion efforts at Auschwitz. So, researchers have uncovered invoices for manufacturing, production, logistics and materials. But there has yet to be a single purchase order, blueprint, memo, contract or photograph of a single gas chamber (in operation) or the items needed to keep them intact. Admittedly, crematoriums and mortuaries did exist at Auschwitz, but they were used to dispose of sick and elderly inmates that perished during their stay. It goes without saying that the SS didn't possess enough manpower to dig graves for every person that died during the war's most intense moments. These installations also doubled as air raid shelters in times of intense Allied bombings.

Another curious fact is that up to 200,000 inmates at Auschwitz were relocated via train to other installations in Poland or Germany. Involved in these numbers were Anne Frank and Elie Wiesel.

From the summer to fall, 1944, anywhere up to 23,000 women of Jewish descent were transferred from Auschwitz to a camp named Stuffhof. Let's pause for a moment and ask two pressing questions. One, if sadistic mass murdering Nazis intended to kill six million Jews, why would they be tying up valuable resources moving Jews from one locale to another? Secondly, if Auschwitz were a mass extermination center, why relocate Jews who were supposedly aware of these atrocities to other camps where they could inform the authorities or fellow Jews? If Auschwitz attained the status of being the apex of Jewish slaughterhouses, why were so many Jews moved *out of there* instead of instantly killed?

Still, despite these logical arguments, official holocaust historians claim that beginning in early 1942, Nazis systematically gassed countless Jews in crematoria at Auschwitz. On Apr. 18, 1945 *The New York Times* reported that four million Jews had been exterminated at this locale alone. But then, on Jan. 26, 1995 both *The New York Times* and *The Washington Post* revealed that, at best, a total of 1.5 million *total* people—Jews and non-Jews alike—perished at Auschwitz from all combined causes, including sickness, disease and old age.

As a matter of fact, one of the functions reserved by the Germans for Auschwitz-Birkenau was to house Jews who were incapable of working. Grouped in this category were also the elderly and sick.

The numbers bear out this reality. On Sept. 4, 1943 the Nazi SS Economic and Administrative Main Office issued a report stating that of the 25,000 Jewish detainees at Auschwitz, approximately 86 percent were incapable of working. That means only 3,581 were fit for labor.

The following year, on Apr. 5, 1944 the director of Auschwitz's concentration camp, Otto Pohl, dispatched a report to Heinrich Himmler with these figures:

WARSAW (UPI) — A government commission has lowered the number of people believed to have perished at Auschwitz during World War II.

It drops the number from four million to 1.5 million and conceded the overwhelming majority were Jews.

The revision doesn't change the accepted historical figure of six million Jews killed by the Nazis.

The decision to revise the official Auschwitz number was a rejection of figures released after the war by the Soviets, who still have the records kept by the Nazis.

It is also in line with figures used by historians in West Germany, the U.S. and Israel who have documented the number of victims of the Holocaust.

Poland's former communist regime relied on the four-million figure in a bid to make Auschwitz a symbol of Nazi oppression of all peoples, not just the Jews.

Obviously, how do we get from 67,000 total prisoners in 1944 to an astounding four million Jews supposedly exterminated at Auschwitz? Jewish historian and Princeton history professor Arno Mayer put this matter into perspective via a 1988 white paper entitled *Why Did the Heavens Not Darken: The 'Final Solution' in History*. In this study, Mayer stated that at Auschwitz from 1942 to 1945, more Jews perished from natural causes than any other factor.

The reason why is that up until its supply lines were eradicated by Allied bombing campaigns near war's end, Auschwitz provided quite a number of amenities, comforts and outright luxuries to those being held.

An overview of what actually existed at Auschwitz is included below:

- A concert auditorium
- Dance halls
- Swimming pool
- Library
- Non-denominational church where marriages were performed
- Post office
- Soccer fields
- Movie theaters
- Brothel for the workers
- Art centers
- Daycare centers for mothers and babies
- State-of-the-art kitchen
- Plus, there were over 100 different concentration camp currencies issued to workers at facilities such as Auschwitz, Westerbork, Ravensbruck, Dachau, Buchenwald and Oranienburg.

Obviously, if Auschwitz were a highly efficient death factory, why would the workers get paid in actual camp coupons or “scrip” that they could use at on-site stores? In addition, critics complain that all of the above luxuries were provided only to German workers and Nazi guards.

X { Yet, a Jewish worker-inmate at Auschwitz, Marc Klein, who later became a professor at the University of Strasbourg Medical School, admitted, “On Sunday afternoon, there were soccer, basketball and water polo matches to the ardent cheers of spectators . . . the SS administrators allowed regular amusements for the prisoners.”

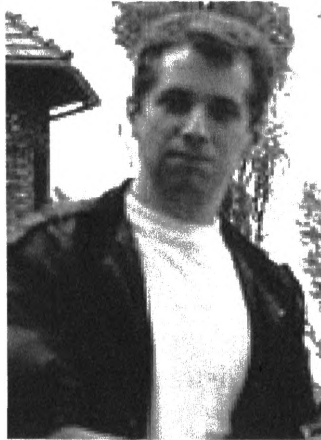
These pastimes included an orchestra, cabaret and film theaters. If the Nazis were slaying Jews non-stop at the Auschwitz slaughterhouse, why provide so many creature comforts for the detainees, many of whom were Jewish?

Here's another interesting point. Again, the source is Jewish holocaust historian Arno Mayer in his book *Why Did the Heavens Not Darken*. "Birkenau was the site of Auschwitz's main medical facility and quarantine center."

The Auschwitz Museum has records verifying that from June 1942 until June 1943, 15,705 prisoners, a large percentage of them Jewish, were the recipients of medical care at an Auschwitz camp called Monowitz.

To reiterate using simple logic, if the Nazis wanted nothing but to exterminate Jews, why were they also *treating* them in Auschwitz hospitals? Are we to believe the Germans wanted to make sure they *felt better* before gassing them, or that they only wanted to murder healthy Jews, not sick ones? Plus, since Auschwitz also maintained a quarantine center, are we to assume that prisoners were deloused prior to being shoved into ovens . . . that they didn't want to kill Jews infected with lice?

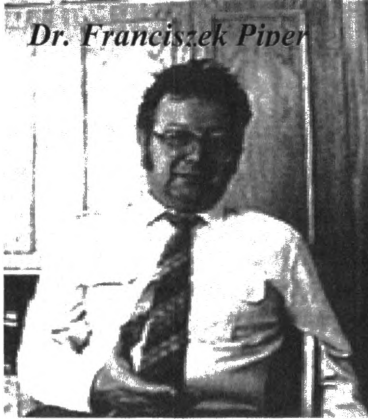
To move this line of reasoning forward, a Jewish researcher named David Cole visited Auschwitz in 1992 and interviewed, on film, the senior curator and director of archives of Auschwitz's State Museum, Dr. Franciszek Piper.

by the Soviets. Piper also dropped a number of other bombshells:

- During WW II, what had originally been an air raid shelter was transformed into what the Jews later called gas chambers. These air raid bunkers helped shield workers from any potential Allied bomber planes.

- To accommodate the transformation of these air raid bunkers, the inside walls of five smaller rooms, including a bathroom, were removed to give the appearance that it was a much larger “death chamber.”

- Although visitors are told that Auschwitz has remained in its *original condition* and that no walls had been knocked down, in actuality dramatic changes had been made.

- Aerial photos snapped during WW II by Allied forces showed no holes in the ceilings of any “extermination centers”

at Auschwitz. Piper disclosed that four holes in the ceiling of Krema I—where Zyklon B was supposedly dropped in to kill Jews—were drilled after WW II.

- The smokestack at Crematorium I was a reconstruction following the war and is *not even connected* as a form of exhaust to any of the buildings where ovens were allegedly used. This chimney at Birkenau served as a powerful symbol of the Nazis viciousness . . . except, of course, it never existed until being built years later.

- Another Auschwitz tour guide and supervisor admitted to Cole that the ceiling holes were not original. Piper concurred during this documentary that the eradicated walls and induction chimney were fabricated for the benefit of tourists to “prove” Adolf Hitler’s “Final Solution.”

- The so-called “white cottage” at Auschwitz’s Birkenau complex was also renovated to give the appearance of being a gas chamber.

Adding support to Cole’s claims is Robert Jan van Pelt, whose 1996 investigations at Auschwitz confirmed that many aspects of the “gas chambers” were erected by Poland’s communist government following the war as a method of impressing (or indoctrinating) tourists.

Similarly, in a Nov. 29, 1993 edition of England’s *Guardian* newspaper, Dr. David Cesarani, director of

London's Weiner Library, likewise admitted that so-called gas chambers were constructed in 1948—three years after WW II. He added that another crematorium chimney, built at the same time, was merely “symbolic” in nature and not functional.

Another German chemist, Germar Rudolf, demonstrated that holes drilled into the ceiling at Crematorium II were elaborate hoaxes used to trick visitors into imagining that Zyklon B capsules were dropped into massive death chambers to mass murder Jews. Yet, it's all an illusion, and not a very well crafted one at that.

If anyone is still not convinced, in Jan. 1995 the esteemed French magazine *L'Express* agreed that “everything about this ‘gas chamber’ [at Auschwitz] is false” and that it was nothing more than a postwar fabrication.

To show how far the lies concerning Auschwitz stretched, an ally of premier holocaust hoaxer Deborah Lipstadt—Prof. Robert Jan van Pelt—testified, “99 percent of what we know about Auschwitz we do not actually have the physical evidence to prove.”

99 percent. Thus, to replace proof, holocaust historians have relied on eyewitness, postwar “confessions.” Let's examine some of these ludicrous revelations.

- Its already been established that the famous Auschwitz chimney was constructed after WW II. Yet, SS guard Henryk Tauber lied by playing the sympathy card when testifying, “The especially high flames shooting out of the chimneys were to attract the attention of pilots.”

- Supposed prisoner Harry Gross claimed that he was held at Auschwitz for six and a half years. However, Auschwitz only operated from late 1941 to the first month of 1945 . . . a total of little more than three years.

- Photos in Israel's Beit Lohamei Hagetaot museum archives allegedly depict corpses piled in mounds at

Auschwitz. But after further research, it was discovered that the pictures were taken after the horrific Dresden fire-bombings.

- Auschwitz occupant Szlama Dragon described how Jews were cremated in huge 10-foot-deep ditches dug by the Nazis. The only problem: a human body cannot be cremated in a ditch due to its inability to reach the extremely high temperatures required, as well as its inherent lack of an adequate oxygen supply. Bodies may be singed or charred, but it's physically impossible to reduce them to ashes in a ditch. Had Dragon said that open pyres were utilized for crema-

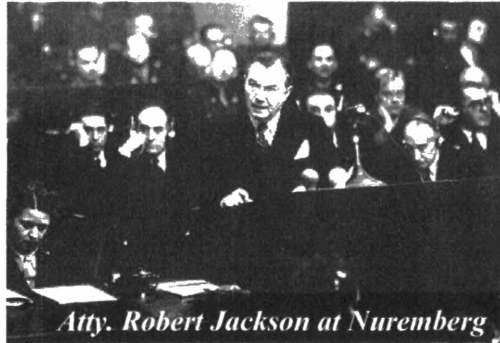

tion, the story would be believable, but the ditch fairy-tale is preposterous, especially since swampland surrounded Auschwitz and the water table sat four feet below ground level. A 10-foot deep pit is impossible because they would have hit water at four feet.

- An initial story circulating among holocaust fabricators involved trucks backing up to death rooms filled with Jews and filling them with carbon monoxide from their exhausts. When people realized the sheer lunacy of this method, it was quietly dismissed.

- Dr. Rudolf Vrba perfunctorily asserted that he personally saw Heinrich Himmler gazing through a window into the gas chambers to watch Jews writhing in pain and dying. Yet, when questioned in court, he backtracked and said he actually didn't witness Himmler himself, but heard it through second- and third-hand accounts.

- At the Nuremberg Trials, U.S. Atty. Robert Jackson introduced testimony that the Nazis used a special vaporization technique which immediately killed 20,000 Jews at a time and left no remnants whatsoever. No historian on any side of this debate accepts such an insane tale.

- Similarly, on Dec. 5, 1945 a communist judge at the Nuremberg Trials directed "Accusation No. 6" against a man on trial named Hans Frank for allegedly using the following tactic: "A large boiler for the pro-

duction of super-heated steam was injected into the interior of the rooms. The doors are closed hermetically and the long asphyxiation of the victims by the steam begins. At the start, screams came from inside, they die down slowly; after 15 minutes the executions are completed.” Again, after being thoroughly debunked, holocaust historians abruptly swept this story under the rug.

- Henryk Tauber again perjured himself on the stand with this whopper about how the Nazis cremated Jews *without using any fuel*. “When one cremation followed another, the ovens used embers given off during the cremation as fuel. For this reason, we usually extinguished the fire during the cremation of fat bodies.” Strangely, hasn’t everyone been told that Nazis starved the Jews, so where did all these fat prisoners originate? Plus, the human body is made up of 60 percent water. Bodies can’t burn by themselves, and they certainly can’t be used to cremate other bodies.

- The Simon Wiesenthal Center has photos depicting prisoners at Auschwitz with an adjoining caption: “As these prisoners were being processed for slave labor, many of their friends and families were being gassed and burned in ovens in the crematoria. The smoke can be seen in the background.”

Except, experts proved that these pictures were air-brushed *adding in the smoke* at a later time. Crematoria don’t produce smoke or flames.

After being embarrassed by this ruse, the Wiesenthal Center deleted all references to smoke. After the controversy persisted, they were then forced to remove the altered photo and replace it with the original . . . the one showing no smoke.

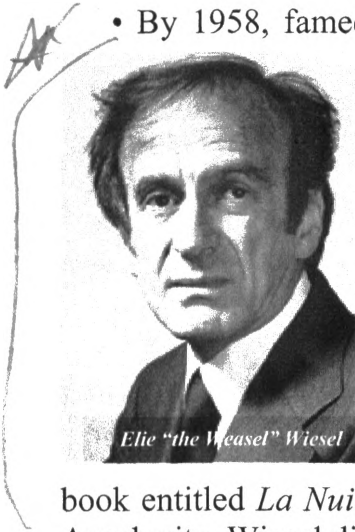

- Nazi SS driver Richard Boerk deceived jurors at Frankfurt's Auschwitz trial that ran from 1963 to 1965 by proclaiming that after Jews were killed in gas chambers, "The door was opened and we could still see a blue vapor floating over a gigantic pile of bodies." However, if Zyklon B were used—as is the official story—the hydrocyanide gasses emitted from it would be colorless. It's impossible for any type of blue vapors to exist.

- Referring to themselves as "eyewitnesses," Soviets told the Russian newspaper *Pravda* on Feb. 2, 1945 that Nazis were methodically executing Jews with "an electric conveyor belt on which hundreds of persons could be electrocuted simultaneously and then moved into furnaces. They were burned almost instantly, producing fertilizer for nearby cabbage fields." Needless to say, this account was buried as being another fanciful deception.

- By 1958, famed holocaust celebrity Elie Wiesel wrote that he actually saw Germans burning Jews alive. "Not far from us blazed flames from a pit, gigantic flames. They were burning something. A lorry [truck] drove up to the pit and dumped something into it. They were small children. Babies! Yes, I had seen it with my own eyes!"

Oddly enough, in his earlier book entitled *La Nuit* that detailed his eight months at Auschwitz, Wiesel didn't make a single mention of gas chambers being used at this facility. Further, even the most ardent holocaust fanatics have never stated that Nazis burned still-living Jews in pits of fire.

However, Jewish religious folklore does contain stories of Jewish parents sacrificing their children in huge pits of fire to the god Moloch.

The issue of Auschwitz's "death chambers" must be addressed once again. First of all, the doors suppo-

sedly used to lock prisoners in their execution rooms were so flimsy as to be laughable. Photos show these doors being made of wood and incapable of being hermetically sealed. As such, with no gaskets, Zyklon B would have naturally seeped out, killing the SS guards. Worse, there are *gaps* between the floors of these rooms and the bottoms of the doors, therefore allowing any gasses to quickly escape. Other photos clearly reveal windows on the doors

made of a single pane of glass. Had prisoners desperate for their lives been inside, they obviously would have smashed these windows within seconds.

Plus, the doors opened *inward*. If piles of corpses were lying inside, wouldn't the Germans design doors that opened *outward* so they could get to the bodies for disposal?

In their original state prior to being reconstructed, these “death chambers” were actually shower units that possessed water pipes running along their ceilings. A holocaust historian named Jean-Claude Pressac concurred in his 1989 book *Auschwitz: Technique and Operation of Gas Chambers* that a door on display at Majdanek used to contain Jews was, in actuality, of a “non-homicidal variety” . . . i.e. it’s purpose was solely to seal a room used to delouse clothing.

Further, Auschwitz’s original design plans still exist, and none of them depict what could be called “gas chambers.” Moreover, these plans—again, original and unaltered—did not contain provisions for exhaust units to dispense of any supposed poisonous gasses. Lastly, no crematoria smokestacks ever existed in the design plans or construction at Auschwitz. There weren’t any whatsoever. All of these “show pieces” were added later for the benefit of museum visitors.

Then there’s the matter of sheer numbers. Historians demand that anywhere upwards of 600-800 Jews were simulta-

neously crammed into the Krema I gas chamber. However, with a mere floor space of 844 square feet, at the very most 100 people could fit into this area. Considering the obvious struggle under such perilous circumstances, quite possibly only 40-50 people could be corralled at a time before total bedlam resulted.

At any rate, the next matter at hand is the subject of cremation. Morticians agree that it requires approximately 60-70 minutes—using up-to-date technology—to adequately cremate a human body. Now, if we buy the version of events provided by holocaust historians—namely, that ovens at Auschwitz were used for, at best, a total of 600 days—let's do some mathematics. If every supposed oven at Auschwitz ran non-stop except for maintenance and the removal of ashes, the TOTAL number of bodies that could have been cremated was 374,000.

✱ Repeat: 374,000. Now, how do we go from this figure to the four million total that stood for decades? A Canadian man named Ivan Lagace, who managed a crematory, revealed during the Apr. 1988 Ernst Zündel trial that the Auschwitz cremation tale was “preposterous” and “beyond the realm of reality.” He added that allegations regarding the incineration of 10,000-20,000 Jews every day was “technically impossible.”

If all the supposed ovens at Auschwitz had worked non-stop *with no downtime whatsoever*, it would have taken until 1972 to incinerate four million bodies.

On that note, if four million bodies had been cremated, it would result in 15,000 tons of ashes. In pounds, that equals 30 million pounds of ashes. There has never been one photograph showing these mountains of ash that would have been produced.

In addition, imagine how many tons of coal would have been necessary to cremate four million Jews. It would require trains traveling around the clock to Auschwitz delivering the coal needed to cremate four million Jews. But there are no Allied reconnaissance photos in existence revealing huge supplies of coal (millions and millions of them) at Auschwitz. Nor do German records support any such massive deliveries to Auschwitz in regard to this much coal. Rather, the Nazis actually needed coal to fuel their war machine, not incinerate Jews.

In all, two researchers—Carlo Mattogno and Franco Deana—estimated that at the very most, 162,000 bodies of the sick and elderly were cremated at Auschwitz after they died natural deaths.

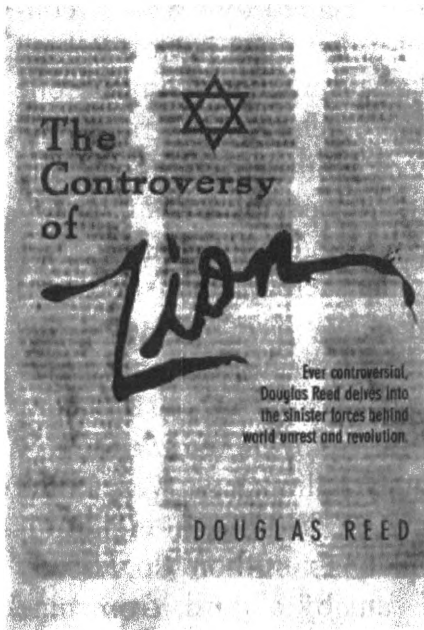
Despite this indisputable arithmetic, a Jewish woman named Kitty Hart authored a book entitled *Return to Auschwitz*. In this tome she stated, “Working around the clock, the four units together could dispose of about 18,000 bodies every 24 hours, while the open pits coped with a further 8,000 in the same period.”

Using Ms. Hart’s astounding calculations, the Nazis could have murdered six million Jews in approximately eight months. Has anyone ever stopped to analyze the insanity of these outrageous claims?

Fortunately, a few individuals have stepped forward to speak the truth on this matter. A Jewish woman named Olga Wormser-Migot penned a book in 1968 published by the *Presses Universitaires de France* that proclaimed, “Auschwitz I, which was to remain the model camp and simultaneously the administrative center, had no gas chamber.”

A few other facts: Historian Douglas Reed in *The Controversy of Zion* stated that the Germans and Japa-



nese killed—in total—approximately 850,000 soldiers during WW II. Plus, Oskar Schindler's widow has gone on the record saying that Steven Spielberg's film *Schindler's List* is rife with lies. Then, by the time Russians reached Auschwitz in 1945, only about 11,000 inmates remained at this decimated facility.

Most importantly of all, Theis Christopherson—who spent nearly a year at Auschwitz—wrote, “I was in Auschwitz from Jan. 1944 until Dec. 1944. After the war I heard about the mass murders [that] were supposedly perpetrated by the SS against Jewish prisoners, and I was perfectly astonished. Despite all the evidence of witnesses, all the newspaper reports and radio broadcasts, I still do not believe today in these horrible deeds. I have said this many times and in many places.”

Christopherson continued, “During the whole of my time at Auschwitz, I never observed the slightest evidence of mass gassings. Moreover, the odor of burning flesh that is often said to have hung over the camp is a downright falsehood.”

To simplify this matter, it would help if Jewish historians merely released a master list of the six million Jews who were supposedly executed by Nazis in concentration camps. But, such a list does not exist even though various individuals have tried to compile one over the years. The major problem is: the grand total never came anywhere near six million, and those who did perish never did so inside ovens or gas chambers.

Yet, grossly deceptive exaggerations have flourished for decades. Despite the sacred Kabalistic figure of six million being permanently fixed in stone, this outlandish fairytale number has been significantly eroded in recent times.

Originally, a film entitled *Nuit et Brouillard* claimed that a whopping nine million Jews were killed in WW II. Other sources placed the totals at eight million, seven million, then finally six million. So, already we've reduced the grand sum by a third, from nine million to six million.

At the bogus Nuremberg Tribunal, an official figure of four million was established as the total number of Jews slaughtered at Auschwitz. But then, this figure for Auschwitz kept dropping.

• Jewish movie director Claude Lanzmann set the bar at 3.5 million;

- SS commandant Rudolf Hoess testified at Nuremberg that three million Jews were murdered;
- Jewish prisoner Rudolf Vrba diminished it to 2.5 million;
- Lucy Dawidowicz reduced it down to two million;
- Finally, Jewish holocaust historian and author ~~X~~ Yehuda Bauer furthered the decline to barely over one million.

Incidentally, other German camps similarly experienced dramatic reductions in death totals. For example, in 1946 it was claimed that over 238,000 Jews were murdered at Dachau. Today, that figure is barely over 20,000.

Yet, up until 1990, a plaque at Auschwitz read: "Four million people suffered and died here at the hands of the Nazi murderers between the years 1940 and 1945."

But then, miraculously, in 1990 a new plaque was erected at

Auschwitz with this inscription: "May this place where the Nazis assassinated 1,500,000 men, women and children, a majority of them Jews from diverse European countries, be forever for mankind a cry of despair and of warning."

Wait a second. The Auschwitz death toll—in the snap of a finger—plummeted from four million to 1.5 million overnight. That's a reduction of 2.5 million.

So, how does the mythical six million remain? Shouldn't this figure—logically—also be immediately slashed by 2.5 million to reflect Auschwitz's admission? Shouldn't it correspond to reality?

But did a million individuals—Jews and non-Jews—die at Auschwitz, or was the sum even lower? A 1995 report entitled *The Changing Face of Holocaust Memory* released by the American Jewish Committee clearly stated, "The figure of four million was as wrong as it was round, arrived at by a combination of the camp's commandant's self-aggrandizing exaggerations, Poles' perceptions of their great losses, and the Soviet occupiers' desire to create socialist martyrs."

Where did these "lost" 2.5 million Jews go? How could such an enormous quantity of people simply "poof" away like chalk from a blackboard? Even more startling are various individuals who've weighed in with starkly lower totals.

- Jewish historian Raul Hilberg set his best estimate regarding the total deaths of all Jews during WW II at nearly 897,000.

- A Swiss publication called *Die Tat of Zurich* conducted a survey rooted in International Red Cross find-

ings and published them on Jan. 19, 1955. They fixed the number of individuals “who died in prisons and concentration camps between 1939 and 1945 at 300,000, not all of whom were Jews, and this figure seems the most accurate assessment.”

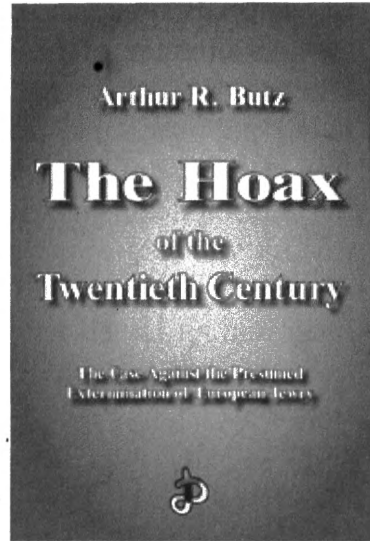
- Arthur Butz, author of *The Hoax of the Twentieth Century*, concluded that less than half a million people *in all* died in German concentration camps during WW II, only a small percentage of whom were Jewish. He also estimated the total deaths at Auschwitz as being 125,000.

- Author, editor and analyst Fritjof Meyer wrote in *Osteuropa* that anywhere from 500,000-510,000 prisoners died in concentration camps, including Jews and non-Jews.

- According to Gerald Reitlinger, author of *The Final Solution*, the total number of registered detainees at Auschwitz during the entire course of WW II was 383,000.

- Israel Gutman, author of *Anatomy of the Auschwitz Death Camp*, placed this total at 405,000.

- Franciszek Piper has gone on record as saying that 197,820 inmates survived Auschwitz. He also wrote, “When Soviet soldiers liberated the camp in Jan. 1945, they found documents that confirmed only 100,000 deaths.”

- At Auschwitz I, on the back wall of Room 6, a plaque discovered by the German Contemporary Historical Educational Trust on June 5, 1985 read: "During the period of this camp's existence, 405,222 prisoners—men, women and children—were entered in the books. Of this number, around 340,000 persons perished at Auschwitz and in the other camps."

- As director of holocaust studies at Jerusalem's Hebrew University, Yehuda Bauer published an article in Nov. 1989 admitting that the four million deaths at Auschwitz was a "deliberate myth." The following year, in July 1990, Bauer and an Israeli named Yad Vashem declared at Poland's Auschwitz State Museum that, altogether, possibly one million of those housed at this camp died (Jews and non-Jews).

- Charles Biederman—using records from Germany's Special Registry Office—confirmed that a total of 373,468 individuals were issued death certificates at Auschwitz during WW II.

- When the Soviet army finally retrieved records from Oranienburg in Apr. 1945 they discovered that the overall death count in every German labor camp combined over the course of 10 years came to 403,713. Interestingly, the Russians kept these documents secret for 45 years. As for Auschwitz alone, the sum came to 73,137 total deaths. Of these, only 38,031 were Jewish. Most of these deaths resulted from typhus, while the onsite crematoria were intended to sanitarily dispose of

the corpses so that more people didn't die from disease. Moreover, Catholic deaths far outweighed those of Jewish deaths at Auschwitz.

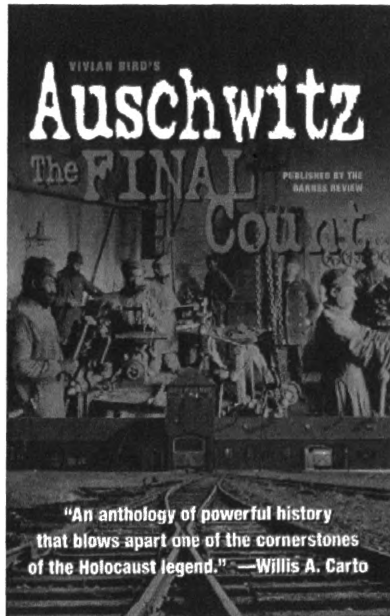
The Soviets also refused anyone access to Auschwitz for nearly 10 years after WW II. During that decade, they engaged in massive renovations to perpetuate the myth that millions were executed.

- In *Auschwitz: The Final Count*, editor Vivian Bird placed the number of inmate deaths at Auschwitz at 73,137. Bird assessed that she arrived at this figure by inspecting records directly from this facility.

- A quote from Shmuel Krakowsky, director of research at the Yad Vashem Museum in Israel, is particularly interesting. "The four million figure was let slip by Capt. Rudolf Hoess, the death camp's Nazi commander. Some have bought it, but it was exaggerated."

- If approximately 400,000 individuals were registered at Auschwitz and approximately 150,000 of all races and nationalities perished there, then 62 percent of everyone who entered Auschwitz survived.

To conclude this section, the Allies "Enigma" code-breaker at Bletchley Park decrypted Nazi radio dispatches by as early as 1943, including all those ori-

ginating from Auschwitz. Not once was there any notation of deaths occurring from gas chambers, hangings or shootings. However, they do mention illness as leading to the vast majority of deaths.

Now, if the Allies *did* become aware of millions of executions in death camps, wouldn't they have dropped leaflets all across Europe to inform the citizenry, especially in Germany? If an actual occurrence, these war crimes would have been shouted from the rooftops far and wide. Also, in 1943 after breaking the German military code, why weren't there any reports of widespread executions broadcast on radios all across Europe?

X Also, in 1979 the CIA released a cache of aerial recon photos that were obtained while flying over Auschwitz-Birkenau. These pictures were repeatedly taken beginning in 1943 and continued throughout 1944 when—according to holocaust historians—most of the supposed murders occurred.

But, when viewed, these documents show no lines of Jews awaiting execution. They also show no spewing chimneys, no huge piles of corpses, no skies blackened by smoke from crematoria, no huge ash piles, burning pyres, or blazing fires from the alleged smokestacks (that didn't even exist at the time). Nor is there any photographic evidence of enormous fuel storage units that would have been a prerequisite to kill millions of Jews.

Last but not least, if the Allies had seen via their aircraft thousands, if not millions, of Jews being executed at Auschwitz, why not simply bombard the Hungarian rail lines leading to this facility so that no one else could have been transported there? Without

access via train, no more Jews would have been carted to these supposed concentration camps.



DACHAU & BELSEN

As we'll learn in a later chapter, even Jewish historians admit that no death camps existed in Germany proper. One of the most infamous of these supposed extermination centers—Dachau—was located in Germany.

So, why are people still told of thousands of Jews being nullified at Dachau? Noted Nazi hunter Simon Wiesenthal has gone on record as clarifying that there were no gas chambers at Dachau.



Still, today, when visitors are led through the Dachau Museum near Munich, they're shown tiny rooms that were allegedly used as gas chambers. In actuality, what they're being shown are installations that were either used as delousing chambers or crematoria for already deceased workers.

Photographs from the end of WW II show the door to one of these rooms depicting a skull & crossbones, along with

the warning: “Danger—Gas—Keep Out.” Now, why would the Nazis place such warning signs on a door if they intended to asphyxiate Jews with Zyklon B?

Robert Faurisson has firmly established that no gas chambers had been constructed by 1945 when Dachau was liberated. Researcher David McCalden also determined that “fully functioning gas chambers” at Dachau were an outright lie. One of the rooms now shown to visitors was actually a fumigation chamber used to delouse clothes. The fake showerheads supposedly used for spraying out poisonous gasses were only added later, after the end of WW II.

A publication called *Our Sunday Visitor* dated June 14, 1959 includes a quote from Stephen E. Pinter, who disclosed, “I was at Dachau for 17 months after the war, as a U.S. War Dept. attorney, and can state that there was no gas chamber at Dachau. What was shown to sightseers there and erroneously described as a gas chamber was a crematory.”

Similarly, Bergen-Belsen was an internment camp, not an extermination center. A 1945 photograph from the BBC documentary *In the Camps* shows the faces of young children standing behind barbed wire with smiles on each of their faces.

However, as the final months of WW II wound down and Germany drew closer to defeat, their supply lines were cut off, food dwindled, and disease set in.

Typhus reached epidemic levels, and Jews died. Helmut Diwald, a professor at Erlangen University, set the record straight about those who were supposedly exterminated. "Actually, about 7,000 inmates died during the period when the camp existed from 1943 to 1945. Most of them died in the final months of the war as a result of disease and malnutrition, consequences of the bombings that had completely disrupted normal deliveries of medical supplies and food. The British commander who took control of the camp after the capitulation testified that crimes on a large scale had not taken place at Bergen-Belsen."

As a propaganda device, however, Belsen became a masterpiece. When the Brits entered Belsen only weeks prior to war's end, they discovered the unburied bodies and emaciated corpses of those that had recently starved to death or died of typhus.

Mass graves were only dug *after* Allied troops had reached Belsen. None were ever dug by the Germans, who had lost control because of supply lines being cut. The Allies proceeded to photograph the dead and those who were starving and then circulated them around the world as "proof" of Belsen being a "concentration camp" where Jews were exterminated.



TREBLINKA



Holocaust historians insist that mass graves surrounded the Treblinka labor camp following WW II. But, when recon photos were analyzed, there was absolutely no evidence that the grounds around this installation were ever obstructed enough to facilitate the burial or burning of inordinate numbers of Jewish prisoners.

Initially, Jewish author Vasily Grossman purported that three million of his people were exterminated at this “death factory” in little over a year. According to Grossman, the modes of death were steam chambers and the use of diesel-powered engines.

Yes, as opposed to gas chambers—which the story was later changed to—at Nuremberg witnesses said Jews were actually killed by steaming them to death.

However, a maximum of only 6,000 inmates could be held at the Treblinka camp at any one time.

In addition, others testified that diesel engines spewing massive amounts of carbon monoxide caused the deaths of their fellow workers. The major drawback of this argument is that diesel engines don't even remotely produce enough carbon monoxide to kill people except in rare cases. Because diesel engines require large quantities of oxygen to operate, the use of carbon monoxide would be quite possibly one of the least efficient modes of mass murder imaginable. In essence, these stories are lies.

A few other glaring inconsistencies cast doubt on the Treblinka account. First, we're told that the deceased were buried in massive burial pits. But these supposed sites were located directly next to Treblinka's water supply, which would have naturally been contaminated if millions of corpses were laid in the ground right next to it.

But this little problem is nothing compared to another whopper. Specifically, in Oct. 1999 an engineer named Richard Krege visited Treblinka to find the locale of these supposed mass graves. Armed with the same type of ground penetrating radar equipment that archaeologists now use, Krege couldn't discover even a single mass grave at Treblinka.

Naturally, this discovery (or lack thereof) poked a major hole in the Treblinka deception. So, to cover their tracks, Vasily Grossman offered an update—that the notorious Heinrich Himmler traveled to this labor camp in 1943 and demanded that all the corpses in these supposed mass graves be dug up and then burned to erase any evidence that three million Jews had been

killed. Furthermore, the bones—approximately 6.6 million pounds of them (or so we're told)—were then ground to bits using wooden rollers and metal sheets.

Again, in 1943 WW II raged at its most extreme. Can you imagine how many men would be needed to dig up three million Jews, pulverize their bones, and burn them on massive pyres? Only 40 men were ever employed at any one time at Treblinka. So, how could they have ever murdered millions of Jews? The Germans didn't enjoy the luxury of tens of thousands of spare men to engage in such a monumental undertaking. They didn't even have at their disposal that many prisoners of war to accomplish such a feat. It's impossible.

As further proof of its profound absurdity, burning three million Jews would have required so much wood that evidence of it would have surely survived. But Germany's *Reichsbahn* records have no listings anywhere for large quantities of wood being shipped via rail to Treblinka.

Moreover, to cremate a body in an open pit necessitates approximately 200 kg of wood. To dig up and cremate even 800,000 corpses (the revised number for Treblinka) would require at the very minimum over 170,000 trees. It would take nearly 3,000 woodcutters working full-time

shifts to eradicate miles of forestland, chop down all these trees, trim them to size, transport them, unload them, and stack them so that massive bonfires could be lit. It's an enormous job demanding thousands of men that weren't available during this chaotic stretch of the world's most destructive war.

Additionally, photos taken during this time reveal no rampant deforestation near Treblinka. So, again, why hasn't anyone ever presented verifiable evidence of mass graves at this camp, or mountains of ash from the supposedly exhumed corpses that were burnt? For that matter, there aren't even any large-scale disturbances of soil that would have surely resulted from such an ambitious project. Nor were millions of bones or teeth ever discovered in the grounds surrounding Treblinka.



THE TRUTH ABOUT CREMATION

To reiterate a few points from the previous chapter, if nearly 900,000 corpses were cremated at Treblinka in an open-air pit, by best estimates 350 million pounds of wood would have been needed to accomplish this task. As a byproduct of such a process, over five-and-a-half million pounds of ash would have remained, in addition to more than 20 million teeth.

To conceal the evidence, holocaust historians forward a notion that Germans covered the ashes with a layer of dirt. But imagine how much topsoil is needed to conceal five million pounds of ashes. Again, as with every element of this tale, it stretches credulity to a laughable extent. Depending on the size of a corpse, the ashes from an adult weigh up to nine pounds. Do the mathematics. There would be millions of pounds of ashes.

In the book *Denying History* by Michael Shermer, the following passage conveys a startling truth. "In Aug. 1944 the Soviet army carried out investigations on the grounds of Treblinka. And what did the communists find after one week of digging at this site? Not so much as one single grave—mass or otherwise—and not so much as one single corpse, skeleton, skull, complete bone, bone fragment, tooth, ounce of human ash, bullet or shell casing. The only thing they found was refuse pits filled with burned and unburned trash."

A judge at the Nuremberg Trial, Lukasziewicz Maciejewski, corroborated this report regarding Treb-

linka. "During work on the terrain, I found no mass graves."

Yet the Jews purport that 870,000 corpses were buried in mass graves. Then, they were allegedly exhumed and incinerated in massive pyres that rose in height many feet into the air. Still, no traces of this carnage can be located anywhere using the most updated modern technology.

Simple common sense also refutes the cremation-conspiracy theory of this many individuals. At Nuremberg, a Jewish witness named Dov Paisikovic testified that the total amount of time to cremate a body is four minutes. Another "survivor," a Polish Jew Henryk Tauber, went further by stating that at Auschwitz, no fuel was even necessary to burn their corpses.

The outlandishness continues. At Birkenau, a witness named Miklos Nyiszli alleged that Nazis were cremating 20,000 Jews a day. With only 46 "muffles"

(or openings) supposedly at their disposal, the Nazis—using equipment that lacks in comparison to today's technology—were still burning bodies multiple times

more efficiently than morticians could during our present time.

However, as stated earlier, human bodies consist of 60 percent water that, naturally, doesn't lend itself well

to cremation. In fact, it's hard to completely make a corpse disappear. Most experts agree that rather than a mere four-minutes, the cremation process for a single body nears the one-hour mark. *

Now, if ovens were used to cremate Jews, at least half the time required for these devices to operate efficiently must be reserved for ash disposal, cleaning and regular preventive maintenance. In other words, they cannot run 24 hours a day, seven days a week non-stop. Also, crematoria absolutely do not belch fire and smoke, thus confirming that photos at Auschwitz depicting such an occurrence were deceptively altered. *

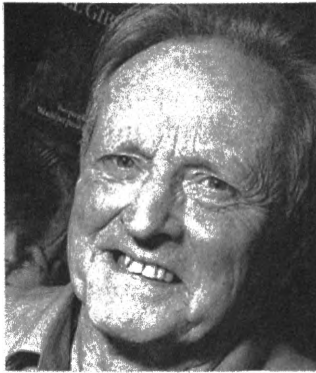
One may ask: why, then, did Nazi work camps have on-site crematoria? The answer: to sanitarily dispose of the elderly, sick and diseased that perished at these facilities. The Germans desperately didn't want any further outbreaks of typhus that would affect their healthier workers. *

Moreover, it's out of the question that hundreds of thousands of corpses could be cremated in open pits because there's not enough oxygen between bodies to allow them to be destroyed by the blazes. Fire requires oxygen, and when bodies are stacked in mounds, there's not enough oxygen amid each corpse to fuel the fire.

Of course, there is also zero evidence of massive deforestation surrounding Treblinka. So, to compensate, holocaust apologists suggested that motor oil was used to cremate these people. But researchers delving into this matter assert that almost five million liters of oil would have been needed to incinerate up to 100,000 corpses. If nearly 900,000 Jews were suppo-

sedly cremated, we're now nearing 45 million liters of fuel needed for this endeavor.

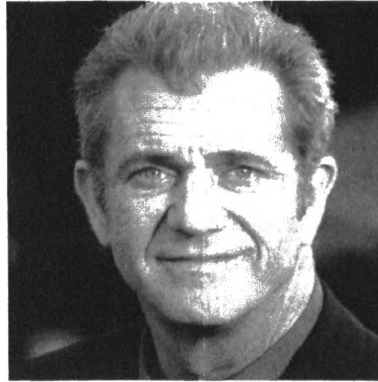

Be that as it may, the Germans lost the war, at least partially, because they ran out of fuel. To remind us of this detail, Hutton Gibson, father of actor Mel Gibson, told WSNR radio, "Do you know what it takes to get rid of a body; to cremate it? It takes a liter of petrol and 20 minutes. Now, six million of them . . . the Germans didn't have the gas to do it. That's why they lost the

war."

Plus, there are no skeletal remains, no tons upon tons of ashes, no reconnaissance photos of enormous plumes of smoke clouding these camps, and no millions of bones or teeth (since the cremation process doesn't completely obliterate a corpse, but merely reduces it to bone fragments).

Finally, to cremate six million Jews would have taken multiple decades stretching into the 1970s at the very least.



CONCENTRATION CAMP MYTHOLOGY

When considering the supposed six million-person death count, an impression is given that Nazis were exterminating Jews in every single concentration camp that existed. After all, to attain six million requires a monstrous amount of killing.

As such, numerous “eyewitnesses” have gone on record saying that camps constructed on German soil—including Bergen-Belsen, Dachau and Buchenwald—possessed homicidal gas chambers. At the Nu-



remberg Trials, Sir Stanley Hartcross, an English prosecutor, characterized the alleged slaughter as a “mass production” with practically every facility in Germany,

Poland, Austria, Czechoslovakia and Alsace being the equivalent of a death camp.

But over the years, a transformation has taken place, with numerous German and Jewish figures of authority admitting that these postwar claims were false. For example:

- On Apr. 19, 1960 the director of Munich's Institute of Zeitgeschichte [i.e. Institute of Contemporary History], Dr. Martin Broszat, declared that no mass gassings ever occurred in the Old Reich (i.e. Germany). Only a few camps in Poland, according to him, could have been used for this function.

- In Apr. 1975, famed Nazi hunter Simon Weisenthal published a report entitled *Books and Bookmen* where he dropped a bombshell. "No gassing took place in any camp on German soil."

- On Jan. 24, 1993 in *Stars and Stripes*, Weisenthal repeated the claim that no gassings occurred anywhere in Germany. "It is true that there were no extermination camps on German soil." He also admitted that a supposed gas chamber at Dachau was never constructed.

- In a 1995 publication called *The Changing Shape of Holocaust Memory*, the American Jewish Committee revealed, "There were no killing centers per se in Germany, [and] as horrifying as the conditions were at Dachau, its gas chamber was never used." Of course, we know from Weisenthal's statement two years prior that Dachau never had a gas chamber.

So, at this point, the only camps that could have potentially been used as "death chambers" were solely

located in Poland, and their number has been reduced to and established at six—Auschwitz (Birkenau), Belzac, Treblinka, Sobibor, Majdanek and Chelmno. Of these, Jewish historians agree that potential exterminations could have only occurred at two locales: Majdanek and Auschwitz (the main camp and Birkenau).

As readers have already learned, the Auschwitz death count could be as low as 70,000—from old age, starvation and disease—while no mass graves were ever discovered at Treblinka.

How, then, could anyone *ever* attain the mythical figure of six million, especially when WW II ended and Russia's Jewish Bolsheviks seized these facilities and didn't permit anyone to inspect them for years until all the necessary "renovations" were completed to transform them from labor camps into death factories?

Holocaust historians have officially dropped from their lists hundreds of other facilities where executions supposedly took place. Why? Because absolutely no evidence has ever been unearthed to support the claims of their existence. There wasn't adequate manpower, money, resources, chain-of-command orders, autopsy substantiation, weaponry or raw materials to conduct the execution of six million Jews. Corroborating evidence does not exist.

Therefore, claims that Jews were snuffed at Dachau and Buchenwald have been dismissed out of hand because the fairytales are so untenable as to be laughable. Instead, what were originally called gas chambers at German labor camps have now been revised to reflect their actual intent—they were morgues to process the deceased, especially during the final months of WW II

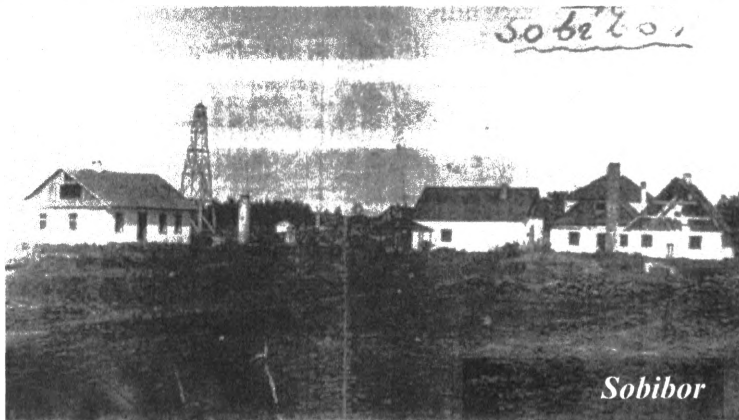

when Allied forces bombed supply lines and workers starved or died of typhus-related illnesses.

When we analyze Majdanek, two holocaust researchers—Wolfgang Benz and Gerald Reitlinger—deny that any killings took place at this installation, even though some claim over a million Jews perished there.

In this regard, the only camp that exterminations could have occurred at was Auschwitz. But these absurdities have already been debunked in an earlier chapter. With these facts in mind, consider a few of the other preposterous fabrications told about these facilities.

- Sobibor — Eyewitness Alexander Pechersky told this fantastical lie about supposed execution methods.



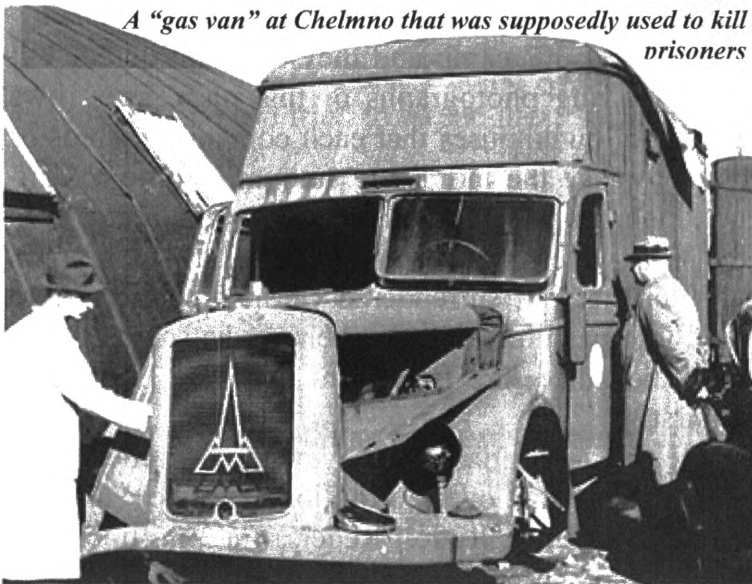
“As one entered it [looked] like a normal shower: hot and cold taps for running water, wash basins. As soon as everyone was inside, the doors slammed shut with a loud noise. Out of holes in the ceiling, a heavy blackish substance poured down in spiral shapes.”

Now, to compensate for all the people supposedly screaming inside these shower stalls, the Germans, we're told, kept caged geese at Sobibor and released them whenever the showers were turned on to cover up the garish sounds of death wails emitted by the prisoners.

- At Nuremberg, a Nazi guard named Anton Kaindl was coerced into testifying that he and several others built a gas chamber at a camp in Germany called Sachsenhausen. Yet, it's already been established that no death factories existed on German soil.

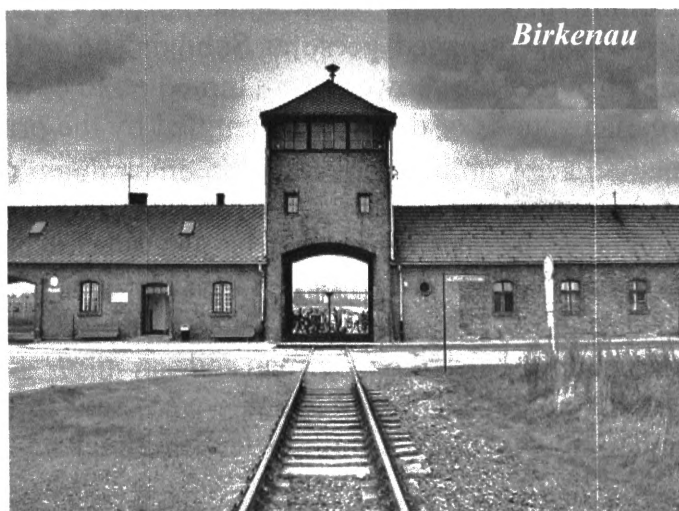
- Chelmno — SS commandants were said to have executed upwards of 1.3 million Jewish inmates inside



"gas vans." Imagine how much fuel and how many vehicles—not to mention personnel—would be needed to kill over a million people inside tiny little vans.

- Birkenau — As the story goes, no sooner would



Jews arrive at this camp and they'd be murdered. Yet anyone viewing photographs of this place sees rows and rows of bunkhouses that each contain hundreds of beds. Why take the inordinate amount of time to construct this many sleeping quarters with this many beds if the Jews were merely going to be killed upon arrival? (After the war, surrendered German soldiers were herded into pastures with no shelter whatsoever, whereupon they died like flies from exposure, starvation and thirst.)

- Belzec — Initially, an eyewitness named Kurt Gerstein swore that over 20 million Jews were slaughtered here. Another, Rudolf Reder, said 3 million were killed.

How did the Germans allegedly slay this many people? Some said via the use of diesel engines that asphyxiated the victims (an extremely inefficient mode of killing). Author Dr. Stefan Szende proposed that the soon-to-be deceased were lowered into containers filled with quicklime. Then

again, Abraham Silberstein was convinced that electrical ovens (not gas) constituted the preferred method.

Of course, no executions were performed at Belzec, and historians have tried to sweep these ludicrous tales under the carpet.

- Bergen-Belsen — Even the most hardcore holocaust faithful admit there were no gas chambers there.

- Birkenau — The only evidence that is offered for the gas chambers supposedly used at this locale is a plastic replica with a fake metal door that was crafted by an artist in Poland. Nothing else.

- Treblinka — Although already covered in a previous chapter, it should be noted that in Vasily Grossman's book on this subject, he claimed that Jews were killed here via suffocation (i.e. removing the oxygen from inside a room filled with victims).

At Nuremberg, others forwarded the notion that steam killed the Jews. Others claimed it was diesel exhaust, chlorine, or mass firing squad executions.

Then, as has been shown, the corpses were allegedly buried in mass graves, exhumed in 1943, and then cremated in mass pyres without anyone noticing millions of bodies being burnt.

Taken a step further, if hundreds of Jews at a time were killed inside gas chambers and then guards entered shortly thereafter to remove the corpses, they too would have instantly died because gasses trapped between these mounds of bodies would have been released when they were un-piled from one another.

As the Latin saying goes: *falsus in uno, falsus in omnibus* . . . false in part, false as a whole. When inspectors looked at the showers that were supposed to have rained Zyklon B onto prisoners, they all ruled it impossible.

As for the use of diesel exhaust, anyone with a basic understanding of science knows that the carbon monoxide ratio is extremely low. A gasoline engine produces at least seven times more carbon monoxide than does diesel, but still this inefficient mode of death is listed quite extensively in holocaust lore.

Again, after wading through these absurd stories, its necessary to remind readers as to why these various camps were erected—to harness forced labor as a means of keeping the German war machine rolling. If all of them were used to gas Jews, why isn't there even one single live-action photo of these people being executed? Of six million victims, no one—not even a sympathetic or merely curious German—snapped a picture? There is, however, film footage of Jews working at a camp in Czechoslovakia named Taurezstadt.

Guards could have made vast sums of money after the war with this crucial evidence. Yet not one—NOT

ONE—photo exists to chronicle even a single killing in German gas chambers. No victims in crematoria, no pictures of actual spewing smokestacks, no photos of vast ash piles. Nothing.

Then again, pictures that surfaced later—those of the chutes supposedly used to introduce Zyklon B—were proven false. Further, photographic negatives of the camps were altered, adding smoke to chimneys or large groups of people surrounding alleged crematoria.

In addition to a lack of physical evidence, records for the construction of hundreds of “death camps” are completely absent from German files despite virtually 100 percent detail for every other project.

Historians have also not been able to produce the smoking gun document where Adolf Hitler ordered a mass extermination of Jews. To sidestep this issue, holocaust fabricator Raul Hilberg floated an idea that the Nazis—hundreds and thousands of them—had a magical telepathic meeting of the minds—without any specific orders—that drew all of them to take it upon themselves to kill Jews by the millions. They simply all acted on an unspoken “understanding.”

Surely nobody could buy such an insane idea.

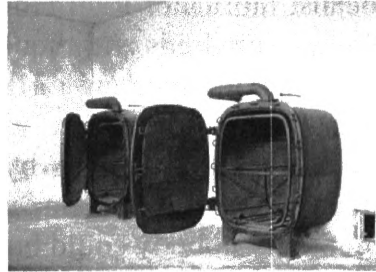
Premier holocaust historian Arno Mayer came clean in his book *Why Did the Heavens Not Darken* that proof of functioning gas chambers was “rare and unreliable.” Plus, if Hitler’s henchmen were so maniacally efficient to kill six million Jews, why are there *so many survivors . . .* supposedly millions and millions of them *that weren’t exterminated*? If this were such a crucial project, how could so many Jews have escaped—right between their fingers?



DEATH MODE FANTASIES

In addition to alleged poison gas chambers, Zyklon B, mass pyres and Elie Wiesel's claims that Jews were burned alive, firing squads, chlorine, vacuum chambers, high voltage electricity, steam, lime baths and diesel death factories on wheels were allegedly used to kill Jews. A man named Kurt Gerstein once proposed that, at minimum, 20 million Jews were killed via diesel exhaust alone. Other modes of murder supposedly also existed that haven't already been recounted in this book. A sampling of these absurd stories:

- During the Nuremberg Trials, purported evidence of "steam chambers" at Birkenau used to kill Jews was presented to onlookers. In actuality, these relatively small rooms were used to de-louse inmate clothing.

- The Soviet newspaper *Pravda* carried the following item on Feb. 2, 1945: "Germans wiped out [any] trace of the assembly line killing installation [at Auschwitz] where hundreds of people were killed simultaneously with electrical current" (i.e. death by electrocution). Other sources claimed that prisoners were electrocuted in huge vats of water or, to make matters simpler, they were immersed into boiling pools of water.

- A report issued by members of the Polish resistance movement recounted death via pneumatic hammers. “They bound the prisoners’ hands together behind their backs and brought them in, one after the other, naked, into the courtyard. They placed them in front of the barrel of an air gun that was discharged without a sound. The hammer crushed the skull, and the compressed air destroyed the entire brain.”

- A prosecutor for the United States, Robert Jackson, accused Nazis of killing Jews with atomic bombs. At Nuremberg he proclaimed, “By means of this newly invented weapon of destruction, 20,000 people were eradicated almost instantaneously in such a way that there was no trace left of them.”

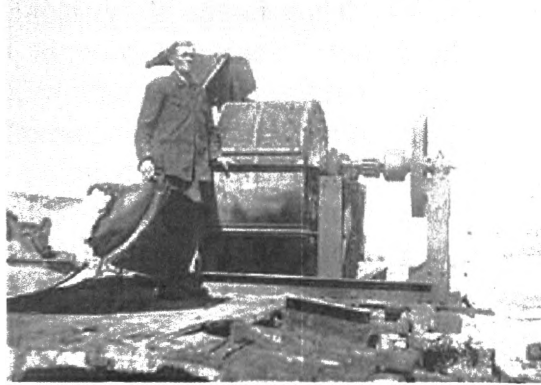
- At the Chelmno camp, an occupant named Adalbert Rueckerl claimed that three “gas vans” were used to exterminate, at a bare minimum, 150,000 Jews.

- Another fantastic tale involves the supposed execution of 33,711 Jews via gunfire on Sept. 29, 1941 on the outskirts of Kiev in a village named Babi Yar. After burying the corpses in a ravine, German forces supposedly learned that Soviet troops were approaching. To avoid detection of their firing squad executions, the Nazis allegedly dug up all 33,000+ corpses and then set them afire in a blazing crematory pyre.

Not to let facts get in the way of a good fairytale, reconnaissance planes at that time revealed no mass burnings of corpses. Later, investigators found absolutely no mass graves, no fiery pyres, nor any evidence that the ground had been dug up or overturned. No massacre in any way, shape or form occurred at Babi Yar.

- As the Nuremberg war crimes trials proceeded on Feb. 14, 1946 prosecutors presented into evidence a photo of what they called a “mobile bone-grinding machine” that the SS *Sonderkommandos* allegedly used at the Janowska concentration camp.

- In Dec. 1945 at the Nuremberg trials, those on the witness stand described the use of steam chambers to kill Jews. “The chambers were hermetically closed and steam was let in. In a few minutes all was over.”

- An interesting sidebar once appeared on *The Learning Channel* relating to a convicted American prisoner in North Carolina named David Lawson. On June 15, 1994 he was executed in the gas chamber. Oddly enough, it took wardens a total of 18 long, grueling, torturous minutes to kill the condemned man using this method. 18 minutes! They had filled the gas chamber with specially prepared poison made precisely to kill prisoners. But because Lawson didn’t take deep breaths, he endured for nearly 20 minutes. Now, imagine if a room were filled with hundreds of prisoners, and the gas in question—Zyklon B—had to affect all these individuals simultaneously. There is no way possible that the Nazis could have efficiently snuffed six million Jews using such an incompetent mode of execution.

- A self-described eyewitness at Belzec, Jan Karski, related how trains filled with quicklime were used to kill Jews. "The floors of the cars had been covered with a thick, white powder. It was quicklime, [which] is simply unslaked lime or calcium oxide . . . the occupants of the cars would be literally burned to death before long, the flesh eaten from their bones." (In reality, quicklime is only somewhat dangerous. It causes severe irritation when inhaled or placed in contact with moist skin or eyes. Inhalation may cause coughing, sneezing and labored breathing. It does not eat the flesh from your bones, and is unlikely to kill a human being.)

- In some of the most remote areas of Europe, the Nazis were accused of killing Jewish prisoners at "blood poisoning stations."

- At the Odessa camp, holocaust expert Yehuda Bauer claimed that 144,000 Jews were drowned. Another person alleged that drowning was used to eradicate an entire city. "Not a single Jew remains in Kiev since the Germans have thrown the entire Jewish population into the Dnieper [River]."

- Last but not least, Dr. Stefan Szende described death chambers where prisoners were electrocuted. "The naked Jews were brought into gigantic halls. Several thousand people at one time could fit into these halls. The halls had no floor [sic]. The floor was of metal and was submergible. The floors of these halls, with their thousands of Jews, sank into a basin of water which lay beneath, but only far enough so that people on the metal plate were not entirely under water. When all the Jews on the metal plate were in the water up to over their hips, electrical current was sent

through the water. After a few moments, all the Jews, thousands at once, were dead. Then they raised the metal plate out of the water. On it lay the corpses of the murder victims. Another shock of electrical current was sent through and the metal plate became a crematory oven, white hot, until all the bodies were burnt to ashes.”

Over the past six decades, holocaust experts have quietly tried to dismiss each and every one of these far-fetched fabrications so that they all fell by the wayside—ignored, forgotten and dismissed so as to no longer be such a grotesque embarrassment.



LIES & TRUTH-TELLERS

In 1945, as WW II came to an end, the man who directed the Soviet Union's secret police, or NKVD, proclaimed that the Nazis had exterminated six million Jews in a horrendous holocaust. His name was Lavrenty P. Beria, and he was Jewish.

May, 1945 also saw the arrest of an Austrian Nazi Party member and SS officer named Wilhelm Hoettl, who, by various accounts, had sold his services to as many as a dozen different intelligence agencies around the world. When Americans seized Hoettl, he soon became an employee of the CIA's forerunner, the OSS.

Afterward, Hoettl shifted his allegiance to the U.S. Army's counter-intelligence corps, whereupon he announced that Germans had killed six million Jews. Interestingly, only five years later, the CIA characterized Hoettl as "a notorious fabricator of intelligence." By 1952, they called his testimonials "worthless and possibly inflated or fabricated."

Conversely, world leaders who had directed war efforts for the U.S., Britain and France failed to once mention a holocaust of any sort in their memoirs. Consider:

When added together, the memoirs of these three extremely well informed, influential men, totaling 7,061 pages, never once mentions a holocaust, genocide of the Jews, gas chambers, or that Hitler's soldiers exterminated six million victims. Not once.

Furthermore, the International Red Cross, who visited each and every one of these labor camps on German soil and in foreign countries, doesn't mention even once the supposed systematic slaughter of six million Jews. Not once. Likewise, as previously noted, Nazi hunter Simon Wiesenthal admitted in 1975, "No gassing took place in any camp on German soil."

Moreover, a 1943 report entitled *Foreign Relations of the United States Diplomatic Papers* clearly stated that there was "insufficient evidence to justify the statement regarding execution in gas chambers."

Even when the historic Yalta Conference occurred in Feb. 1945—attended by Winston Churchill, FDR and Joseph Stalin—none of these three men uttered a

single word about what would have been, conceivably, an ongoing, massive holocaust that led to the deaths of six million Jews. But, not one mention from

these world leaders, the Pope, or the international press. Why didn't any of them find it necessary to broach the subject when these mass murders were supposedly at their height?

Despite no evidence, reports, or mention from these official sources, quite a number of Jews have made claims that were later proven to be lies. For example:

✕ • Moshe Peer stated in 1993 that she miraculously escaped six times from the gas chambers at Bergen-Belsen. Of course, no gassings ever occurred at this installation.

• Another woman claimed to have escaped three times from Nazi gas chambers, the last time by clawing her way through concrete walls using nothing more than her fingernails—a Sisyphean task.

• Incredibly, Nazi hunter Simon Wiesenthal has publicly stated that he was imprisoned in 13 different death camps, but amazingly, the Nazis didn't kill him in any of them. During one alleged escape, Wiesenthal claimed to walk 170 miles with an amputated toe and a foot infected with gangrene. Then, his gangrenous limb healed all by itself without assistance from any doctors or nurses. ✕

• In Apr. 1944 a Jewish inmate, Rudolf Vrba, fled from Auschwitz with another Jew, Alfred Wetzler. Vrba asserted that exterminations were being conducted at Auschwitz, and that SS commander Heinrich Himmler watched Jews being gassed at Birkenau through a

tiny glass peephole in the door.

When questioned about this information, however, Vrba's story fell apart. First, Himmler's last appearance at Auschwitz occurred in July 1942, and Birkenau's crematorium didn't even open until Mar. 1943.

Secondly, Vrba backtracked on his sighting of Himmler. "Perhaps it was him, perhaps it was only a representative. I don't think it makes a big difference." He also retracted another element of his account. "No, I didn't say I was present when he peeked through the door of the gas chamber, but I put together a story which I had heard several times from various people." To compensate for stretching the truth, Vrba concluded that he used "poetic license" when relating this tale in his book.

Fortunately, others have stepped forward to set the record straight:

- On Jan. 18, 1945 Jewish holocaust expert Raul Hilberg testified at a trial, "No scientific reports prove Jews were exterminated in Nazi gas chambers." He added, "German war documents contain no mention of killing Jews. There are no autopsy reports indicating a single person died from exposure to poisonous gas in chambers."

- In the German publication *Die Zeit*, historian Dr. Martin Broszat wrote on Aug. 19, 1960, "Neither in Dachau nor in Bergen-Belsen, nor in Buchenwald were Jews or other prisoners gassed. The gas chamber in Dachau was never entirely finished or put into operation."

- Jewish historian Samuel Gringauz told *Jewish Social Studies* in Jan. 1950, “Most of the memoirs and reports of holocaust survivors are full of preposterous verbosity, graphomaniac exaggeration, dramatic effects, overestimated self-inflation, dilettante philosophizing, would-be lyricism, unchecked rumors, bias, partisan attacks and apologies.”

- In regard to the so-called Wannsee Conference where a blueprint for the final solution was allegedly crafted, Jewish holocaust expert and faculty member of Jerusalem’s Hebrew University, Yehuda Bauer, stated, “It was hardly a conference, [and] little of what was said there was executed in detail.”

- Holocaust author David Irving succinctly put this matter into perspective.

“The gas chambers and

factories of death are legend . . . the Jews are very foolish not to abandon the gas chamber theory while they still have time.” Interestingly, some eyewitnesses retell how corpses allegedly pulled from carbon monoxide death chambers were wet and covered in sweat and urine, their skin a bluish color. Except,

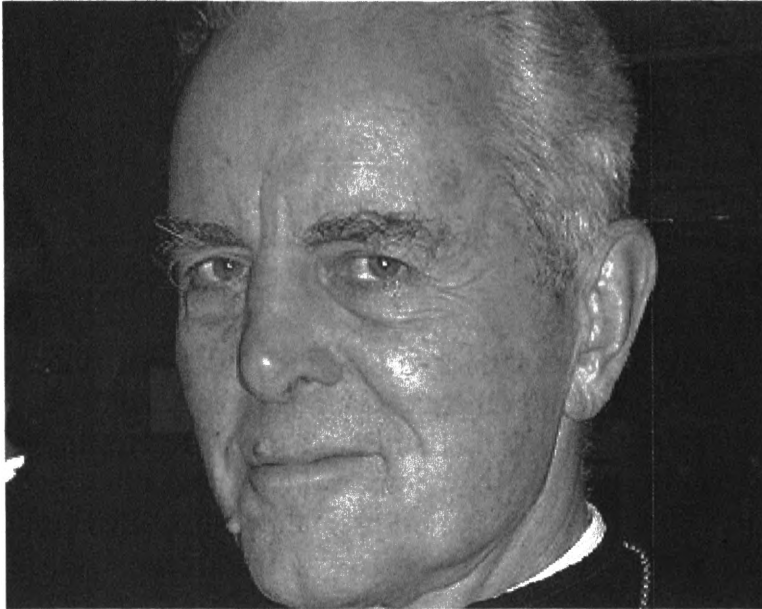

all medical literature has the flesh of those dying from carbon monoxide asphyxiation being bright pink or cherry red in color [not blue].

- Valery Lebedev, a woman who worked in the gas industry, said after reading a book on the holocaust, "There was no killing of Jews in gas chambers of the Nazi camps since there were no chambers there. The bombing of Germany and the evacuation of the camps blocked German supplies; the people there were starving, but the main thing is that there were outbursts of typhus epidemics in the camps. Lice spread this illness, and the Germans were disinfesting their clothes with Zyklon B insecticide."

- Bishop Richard Williamson told a camera crew



for Swedish television in Nov. 2008, "I believe that the historical evidence is strongly against six million Jews having been deliberately gassed in gas chambers as a

deliberate policy of Adolf Hitler.” He added, “I think 200,000 to 300,000 Jews perished in Nazi concentration camps, but none of them in gas chambers.”

- Dr. Aryeh Leon Kubovy, while belonging to Tel Aviv’s Israel Center for Jewish Documentation, proclaimed in 1960, “There exists no document signed by Hitler, Himmler or Heydrich speaking of exterminating the Jews, and the word ‘extermination’ does not appear in the letter from Goering to Heydrich concerning the Final Solution to the Jewish question.”



EXPOSED: FAKE MEMOIRS

A common response to holocaust revisionism is: “Well, what about all the eyewitness testimony and personal accounts from survivors?”

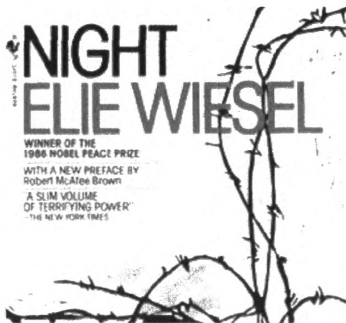
If the following individuals are any indicator, deceit seems to be the predominant theme among these people.

• Jerzy Kosinsky — This Polish Jew penned an autobiography that became a virtual pornographic onslaught of “anti-Semitism,” violence, obsessive sadomasochism, sexual torture and gore. Kosinsky paints his fellow countrymen as Jew-haters that abuse their inmates at concentration camps with a relish that is beyond description. Praised by Elie Wiesel and other major historians, his book *The Painted Bird* ultimately was exposed as a literary hoax.

• Elie Wiesel — Speaking of which, Wiesel’s book, *Night*, claims that at Buchenwald, at least 10,000 Jews a day were thrust, still alive, into ditches filled with flames until they were burned to death. Anyone familiar with ancient Old Testament

lore realizes that such an act is reminiscent of Jewish parents throwing their children into burning pits of fire as a sacrifice to the god Moloch.

Strangely, Wiesel, who was supposedly held at Auschwitz, never made one mention of any gas chambers at this facility.

As for the infernal ditches of fire, Wiesel wrote, "Not far from us blazed flames from a pit, gigantic flames. They were burning something. A lorry drove up to the pit and dumped something into it. They were small children. Babies! Yes, I had seen it with my own eyes! Children in the flames."

If such preposterous hyperbolic rhetoric wasn't enough, Wiesel also claimed that Nazi executions at Ukraine's Babi Yar resulted in the following phenomenon. "For month after month, the ground never stopped trembling, and from time to time, geysers of blood spurted from it."

Like Yellowstone's Old Faithful, Wiesel wants us to believe that geysers of blood shot upward into the air from the ground. To magnify his propensity to lie, Wiesel actually claimed to have been liberated from two different concentration camps.

On Jan. 4, 1987 *The New York Times* carried an account of how Wiesel recalled being at Auschwitz when the Soviets arrived to rescue everyone.

On Apr. 11, 1983 Wiesel told Washington, D.C.'s National Press Club that on Apr. 15, 1945 he had been a prisoner at Dachau when the U.S. Army liberated it.

So, according to Wiesel, he was rescued from one camp by either the Soviets or Allies, then somehow fell back into the Nazis' clutches again, whereupon he

became a prisoner in another death camp, only to be lifted yet again from death's clutches.

- Benjamin Wilkomirski —

In his book *Fragments*—based on “recovered memories”—this writer too depicted Nazis as crazed, psychopathic monsters that were so inhumane they actually smashed the craniums of Jewish babies born inside concentration camps. Yet, Wilkomirski isn't Jewish, he was never inside a concentration camp, and instead spent the duration of WW II in Switzerland. Experts concluded that his work was nothing more than a convoluted fantasy.



- Martin Gray — Characterizing himself as a survivor of the holocaust, this author provided a bone-chilling account of his escape from Treblinka to remain alive. Years later, however, the ghostwriter of these memoirs admitted that Gray had never been an inmate at Treblinka, and therefore never escaped from it.

• Edith “Edie” Eger — As a celebrity on the top-dollar holocaust circuit, Ms. Eger tells an improbable story that defies belief. “As Edie was onstage dancing for Dr. Mengele, she saw black smoke from a gas chamber, which likely contained the ashes of her mother, drift upward toward heaven. Edie

and her sister Magda were close to death many times. Whenever they showered, they never knew if they would receive water or gas. They were becoming exhausted and emaciated with hunger. Edie became so weak that she went in and out of consciousness. Even her sister's vigilance as a caretaker couldn't revive Edie. She was unconscious when guards thought she was dead and they tossed her in a mass grave in the woods behind the camp. Then in May 1945 Edie's miracle came. Almost a year to the day from when she arrived in Auschwitz, an American GI who was there with the 71st Infantry to liberate the Guns kirchen Lager camp pulled her from a pile of corpses in the woods. He saw her hand move. She weighed 40 pounds and had a broken back, but she was alive!"

• Herman Rosenblat — Oprah Winfrey called the



romance between this gentleman and his wife Roma the "greatest love story ever told." According to Rosenblat, as a boy he was incarcerated at a Nazi death camp when Roma, from

outside the walls, somehow managed to throw apples over the fence so that he didn't starve to death. After the war, this couple reunited and married. But, once critics began investigating his story in depth, Rosenblat admitted that he had faked the entire story. Pro-holocaust apologist Deborah Lipstadt referred to Rosenblat's tall-tale as bogus before he even confessed to fabricating it.

- Irene Kirkland — On Nov. 18, 1979 this woman told the *Washington Post* that as a young girl, Nazis held her at Buchenwald where, in her own words, “They were doing the exterminating.” But, her words fell apart when Simon Wiesenthal admitted that no extermination camps existed on German soil, where Buchenwald was located.

- Misha Defonseca — Claiming to be another survivor of Hitler’s atrocities, Defonseca penned a book entitled *Misha: A Memoir of the Holocaust Years* in which, as a six-year-old girl, she fled from Nazi murderers in the Warsaw ghettos, only to embark on a 1900-mile quest that took her through Poland, Belgium and Germany in search of her parents.

During her trek that spanned four years, this young girl claimed to have killed an SS officer by the time she reached the age of ten while also living with and being raised by a pack of wolves. Defonseca added that these very same wolves fed her and provided shelter to keep her alive. In return, Misha tended to the wolf cubs while their wolf parents searched for food. When successful in their hunt, the wolves came back with raw meat and bugs that she gleefully ate. If there was no raw meat, Misha said she ate mud and grass.

Also, by the time she turned nine, Ms. Defonseca claimed to have engaged in some type of tryst or love affair with an adult man.

After receiving acclaim from the holocaust community and even film offers, it turned out that Misha's autobiography was nothing more than a delusional folly. She never roamed among wolves, she didn't murder a would-be Nazi captor, and she never rambled across Europe in search of her missing parents. It was all a pathetic fantasy and she subsequently became a laughingstock. Meanwhile, Defonseca pocketed millions in royalties—far more than honest revisionists ever receive in compensation.

- Irene Zisblatt — In 2008, this woman who stressed that she'd endured 50 years of silence, recounted her supposed travails as a holocaust survivor in a book entitled *The Fifth Diamond*.



During the course of chronicling her years during the 1940s, Zisblatt claimed to have been a patient—or guinea pig—of the infamous Dr. Josef Mengele, who, for some reason, removed the tattoo that had been imprinted on her skin by other Nazis.

She also purports to have barely escaped her skin being turned into a lampshade, and said that Nazis were drawing the blood out of other women's daughters. Mengele, at least according to Zisblatt, somehow altered her own eye color from brown to blue. If that's not bad enough, a demented Nazi nurse supposedly tried to kill her via a fatal injection, except that it ended up simply being an attempt to scare her.

In addition to all these morbid episodes, Zisblatt introduced another element to her story. Namely, before

her mother and father were allegedly executed and the young girl was removed to Auschwitz, her mother sewed four diamonds into Irene's dress for safekeeping. That way, if she were to ever achieve freedom, Zisblatt could buy bread with the diamonds.

So, while at Auschwitz, to preserve these diamonds, the child swallowed all of them at sometime during the day, only to defecate them out again later. After performing this act, Zisblatt relates how she scraped through the fecal-encrusted matter and re-ate the diamonds . . . every single day for her entire 15-month stay at this encampment.

How the diamonds didn't slice Irene's tongue, throat, esophagus, intestines or stomach lining isn't explained. Nor does the author fully elaborate on how she didn't get sick from eating diamonds covered with feces. If other Auschwitz survivors are to be believed, none of them had enough water to drink, and therefore suffered from dehydration. However, the young child seemed capable of sanitizing the diamonds so as to not fall ill.

To reach a fevered pitch, Zisblatt proceeded to relate how she escaped from the *inside* of a gas chamber that teemed with numerous other Jewish women. After fleeing from this room of death, Zisblatt then sought assistance from someone at Auschwitz who thrust her over a barbed-wire fence that had an electric current running through it. From there—stark naked—the girl fled to a train and wound up in a hospital where Gen. George S. Patton personally visited her and offered gifts.

Needless to say, her story was proven to be a lie.

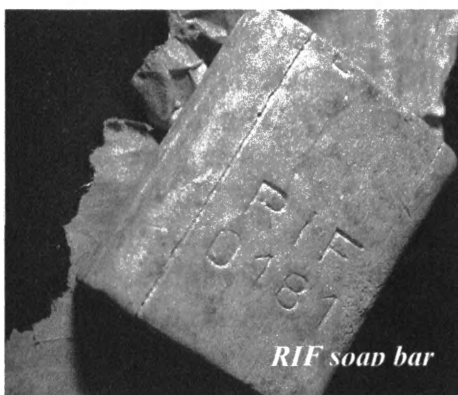


HUMAN SOAP, LAMPSHADES, SHRUNKEN HEADS & TATTOOS

At the Nuremberg Trials, 1945-1946, eyewitnesses took the stand to say that Nazi guards manufactured soap from the corpses of Jews that they'd slain in concentration camps. Further, the Soviets also presented what they called "evidence" of human soap and human skin at these Tribunals (exhibit USSR-393).

In actuality, claims first arose during WW I that Germans were making soap from Jewish bodies, but this fabrication was quickly squelched due to a lack of evidence. Later, as early as 1941, sources in Turek, Poland—basing their information on a U.S. military intelligence report—revealed, "The Germans had brought thousands of Polish teachers, priests and Jews there [a human soap factory] and after extracting the blood serum from their bodies, had thrown them in large pots and melted off grease to make soap."

Other sources contributed to this tale, including famed movie director Billy Wilder, whose film crews supposedly caught the Nazis making soap from Jewish fat and lampshades from their skin.

As alleged proof of these atrocities, Jews presented boxes with the initials "RIF" stamped on them, claiming these letters stood for *Rein Juedisches Fett* or "Pure Jewish Fat."

Why the letter "J" was transmogrified into the letter "I" is something of a mystery. It might have been *Reine juedischen fat*, or *Reine Juedischen fat*. Others say it was *Reichs Juedisches Fett* or other variants.

Nazi hunter Simon Wiesenthal weighed in on this matter in 1946 by writing for a Jewish paper called *Der Neuweg*. "On the boxes were the initials RIF, 'Pure Jewish Fat.' These boxes were destined for the Waffen-SS. The wrapping paper revealed with completely cynical objectivity that this soap was manufactured from Jewish bodies."

Wiesenthal continued, "The civilized world may not believe the joy with which the Nazis and their women thought of this soap. In each piece of soap they saw a Jew who had been magically put there."

Rabbi Stephen Wise of the American Jewish Congress and World Jewish Congress stated in Nov. 1942 that soap and fertilizer were processed from Jewish corpses.

As a detainee at the Stutthof concentration camp in 1944, Nesse Godin later recalled in 1983, "They gave us a shower and a piece of soap. After the war we found out the soap was made out of pure Jew fat, *Rein Juden Fett*, marked in the initials on the soap that I washed with. For all I know, maybe there was a little bit of my father's fat in that soap."

The Anti-Defamation League (ADL) added in a chapbook entitled *The Anatomy of Nazism*, "The process of brutalization did not end with the mass

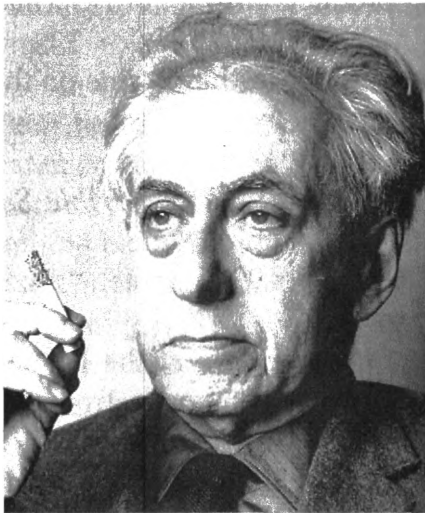

murders themselves. Large quantities of soap were manufactured from the corpses of those murdered.”

In 1942, the American Jewish Congress published a report stating that the Germans also used scientific methods to transform the remains of Jews into glue. The hysteria reached such fevered proportions that at funerals, bars of soap were actually buried in a plot at Jewish cemeteries in honor of the “dead” contained inside them. These same bars of soap were also displayed at holocaust museums worldwide.

Other individuals such as Mel Mermelstein, in his movie *Never Forget*, took it upon himself to perpetuate the soap story, as did Ben Edelbaum in his memoir *Growing Up in the Holocaust*, Konnilyn Feig in *Hitler's Death Camps*, and noted historian William Shirer in *The Rise and Fall of the Third Reich*.

Lastly, one of the primary sources responsible for

proposing the six million death count, a Russian propagandist named Ilya Ehrenburg, detailed in his autobiography, “I have held in my hand a cake of soap stamped with the legend ‘Pure Jewish Soap,’ prepared from the corpses of people who had been destroyed.”

The gaping, tremendous problem with all their versions of history is

that every credible Jewish holocaust expert now admits that the soap story was nothing more than lies and propaganda.

Rabbi Arthur Schneier, at the Holocaust Museum in Washington, D.C., circa 1983, reiterated that RIF represented

Rein Judisches Fett, or “Pure Jewish Fat.”

But in actuality, “RIF” (it was never RJF) stamped on each cake of soap was in ref-

erence to the Reich Center for Industrial Fat Provisioning (i.e. Reichsstelle fuer Industrielle Fettuersorgung) that made cheap cleaning products in war-torn Germany.

A number of respected authorities have gone on the record refuting the human soap hoax.

- Author Walter Laqueur stated in *The Terrible Secret* that there are no facts to back up this tale.

- *Chicago Tribune*, Apr. 25, 1991, wrote, “Nazis didn’t make soap from Jews’ fat.”

- In a Jan. 1986 letter, investigators at the Danzig Institute admitted that soap was never made from human corpses during the war.

- Cited numerous times before in this book, Yehuda Bauer, a historian specializing in the holocaust at Hebrew University in Israel, disclosed in Apr. 1990 that the soap tall-tales weren’t true. Detainees, she said,

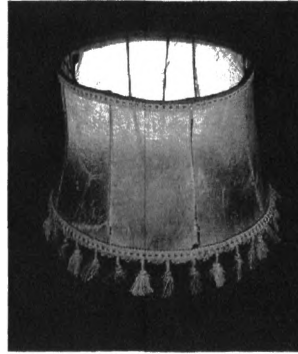

Human soap wasn’t the only grotesque deception perpetrated on the global community by holocaust liars. Another bit of propaganda involved Nazis suppo-

sedly removing the skin of Jewish prisoners and fashioning it into decorative lampshades. Alleged evidence of these crimes was displayed outside the Buchenwald labor camp where tables were lined with “human skin lampshades” and Jewish “shrunk heads.”

Yanina Cywinska, a self-described eyewitness, told of Nazis “parading around [with] briefcases and lamps made of human skin while washing their bodies with soap composed of Jewish bone [sic].”

This lark of shrunk Jewish heads originated with Albert G. Rosenberg of the Allies Psychological Warfare Division. At the Nuremberg Trials on Dec. 13, 1945, exhibit USA-254 was a Jewish skull that had been stuffed and preserved. An adjoining Army report quotes a supposed eyewitness, “I also saw the shrunk heads of two young Poles who had been hanged for having relations with German girls. The heads were the size of a fist.”

Not surprisingly, in their book *The Incomparable Crime*, authors Roger Manvell and Heinrich Fraenkl admitted in no uncertain terms that tales of lampshades made from human skin “appeared to be dubious.”

~~A~~ Two final notes: first, when aged Jews refer to piles of hair as evidence that the Nazis sheared their heads prior to gassing them, the truth is that, indeed, everyone at these installations received haircuts to get rid of lice that carried the typhus disease. A dated Alfred Hitchcock documentary actually depicts the entire process of detainees being laundered and their heads shaved to remove lice.

Huge piles of clothes and shoes were also present because

every incoming laborer was forced to wear new uniforms and shoes due to their previous attire being contaminated with lice. These acts consisted of nothing more than basic human cleanliness to prevent the further spread

So, when holocaust museums show huge piles of shoes to allegedly reinforce the notion that thousands of Jews had been massacred; it's really nothing more than a childish ploy to play on the gullibility of those viewing the exhibits. But nothing more sinister than shoes being removed to prevent the

spread of typhus can be derived from these crass displays of propaganda.

As for the legendary tattoos that so many survivors flash as proof that they were in a concentration camp, it's true that they did receive these markings. But first of all, the simple fact that they're still alive and able to *show* these tattoos means they weren't executed. The sheer number of these individuals who go around rolling up their sleeves to show a tattoo directly implies that hundreds of thousands of Jews *weren't* killed at these work facilities.

The answer is quite elementary. Since the Jews and other workers didn't possess fancy laminated ID cards like we carry today, the Germans tattooed them so they could keep track of their laborers. If someone was to be killed instantly, there's no necessity for a tattoo. But if they intended to use their services in a factory setting for years into the future, the tattoo served as a way

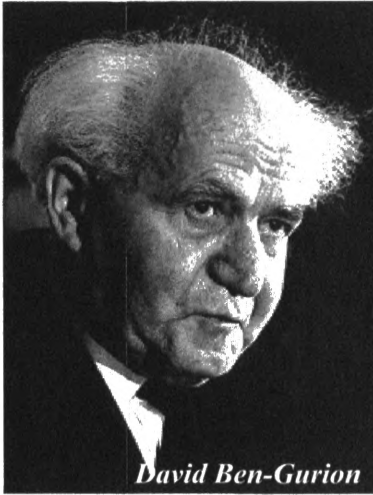

Secondly, less than three months after Hitler rose to power, a Mar. 24, 1933 headline declared, "Judea Declares War on Germany." This war wasn't of a military variety, but rather in the form of boycotts. With Germany's economy already in shambles, Hitler and his colleagues sought nothing less than to see the Jews leave their country. Zionist organizations, on the other hand, were already envisioning a new Promised Land in the Middle East where they could establish a new state.

So, by 1933—years before the first shots of WW II rang out—Hitler's cabinet, in accord with Zionists, encouraged Jews to begin an emigration process toward Palestine. To make this transition easier, Nazis permitted Jews to withdraw their money from banks and take it with them.

Soon, tens of thousands of Jews led a wave of relocation toward the Middle East and other parts of the

world. Once Hitler rose to and secured power, his party felt a direct kinship with the Zionists. Their bond grew so strong that Zionism was the only other official, legalized party sanctioned by the Nazis in Germany. The Zionists even had their own distinct flag that they were permitted to display.

Two Zionist leaders—Kurt Blumenfeld and Robert Weltsch—specifically engaged in deals with the Nazis. Moreover, the Zionist military arm, Haganah, negotiated directly with the SS. This relationship became so involved that Feivel Polkes, a Haganah agent, met with Adolf Eichmann in Berlin on Feb. 26, 1937. Later that year, on Oct. 2, Eichmann and his superior, Herbert Hagen, stepped from an ocean liner named *The Romania* in Haifa, Palestine. The man they met with, again, was Feivel Polkes.

The Zionist agenda had as its foremost priority the creation of an Israeli state in Palestine filled with diasporic Jews who left Germany and Europe. To accomplish this feat, they needed to create a fake “holocaust” upon which to generate immediate sympathy they could exploit in a Machiavellian way to meet their goals.

The Zionists couldn't accomplish this Sisyphean task alone, so not only did they blackmail and bribe U.S. leaders to establish a new "United Nations" organization, they also collaborated with the Nazis. The Zionist betrayal of their own people became so vast that a Jewish scholar named Hannah Arendt wrote in a book about Adolf Eichmann that Jews in Europe willingly worked alongside Nazis in arresting fellow Jews who would eventually be put into labor camps. At least 150,000 Jews or persons of mixed Jewish heritage also served in the German military. Other Jews also sought employment as work camp administrators.

Zionists negotiated what came to be known as the Transfer Agreement, or *Haavara*. Naturally, establishment historians refuse to acknowledge that the Third Reich allowed Zionists to establish special areas in Germany where Jews could be trained to learn

trades or professions that they'd later use in Palestine.

At these locales, Zionists flew their own flag, published a newspaper, and continued facilitating emigration to the Middle East. By 1939, the German government assisted Zionists in securing the departure of approximately 400,000 Jews—roughly two-thirds of the entire German Jewish population.

Dr. Austin App, a professor at the University of Scranton and LaSalle College, explained this situation in simple terms:

Hitler's so-called "Final Solution" to the Jewish problem was not annihilation, but rather deportation or expulsion from Germany, which was approved with the open cooperation and encouragement of the Zionists themselves who wanted German Jews to join other Jews from around the world to leave their own native countries in order to colonize Palestine.


Absolutely no live person (Jew or non-Jew) was ever gassed or burned in any German concentration camp, including Auschwitz.

It goes without saying that Germans maintained meticulous records during WW II, but no one has ever uncovered a single document or plan that detailed genocidal murders inside gas chambers or ovens. There aren't any documents that even refer to extermination policies.

Rather, every official report clearly indicates how Jews would be deported out of Germany—not exterminated. Only *after* WW II concluded were fraudulent documents created in order to deceive the public. No orders were delineated from Hitler or anyone else to deliberately engage in mass murder against Jews or any other prisoner.

However, after America entered the war and Germany's prospects for victory became increasingly dire, the Palestine deportation program ended and captured Jews were shipped off instead to labor camps—many in Poland—to help sustain their war machine.

 Reinhard Heydrich, a noted SS general and head of security for the Reich, wrote on Jan. 20, 1942 at the infamous Wannsee Conference, "The emigration program has been replaced now by the evacuation of Jews to the east as a further possible solution, in accordance with the previous authorization of the Fuhrer."

Hysterically paranoid (and overtly deceptive) holocaust historians cite this reference as the "final solution" crafted by Hitler to murder Jews on a mass scale. But, quite clearly, since the Germans desperately needed workers in their factories, they could no longer deport Jews to Palestine. They now required, by sheer necessity, their efforts as laborers in various industrial centers.

Even at the notorious Wannsee Conference, never once did Reinhard Heydrich use the term "extermination." Instead, he specifically stated that Jews would have *Arbeitseinsatz im Osten* ... i.e. labor assignments in the east, meaning Poland.

There was no genocide . . . only work reassignments.

To revisit an earlier, crucial point, on Jan. 25, 1939 the German Foreign Ministry released a statement on how to deal with the *Jewish problem*. “The end policy in regard to the Jews is the emigration of all Jews living in the territory of the old Reich.”

On Jan. 27, 1942 Adolf Hitler himself proclaimed, “The Jews must leave Europe. The best thing is that they go to Russia.”

At the Nuremberg War Crimes Trial, Hans Lammers, chief of the Reich chancellery, testified that when he asked Heinrich Himmler about Germany’s “final solution” for the Jews, he was told, “The Jews must be evacuated from Germany.”

Almost whimsically, when asked how he first discovered that Jews had supposedly been eliminated via mass murder policies, Lammers told those present, “Right here, at the Nuremberg trials.” Hermann Goering offered the same sentiment.

To be perfectly clear, the Nazis and Adolf Hitler never planned, intended, plotted or actually carried out the deliberate extermination of Jews. Their solution involved emigration, pure and simple.

There exists no master list of names documenting six million dead Jews killed in camps, despite numerous people over

✱ the years trying to compile one. None. There is no list. Further, in a biography of Hitler, British historian Colin Cross notes, "There does not exist anything like a written order signed by Hitler for the extermination of Jews in Europe." Plus, over 60 million documents obtained by U.S. armed forces and the Brits after WW II have never been released to the public. Rather, they're still secreted away at Bad Arolsen, never to see the light of day. Lastly, protocol orders, or signed statements declaring a "Final Solution" to murder Jews, has never been revealed from the notorious Wannsee Conference. There is no smoking gun, nor a single scrap of evidence ever produced to prove that a holocaust was ordered or occurred.

To arrive at the truth, however, documents and historical objectives produced by Zionist leaders must be examined. To begin, in 1897 the World Zionist Organization was formed. Financed by Europe's most influential, wealthy family, the Rothschilds, their ultimate goal revolved around the creation of an exclusive Israeli state in the Middle East where diasporic Jews could return and settle after having been forced to flee Jerusalem in A.D. 135 by the Romans.

In order to be successful—therefore stealing land that had been settled by Palestinians for thousands of years—the Zionist political movement had to create a victimization tale of such extraordinary lengths that eternal sympathy for the Jews would result.

But how could they go about inventing such a heart-rending story, especially when the Zionists weren't an especially religious outfit? This simple quandary didn't seem to halt their efforts, for a holocaust, or "burnt offering," had to be rooted in Judaic lore.

In particular, Jewish prophets of yore foretold of a time when, after six million Jews were slaughtered, only then could their people return to what they considered their promised land. Even 2,000 years ago, the number six million played an essential role in justifying the *legitimacy* of a Jewish state, even if it meant telling egregious lies and stealing land that belonged to other people. A casualty count of six million became the political tool leading to a much sought after “reward” of a homeland. Clearly, their end goals were justified by any means.

The six million “figure” hardly originated with a body count following WW II. Instead, it’s a superstitious, occult number derived from Kabalistic gematria deep in the texts of ancient Judaism.

This total, seen as supernatural and used in occult rites by the Jewish religious hierarchy two millennia ago, can never be altered in any way. It’s a dark, diabolical number that needs to be repeated over and over again like a Talmudic, magical incantation.

overwhelming evidence, modern-day Pharisees of the holocaust religion can never allow that mystically fa-

bricated total to be lowered. It's Jewish doctrine, dogma, and unholy scripture all rolled into one.

Derived from the Greek word *holos* ("whole") and *caustus* ("burnt sacrifice"), the word refers back to an ancient Jewish ritual wherein parents sacrificed their innocent children in a fire to the evil god Moloch. In this sense, the original perpetrators of a holocaust were the Jews themselves.

Later, this predetermined six million number assumed a supernatural status as if it were released during some type of dark occult ceremony. As a result, the rites of six million promised to empower the Jews if they could adequately convince the uninitiated that this many of their people had been killed. Thus, six million became a literal altar where Jews worshipped and ritualistically repeated the number again and again. In 1944, a Polish Jew named Raphael Lemkin invented the term "genocide," whereupon the Jews now had a satanic spell to spread across the world that they could publicly worship.

But let's not get ahead of ourselves. The plot to create an Israeli state (ultimately formed by a UN edict in 1948) stretches back to a vital event that occurred in 1917. As WW I raged across Europe, the Germans had all but achieved victory and the impending surrender of England. To prevent this embarrassing defeat, Zionists approached England's leader and made a pact with the devil. In return for the eventual creation of an Israeli state, they'd lure America into the war and help the English defeat Germany.

The Brits agreed, and thus U.S. President Woodrow Wilson was blackmailed over certain sexual indiscretions that he had committed (peccadilloes with a certain Mrs. Peck). As a result, Wilson pushed America into the war even though he vociferously campaigned against such a move.

In *Zionism: The Hidden History*, esteemed Jewish author Benjamin Freedman exposed the reality behind WW I. "Samuel Untermyer blackmailed Wilson with Mary Peck's love letters in order to get Louis Dembitz Brandeis, the most politically influential of all Zionists in the United

States, appointed to the Supreme Court."

Freedman continued, "Untermyer informed President Wilson that his client was willing to accept \$40,000 in lieu of commencing the breach of

promise action.” Wilson did not have the money, so Untermyer volunteered to pay the sum on one condition: that Wilson would appoint to the first vacancy on the United States Supreme Court a nominee to be recommended by Untermyer.

At this stage, Freedman revealed the conspirator’s true intent. “On June 14, 1916 Louis Dembitz Brandeis, the most politically influential of all Zionists in the United States, on the recommendation of Untermyer, was appointed to the Supreme Court. Brandeis volunteered his opinion to President Wilson that the [alleged] sinking of the *SS Sussex* by a German submarine in the English Channel justified the declaration of war against Germany.”

Finally, the World Zionist Organization’s secretary, Samuel Landman, stated, “The only way to induce the American president to come into the war [was] to secure the cooperation of Zionist Jews by promising them Palestine, and thus enlist and mobilize the hitherto unsuspectedly powerful forces of Zionist Jews in America and elsewhere in favor of the Allies on a *quid pro quo* contract basis, the Balfour Declaration.”

Now, quite amazingly, widespread claims were made following WW I that six million Jews had been slaughtered by the Germans.

- To stampede the American public into entering WW I—by subjecting them to horrendous propaganda

campaigns crafted by Jewish P.R. men—Germans were blamed for “eating Belgian babies and delighting to throw them in the air and transfix them on bayonets.”

- Sept. 29, 1919, *New York Times*, page 7 headline: *Felix Warburg Tells Sad Plight of Jews*—“The successive blows of contending armies have all but broken the back of European Jewry and have reduced to tragically unbelievable poverty, starvation and disease about 6,000,000 souls, or half the Jewish population on earth.”

- 1910 *Encyclopedia Britannica*—“There remain in Russia and Rumania over six million Jews who are being systematically degraded.”

- A July 19, 1921 *New York Times* headline declared: “BEGS AMERICA SAVE 6,000,000 IN RUSSIA: Massacre threatens all Jews as Soviet power wanes, declares Kremlin—Russia’s 6,000,000 Jews are facing extermination by massacre.” This plea originated from Dr. Joseph Kreinin, a Zionist activist and president of the Russian Joint Board of Jewish Societies.

- From the Oct. 31, 1919 edition of *The American Hebrew*, former New York Governor Martin H. Glynn penned an article entitled *The Crucifixion of Jews Must Stop* that began, “From across the sea, 6,000,000 men and women call to us for

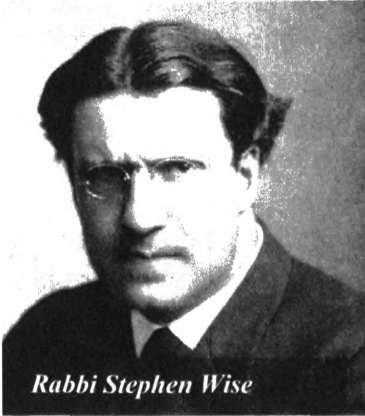

BERLIN, July 19.—Russia’s 6,000,000 Jews are facing extermination by massacre. As the famine is spreading, the counter-revolutionary movement is gaining and the Soviet’s control is waning. This statement is borne out by official documents presented to the Berlin Government, which show that numerous pogroms are raging in all parts of Russia and the Ukraine.

The information was gathered by Dr. Joseph Kreinin, a noted Jewish social worker and President of the Russian Joint Board of Jewish Societies. He says that several villages have been burned already and scores killed, sev-

help . . . 6,000,000 men and women are dying in the threatened holocaust of human life.” Glynn also gave a speech on this very same subject [the holocaust of six million men and women] in Albany, New York.

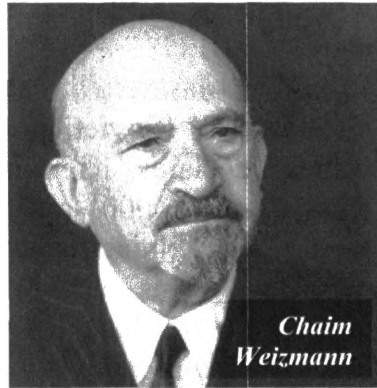

tified before the Peel Commission in 1936, “It is no exaggeration to say that six million Jews are sentenced to be imprisoned in this part of the world [Europe].”

✱• Edward J. Rozek noted in *Allied Wartime Diplomacy* that English clergymen hounded the British Ministry of Information to create tales of “gas chambers” used by Germans against Jews during WW I. However, the story was so outlandish that the ministry felt it would be too absurd to risk such a foolish endeavor.

• 1912, *American Jewish Yearbook*, # 5672, the American Jewish Committee reported, “Russia has since 1890 adopted a deliberate plan to expel or exter-

minate six million of its people for no other reason than that they refuse to become members of the Greek [sic] Church, but prefer to remain Jews.”

If we move forward to WW II, the man primarily responsible for inventing the myth of six million slaughtered Jews was a Jew himself, Ilya Ehrenberg. As a fiction novelist, Soviet propagandist and leader of the Jewish anti-fascist committee during WW II, he appeared in the U.S. and began disseminating fabricated stories of Germans using Jewish corpses to manufacture soap bars as early as 1942.

On Dec. 22, 1944 Ehrenberg was already spewing the figure of six million in a publication called *Soviet War News*. “Ask any German prisoner of war why his compatriots annihilated six million innocent people, and he will simply answer: well, they were Jews.”

Also, in Mar. 1945—before the war even ended—Ehrenberg wrote in *Soviet War News*, “The world now knows that Germany has killed six million Jews.”

Thus, Zionists such as Ehrenberg, in collusion with an organization named the World Jewish Congress, began peddling their holocaust agenda to Allied forces during the war. The entire myth originated from these Jewish individuals, not from any government, independent doctors, or trained researchers. Six million dead Jews in a fiery holocaust is solely a Zionist creation.

We know this fact to be true because, as already noted, the Allies utilized extensive intelligence operations during WW II and they under no circumstances uncovered a massive German operation where six million Jews were systematically eliminated. Once these

deceptive reports began filtering out, all the wartime commanders knew it to be nothing more than outlandish propaganda.

For instance, in May 1942 Nahum Goldman, eventual president of the Jewish World Congress, prophesied that millions of Jews would be slaughtered in Germany. On Dec. 13, 1942 Rabbi Israel Goldstein referred to a holocaust where six million Jews were being exterminated—two and a half years before the war ended. In Feb. 1943 *Readers Digest* ran a story claiming that half of the eventual six million Jews targeted by Hitler had already perished. Such a notion is pure fantasy.

By May 31, 1945 another propagandist, Rabbi Dov Weissmandel, wrote, “Up to this day, six times a million Jews of Europe and Russia have been exterminated.”

All these liars got the ball rolling with sordid tales of churning Jews into fertilizer, making lampshades and purses from their skin, or turning their flesh and fat into bars of soap or glue. They also, by the end of 1942, told over-the-top stories of ovens, crematoria and gas chambers in German concentration camps. But as this book has shown, it's now an agreed-upon fact—even by holocaust historians—that not a single homicidal gas chamber or death camp ever existed on German soil in any of its 20,000 facilities.

Still, these very same Zionist propagandists coerced Allied forces into dropping leaflets on the Auschwitz camp (and others) with allegations of mass gassings. Allied radio stations in Europe also began reporting claims of a “Final Solution” extermination policy being waged by the Nazis.

Of course, the dead in these installations largely perished from starvation and disease after supply lines had been obliterated by Allied carpet-bombings. The leaflets dropped by planes in Poland and other parts of German-controlled territory served as another genesis of the holocaust myth.

Also, how could anyone dismiss the efforts of Supreme Allied Commander Dwight D. Eisenhower, who disseminated alleged photos of gas chambers and other alleged mass extermination facilities to the U.S. media, specifically of Buchenwald and Dachau? Later, proof arose that neither of these camps had been used as genocidal extermination centers.

Most interesting of all, by June 1945—less than two months after the end of WW II—the number six million had already been firmly established and entrenched as the definitive total of Jews killed in Germany's "holocaust." No one had investigated all the thousands of work camps maintained by the Germans, precisely identified each and every corpse, conducted intensive demographic surveys or population counts, or rifled through the rampant chaos of Germany and the satellite countries around it. Yet a precise, final count had been erected forevermore to stand for history—six million.

To ensure that their elaborate ruse was cast in concrete, a kangaroo court known as the Nuremberg Trials began on Nov. 20, 1945. Overseeing these show hearings was America's predecessor to the CIA, the OSS (Office of Strategic Services). The OSS worked hand-in-hand with members of the Zionist International and Soviet Union's Communist Party. These three primary

entities acted as gatekeepers of all the so-called evidence to be presented.

Behind the scenes, other groups lurked in a realm of shadows. In a 1978 book, *The Jewish Paradox*, Nahum Goldman wrote, "During the war, the World Jewish Congress created an Institute of Jewish Affairs in New York. The directors were two great Lithuanian Jewish jurists, Jacob and Nehemiah Robinson. Thanks to them, the institute worked out two completely revolutionary ideas: the Nuremburg tribunal and German reparations."

Another element that participated in this miscarriage of justice was Britain's Political Warfare Executive (PWE). During WW II this bureau was responsible for disseminating propaganda across Europe. The PWE helped launch the false notion that Majdanek and Auschwitz were equipped with gas chambers that served to exterminate Jews.

A 1945 *New York Times* article by C.L. Sulzberger—a member of the Jewish family that still owns this newspaper today—provides a good understanding of where the concentration camp numbers originated. Sulzberger stated that Soviet Russia supplied the figure of four million Jews who were allegedly gassed at Auschwitz.

Once these "totals" were brought to the infamous trials, a different set of rules was applied to the proceedings. Article 19 of the Statutes of the International Military Tribunal declares, "The Tribunal shall not be bound by technical rules of evidence." Article 21 further states, "The Tribunal shall not require proof of facts of common knowledge, but shall take judicial notice thereof."

Thus, not being guided by either evidence or proof, those at Nuremberg didn't seem concerned that the overall number of prisoners held at all German controlled camps in 1943 was 224,000. Then, again using this same criteria, in 1944 the total amount of prisoners—Jews and non-Jews combined—held at all of Germany's work camps was 524,000.

Since these two years were when most Jews were supposedly murdered, how do we go from 524,000 prisoners of Jewish and non-Jewish descent to the astounding total of perhaps 11 million deaths—six million of them Jewish? In addition, Time-Life Books clearly noted that the U.S. held six times as many Japanese, Germans, Italians and other POWs as the Nazis did. Plus, neither came close to equaling Stalin's slaughterhouse gulags.

While on the subject of books, doesn't anyone find it curious that British icon Winston Churchill's sprawling six-volume account of WW II, which he found himself directly involved in, doesn't once refer to the genocide of Jews or concentration camp gas chambers? Similarly, Eisenhower omits any and all allusions to these subjects in his memoirs, too.

With the mention of Joseph Stalin a paragraph ago, how did Communist involvement in the Nuremberg Trials benefit that mass-murderer's country? Quite simply, since the Soviet Union was viewed as an ally of the U.S. and Britain during WW II, it became an uncomfortable situation to expose the millions of Russian citizens that had been annihilated at Stalin's hands under his wave of Communist terror.

Hitler didn't have millions of Jews exterminated, but the man who sat with FDR and Churchill at Yal-

ta—Joseph Stalin—most certainly did, and both U.S. and UK leaders knew it. In this light, Communist claims that millions of Jews had been extinguished under Hitler's command diverted attention away from their own inhuman atrocities and mounds of corpses.

Ultimately, once the ridiculous Nuremberg War Crime Trials had ended with an established verdict that Nazis had mass murdered six million Jews in concentration camps, this fabricated "holocaust" served to justify the formation of a new Israeli state in Palestine under the preposterously false mantra, "Never again."

As fervent propagandists hammered this idea (i.e. psychic driving) and made it an integral, inarguable part of history books and conventional wisdom, the natural result was an outpouring of sympathy for the Jewish people. As compensation, then, leaders at the recently formed U.N. decided that—as protection—the Jews deserved their own nation so that another "holocaust" would never again occur.

On Dec. 29, 1979 Nathan Goldman told the *Paris Match* how Jews have played the sympathy card. "Since the Second World War, Jews have been treated with silk gloves. Without Auschwitz, there would be no Israel."

Jews decried the alleged genocide committed against them by Hitler's supposed henchmen, yet that didn't stop them from engaging in an actual brutal genocide against the Palestinian people after the creation of Israel in 1948.

Ironically, from the inception of Zionism in the late 1800s, its plotters would stop at nothing in their aim to create their own chosen land in Palestinian-settled territory. It took the onset of two horrendous world wars,

100-116 million casualties, the decimation of Europe, and even the dropping of two atomic bombs.

But in the end, the Zionists accepted a plan that predated the Nazi rise to power where European Jews would be resettled in Palestine to establish their own racist colony. As Jews immigrated into Palestine, they proceeded to wage a decades-long genocide against the Palestinian people, slaughtering men, women and children by the hundreds of thousands.



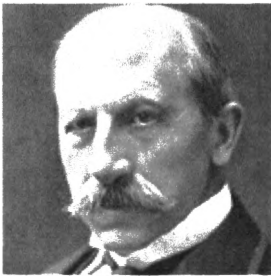
THE MASTER PLAN

Both world wars, at their crux, developed as a way to reorder Europe and to establish a Jewish homeland in Palestine. The initial setting to put this plan in motion can be traced back to Cecil Rhodes' Round Table and their meetings at the Astor family's Cliveden estate.

To initiate a European New World Order, it was imperative that Germany once again became a driving force that

pushed other nations toward war. The ultimate creation of Adolf Hitler's Nazism has among its masterminds Lord Alfred Milner, James, Edmond, Lionel and Nathaniel Rothschild, the Warburg brothers, Cecil Rhodes, Arthur James Balfour, and Lord Robert Cecil (among others). This elite circle envisioned the promotion of a Teutonic master race that eventually congregated under the Nazi swastika. The Germans would

see themselves as Nordic rulers establishing a conquering Third Reich.

To ensure Germany's defeat in World War I, the Balfour Declaration manipulated President Woodrow Wilson—via Judge Louis Brandeis and foreign policy advisor Colonel House—into saving England from



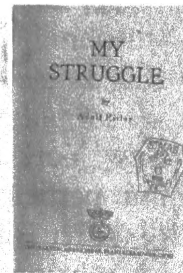

certain defeat by guaranteeing a homeland for Jews in Palestine. If America hadn't entered the war, the UK would have undoubtedly surrendered to Germany. Lord Robert Cecil, an architect of the League of Nations, sought the erection of this new nation with such fervor that his motto became, "Judea for the Jews."

Since Edmond Roth-

schild already oversaw much all they needed was a new war following the Treaty of Versailles.

But Germany—dispirited, stunned and angered—had to usher in a vigorous nationalist leader to lead their resurgence. It is rumored (although certainly not proven) that a London Round Table agent named Professor Karl Haushofer propelled the



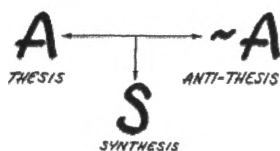
*A rare copy of Adolf Hitler's

destiny of a young Adolf Hitler by ghostwriting *Mein Kampf*.

Then, through the 1920s and 1930s, the Rothschilds, Warburgs and Hjalmar Schacht conspired with financiers at the Bank of England and associated New York-based tycoons to begin bankrolling such industrialists as I.G. Farben and the Krupp dynasty.

Within a decade, the German war machine had reestablished its prowess, while manufacturing achieved a *Drang nach Osten* (i.e. German expansionism) effect. In due course, these Zionists in the shadows established Hitler as a force to be reckoned with. This diabolical collaboration between Jewish money-men and the Nazi juggernaut continued until 1939, when they then decided to change course and pull the rug out from beneath Hitler's feet. Der Fuhrer, it seemed, didn't plan on sticking with their orchestrated script, thus once again endangering the British Empire.

But the plan was never quite so cut-and-dried. A Hegelian dialectic was needed to set *thesis* against *an-*



tithesis in order to achieve a final *synthesis*. Therefore, despite clear Zionist financial backing of Adolf Hitler, a counterforce entered the picture under the auspices of

New York attorney Samuel Untermyer (another Bal-four participant and Woodrow Wilson puppet-master).

After Hitler and the German people learned of Jewish sabotage against them during WW I (i.e. bringing America into the war to save Britain), an undeniable amount of anti-Semitism arose in Germany. Yet rather than abating this hatred toward the Jews, Zionist lead-

ers actually sought to increase it so that they could eventually blame their false holocaust on a rabid hatred of the victimized Jewish population.

On Mar. 12, 1933 Rabbi Stephen Wise's American Jewish Congress planned a rally at Madison Square Garden for Mar. 27. However, three days prior to this protest, on Mar. 24, London's *Daily Express* ran a bold headline declaring, *Judea Declares War on Germany*. The international Jewish leaders involved, including Untermyer, launched a blistering economic boycott against Germany that they hoped would bring Hitler and his country to their knees.

By uniting all Jews into a holy war through a boycott of German goods, these madmen intended to cripple their mighty European foe once and for all. They declared Germany an enemy of the Jewish people and wanted to level a final stranglehold from which they'd never recover.

In response to this call for Germany's destruction, on Mar. 28, 1933 Hitler took the defensive measure of telling his people to refrain from doing commerce with Jewish shop owners. Establishment historians conveniently gloss over the fact that Jews declared an offensive, international war on German finance and industry prior to Hitler's retaliation. The Jews behind this scheme wanted Germany to remain vulnerable, bankrupted and without military strength.

The assault against Germany continued for months, as can be seen from Samuel Untermyer's Aug. 7, 1933 speech on WABC radio. "Germany has been converted from a nation of culture into a veritable hell of cruel and savage beasts," Untermyer roared during his plea for a sacred war against Hitler. Untermyer, president

of the World Jewish Economic Federation, also conveniently mentioned, or planted a seed—12 years before the end of WW II—how the Germans would “exterminate the Jews.”

Around this same time, a Jewish newspaper called *Natscha Retsch* demanded, “The war against Germany will be waged by all Jewish communities, conferences and congresses . . . by every individual Jew.”

At this moment in 1933, with the Committee of Jewish Delegations, Rabbi Wise’s American Jewish Congress, and Untermeyer’s fanatical legions, the Jews—via their economic boycott—could have crushed Hitler’s financial status and caused him to fail. The Germans, already facing stagflation, would have surely turned on their new leader, causing Nazism to die a quick death.

But such unity and organization—leading to Hitler’s downfall—wouldn’t have contributed to the creation of an Israeli state. So, a toppling of Hitler was anathema, at least in 1933.

Here is where the situation gets extremely interesting. While Wise and Untermeyer insisted on a German boycott, other Jews in Germany, New York and London worked diligently to sabotage their efforts by *promoting* the export of German goods. One of the primary agents in this camp was Chaim Weizmann, president of the World Zionist Organization.

Interestingly, Weizmann’s World Zionist Organization had already started moving European Jews into Palestine by as early as 1904. Weizmann realized that a German

boycott would never allow Nazism to flourish. If the Nazis fell, there would be no one to blame for anti-Semitism that compelled mass Jewish emigration from Europe to Palestine.

Thus, a clearly defined, ingenious Hegelian Dialectic had been established. The Wise-Untermeyer faction would decry Nazi anti-Semitism and scare the Jews into fleeing to Palestine (i.e. a Diaspora based on German hostilities).

On the other hand, National Socialism had to prosper and not be ruined under a boycott. So, although a certain amount of boycott fear mongering was allowed to persist, ultimately Rabbi Wise crumbled under pressure and failed to vehemently enforce his boycott. Of course, these individuals repeated their mantra of SS anti-Semitism and denunciations, but more important was the financial stability of Hitler's economy that would lead them into WW II.

A key point is now apparent. Zionists needed to enter into what became known as the Transfer Agreement, even acting as the largest distributor of Nazi goods in the Middle East and other parts of Europe. These Zionists countered the aforementioned boycott by pimping Germany's products for them.

Nazi survival depended on the Transfer Agreement and an investment of money that propped up Germany's war machine. This reasoning provided an excuse to the Jews for entering into the Transfer Agreement. So, a trade alliance between Nazis and Zionists would ultimately facilitate Jewish resettlement in Palestine. Further, to establish this new homeland, Zionists had to lie down in bed with the Nazis so that the movement of capital out of Germany wouldn't be thwarted.

Whereas one Zionists element kept drumming up their scare tactics against Adolf Hitler, the other side fully cooperated with National Socialism in order to augment their cherished Diaspora. A thriving German economy was abundantly necessary for their plot to succeed.

The apparent fissure among Zionists was, in actuality, an illusion—two prongs of the same crown that worked in unison with one another . . . a combination of sensationalized fear mongering propaganda in concert with the vested interests of financial prosperity for National Socialism . . . all to force European Jewish immigration into Palestine. The mutual end-goals of these two factions weren't in conflict at all. That's why one denounced Hitler while the other developed a close relationship with him.

Jewish scholar Edwin Black later wrote in 1984's *The Transfer Agreement: The Untold Story of the Secret Pact Between the Third Reich and Jewish Palestine*, "Zionist leaders understood that the success of the future Jewish Palestinian economy would be inextricably bound up with the survival of the Nazi economy. So, the Zionist leadership was compelled to go further. The German economy would have to be safeguarded, stabilized, and if necessary reinforced. Hence, the Nazi Party and the Zionist organizers shared a common stake in the recovery of Germany."

At any rate, we return once more to the Transfer Agreement whereby billions of dollars were ushered to Zionists in Palestine in order to begin the mass movement of Jews toward their new homeland. To guarantee that Diaspora travelers were destined toward the

Middle East, the U.S. limited the number of Jews that were permitted to cross their borders during WW II.

There is, naturally, a debate as to whether Adolf Hitler directly and deliberately entered into a contractual arrangement with the Rothschilds and Warburgs. Although both sides in this argument make their case, one aspect is certain: not once did Hitler, Goebbels, Goering or any other Nazi leader publicly criticize the Transfer Agreement.

Another crucial piece of evidence cannot be denied. After Samuel Cohen—a close friend of Chaim Weizmann—began his negotiations with Hitler's representatives in Mar. 1933, the Nazi government signed onto the Haavara Transfer Agreement in the summer of 1933. A June 22, 1937 document from the German foreign office (*Wilhelmstrasse*) states, "This German position is entirely dictated by domestic considerations. In practice, it promotes the consolidation of Jewry in Palestine and thus facilitates the building of a Jewish state, and could lead one to conclude that Germany favors the establishment of a Jewish state in Palestine."

Coincidentally, in 1933 Max and M.M. Warburg—via their Anglo-Palestine Bank—created the Trust and Transfer Office Haavara Ltd. in Tel Aviv. This quasi-financial center acted as a conduit that served both Nazis and Zionists. Via the Transfer Agreement, the shipment of German goods grew so quickly that they became the number one exporter to

Palestine by 1937. Needless to say, Hitler's industrialists derived much needed capital, while simultaneously opening doors to other Middle East markets. Not only did this arrangement undermine the Zionist economic boycott, it also allowed Jewish emigration out of Europe to Palestine.

In fact, this motive served such a strong role for the Nazis that they green-lighted the transfer of 60,000 Jews to Palestine between 1933-1939. This collaboration proved mutually beneficial to the Zionist cause, also, as outward bound Jews were permitted to retain a percentage of their financial assets after relocating.

Before 1940, Jewish settlers in Palestine tripled, while both German and Zionist business interests profited from this newly created market. Their entrepreneurial spirit met the goals of both sides involved. Ironically, Adolf Hitler's government lent itself more than any other legislative body to enhancing Jewish development of a new state in Palestine. Likewise, German Jews read the tea leaves by realizing—with prompting from propaganda-inspired fear mongers—that they were doomed if remaining in Europe. Thus, much to their dismay, immigration into the desert became a not-so-desired last option.

The particulars of this arrangement were ingenious. To prevent being stripped of their wealth, Jews deposited their money in aforementioned Haavara Company accounts established by the Warburg brothers. These funds were then used to purchase German-manufactured goods needed for construction materials, tools, and other supplies for development in Palestine. Once these products were sold, Jewish immigrants received their money after relocating. German industrial-

ists thrived, as did Jewish moneychangers. Plus, the Zionists were pleased that their Diaspora dreams were coming true, while the Nazis got rid of their despised enemies: the Jews.

All the while, Arabs in the Middle East were witnessing a tremendous influx of their exact same enemies: the Jews. But since Hitler's Aryan circle equally saw Muslims as racially inferior as Jews, they never batted an eye in regard to a major conflict arising in that region once a new Israeli state was created.

In an oddity among oddities, in winter 1934 two of the most unlikely shipmates sailed from Germany to the Palestinian port of Haifa. These men were Kurt Tuschler of the Zionist Federation and Leopold von Mildenstein, an SS officer. Once reaching Palestine, they toiled for six months investigating the possibilities of Zionist development.

Another similar incident occurred in the opening months of 1935 when a Jewish owned ship called the *Tel Aviv* left Bremerhaven flying a swastika banner. To commemorate these voyages, a German newspaper, *Der Angriff*, applauded the collaborative efforts of the

Zionists and SS by releasing a medal that bore a swastika on one side and a Star of David on the other.

Even more telling, both the Zionists and Nazis harbored a distinct sense of racial superiority over other peoples. The philosophy of Nazi supremacy is only surpassed by doctrines of Jewish purity. Whereas the SS looked to Odin and the Thule Society to purify their race, elite Zionists turned to the Talmud as their inspiration.



In this sense, neither the Nazis nor Zionists had any desire to let others assimilate into their ranks, whereas an urgent sense of identity caused both to seek separate and distinct existences apart from those they saw as inferior to them.

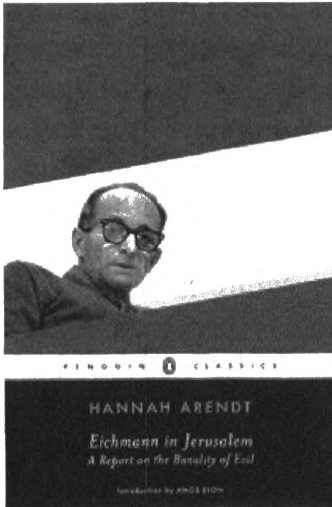
Theodor Herzl, the founder of modern political Zionism, vowed that Jews could not be accommodated among other people or nations. They required a homeland of their own, a goal the Nazis were more than willing to help accommodate, if for no other reason than to free themselves of what they saw as a Jewish toxin that had poisoned their ideal state.

Despite their overt antagonism toward each other, collaboration between these disparaging forces continued during the 1930s. Both agreed that, in light of their distinct feelings of racial superiority, Jews couldn't reside in harmony on German soil or among Aryans.

As a result, it appealed to each of their national interests that emigration into Palestine best suited all of the parties involved. Although devotees from both sides feel pained to admit it, a tremendous amount of cooperation existed between Nazis and Zionists. Indeed, the Zionist movement enjoyed a great deal of support from the German government and SS until, at least, 1938.

As has already been established, a small yet elite cabal of Zionists—via the Transfer Agreement—prevented a systematic dismantling of the fledgling Hitler regime. International Jewry, at least on one level, sought to undermine the German economy. But a tactical allegiance between European Zionists and Nazi Party members was forged on a common goal: shipping Jews *en masse* to Palestine.



Numerous books chronicle these collaborations, including Ben Hecht's overview of Jewish attorney Rudolf Kastner's interactions with Adolf Eichmann and Heinrich Himmler. Similarly, Hannah Arendt's contribution, *Eichmann in Jerusalem*, portrays the hidden Zionist-Nazi pacts. [Kastner was put to death by the Israel

government in 1957 after a court found him guilty of collaborating with the Nazis.]

Once WW II concluded, Dr. Hans Friedenthal, leader of Germany's Zionist Federation, confessed,

“The Gestapo did everything in those days to promote emigration, particularly to Palestine.”

This relationship extended to German SS members assisting in the establishment of 40 Zionist training camps throughout Germany. At these installations, Jews actually flew blue-and-white flags that later became their national symbol.

Up to as late as 1938, Adolf Hitler personally acknowledged that the deportation (i.e. cleansing) of Jews from Germany to Palestine required his government's assistance. Regardless of the costs and dangers, Germany was better without the presence of Jews among their ranks.

As a sign of what extents they went to, Hitler's forces—along with those of Italy's Benito Mussolini—

helped train what came to be known as the Irgun Strike Force. These killers, led by Menachim Begin (the father of modern-day terrorism and a future Israeli prime minister) prepared for a time when—following

the creation of Israel in 1948—they'd unmercifully slaughter Palestinians whose land they had just stolen.

Still, this joint emigration program faced opposition, primarily from the Brits, who placed severe travel restrictions on German Jews fleeing to Palestine. From 1937 to 1939, to combat these impositions, SS security forces and a preliminary version of the Mossad became even more secretive in their illegal smuggling operations. Clandestine fleets of ships reached their

height during the years 1938-1939 as a sense of desperation began to settle in over Europe.

At the same time, beginning in 1937, the Germans began to reevaluate the creation of an Israeli state in Palestine. Since this new nation could never attract or support every Jew, the Germans realized that a Frankenstein's monster had been surreptitiously created.

On Jan. 27, 1939 Joachim von Ribbentrop—Adolf Hitler's foreign minister—issued a memo warning, "Germany must regard the formation of a Jewish state as dangerous because it would bring an international increase in power to World Jewry."

Yet, up until 1941, at least to a small degree, the SS lent their services to dispatching German Jews to Palestine. Additionally, the last kibbutz training facility on German soil wasn't disbanded until 1942. At this juncture, with America entering the war and the requirement of even more German males to fight on multiple fronts, the Germans decided that instead of deporting Jews to Palestine, they'd instead place them in work camps to be used as labor in their war machine factories.

In the end, to achieve their ultimate goal of a new state and homeland in Palestine, elite Zionist Jews—not Nazis or Adolf Hitler—choreographed the deaths of their own Jewish people during WW II. These Jews didn't die in gas chambers or ovens, but were abandoned by Jewish leaders that sought revenge against them for failing to heed their emigration demands (i.e. out of Germany to the Middle East).

Jews killed the Jews, not Germans.

To reiterate the mechanics of their grand scheme, a sordid Hegelian dialectic came into play. First, filling the role of *thesis*, World Jewry announced an economic boycott against Germany. As an *antithesis*, this move pushed Hitler and the German people closer to peril and inflamed their feelings of anti-Semitism. The resulting *synthesis*, then, arose via collaboration (i.e. the Transfer Agreement) between Zionists and Nazis to initiate a Diaspora to Palestine.

This “final solution” absolutely did not involve mass executions of Jews, but instead a mass exodus of Jews to this new homeland.

The final solution equaled exodus, not execution.

Now, to lay out another Hegelian dialectic, even though Samuel Untermyer and Chaim Weizmann—at least on the surface—took opposing stances against Hitler's rise to power, they still worked in unison.

Untermyer—boycott, crush Germany economically

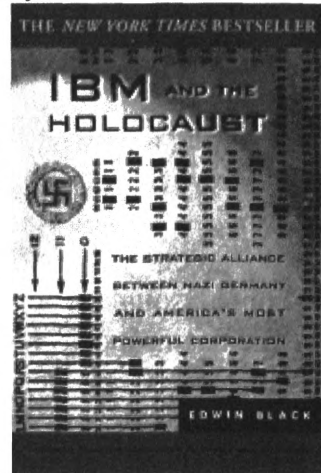
Weizmann—Transfer Agreement, bolster Germany's economy

Along with their Round Table co-conspirators in England, all three factions had an overriding fear and loathing of a powerful Germany, thus forming a new *thesis* element to our equation.

As an *antithesis*, Hitler and the Nazis concluded that they had to defend themselves against these enemies. The Germans never wanted war, but the eventual *synthesis* could only be WW II and a fake holocaust that would then be used as an excuse, or justification, for a newly created Israeli state.

In theory, their grand Zionist design seemed possible. Except, much to the elite Jews' dismay, it wasn't Hitler that proved a stumbling block to their plan, but other Jews themselves. Following WW I—and Hitler's early rise to power in the late 1920s into the 1930s—most everyday Jews in Germany identified as Germans, not misallocated Judeans.

The powerful Rothschild family became disturbed by the fact that they'd lost control of their Jewish underlings—not only physically, but also on a mental level. German Zionists seeking a mass *aliyah* (migration to Palestine) only constituted a small percentage of the overall population. So, to get a precise count, or number, of German Jews, the Rothschilds contracted with IBM to make punch cards that would identify

every Jew in Germany. That way, the Rothschilds had a much better idea of what they were dealing with as a prelude to Jews being rounded up and shipped to Palestine.

The Rothschilds and their other Zionist allies were also frustrated with the English because they had never turned over Palestine to the Jews following WW I (in accordance with the Balfour Declaration that stated Jews would save England from the Germans by dragging America into the war). In return, Brits were supposed to begin the process of creating a new Israeli homeland.

But by failing to do so, Zionists needed to initiate a second Great War that would crystallize their plans. To accomplish such a feat, the Zionists fomented an economic boycott against Germany, deliberately fueled the fires of anti-Semitism against their own people (via Hitler's Nazi Party), and then financially joined forces with National Socialism under the Transfer Agreement so that Germany would meteorically rise to become another military superpower.

The Jews started WW I, and by destabilizing Europe and placing the English Empire at risk yet again in the late 1930s, they also paved the way for WW II, all so that a new nation could be created for them.

However, yet again, regardless of these Zionist efforts, Jews—not Nazis or communists or Mussolini—were their major obstructions. Why? Even though Zionists sought a Jewish state by any means necessary, typical European Jews didn't cherish the thought of relocating from their homes to a god-forsaken Middle East desert where the native Arabs despised and resented them. In fact, it was the last thing on their

minds. The vast majority of Jews were mortified by the prospect of living in a barren, excruciatingly hot, undeveloped desert where they were unwanted intruders.

The Rothschilds, in contrast, had other ideas. Originally, they intended to round up the Jews—identified

with IBM punch cards—export them to the Middle East, and then have these uprooted transients fight the Arabs for their property. Obviously, the Jews wanted no part of such an outlandish ordeal.

Nearly two decades earlier, in 1921, a rabid Zionist leader named

Vladimir Jabotinsky proclaimed to the twelfth annual Zionist Congress, “In working for Palestine, I would even ally myself with the devil.”

But German Jews couldn’t reconcile themselves to the fanciful aspirations of their elite Zionist counterparts. To European Jews, Palestine was by no means a “promised land.” Rather, it represented everything hostile, distant, unwelcoming and strenuous they could imagine. None were eager to abandon the relative security of their current residences for such an unknown undertaking.

Needless to say, a chasm developed among the Jews with political Zionists on one hand aligned against the hesitant masses that didn't share their supposedly utopian visions of Palestine. The latter group actually took pride in being Germans and/or Europeans. They thought: to hell with some long-ago biblical territory that their supposed ancestors had allegedly been forcibly evicted from 2,000 years earlier.

The Rothschilds and their elite allies became increasingly enraged by such reluctant attitudes. While most of the "ignorant Jews" (at least in their eyes) were more than willing to at least try assimilating into—albeit apart from—European society, to the Zionists, assimilation served as anathema . . . the enemy.

The only method to accomplish the creation of an Israeli state . . . the Jews' "Final Solution" . . . was another war. To prime the pumps for WW II and a mass exodus of Jews, this monstrous cabal had to create such an atmosphere of anti-Semitism that other "lowly, unenlightened" Jews would have no alternative than to relocate. After the Transfer Agreement was enacted (allowing Jews to forward their financial resources to Palestine), Zionists hidden in the shadows engineered a full frontal campaign of virulent anti-Semitism.

But this anti-Semitism was, to a large extent, self-created, arising from the Zionists themselves that viewed their "cause" as inordinately more important than the lives of Jewish people. According to a Zionist named Jacob Klatzkin, if European Jews were reticent to establish a purified promised land in Palestine, then they were "living a false and perverted existence."

Such self-loathing propaganda also emanated from the likes of modern-day Zionist founder Theodor Herzl, who characterized Jews opposed to their case as

“disgusting, dirty, anti-Zionist kikes.” To Herzl, any Jew not in line with their Zionist aims of a purified, separatist homeland was defined as a kike.

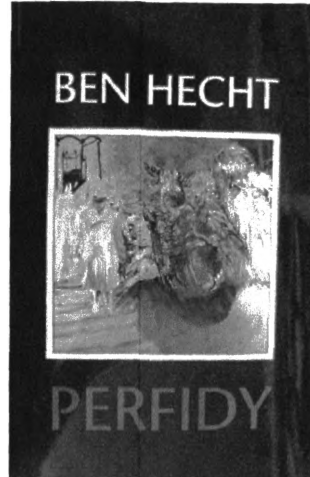
Herzl’s vile nature assumed such a pronounced level of hatred against his own people that he actually conspired with known anti-Semitic leaders and governments—not to lessen attacks on Jews, but to increase them. In his diary, Herzl wrote, “The anti-Semites will be our most dependable friends.” Far from opposing anti-Semitism, Herzl and his kind promoted it in order to make Germany so unbearable that Jews would have no option but a mass exodus to Palestine. Self-created anti-Semitism became an integral component in their Hegelian Dialectic. Adolf Hitler—rather than being their enemy—instead filled an unwitting role as a force directed against German Jews that harbored little sympathy for the Zionist prize in Palestine.

To keep the pressure on from all sides, some Jewish factions demanded an economic boycott against Germany while others conversely collaborated with the Nazis to bolster their manufacturing base (i.e. the Transfer Agreement). Then, to complete this scenario,

author Ben Hecht wrote in *Perfidy*, “The Zionist movement led a broad campaign of incitement against the Jews living under Nazi rule to arouse the government’s hatred of them, to fuel vengeance against them, and to expand the mass extermination.”

Again, the only aspect of this analysis that Hecht got incorrect was his use of the word “extermination.” Actually, the Zionists longed for an increase in Jewish resettlement to Palestine to formalize their political and nationalist dreams. But to take advantage of their once-in-a-lifetime opportunity, they needed a festering cauldron of self-created anti-Semitism that would lead to—at least on the surface—a (fake) holocaust. Only under such a twisted Machiavellian banner could they visibly seize land in Palestine as their new state.

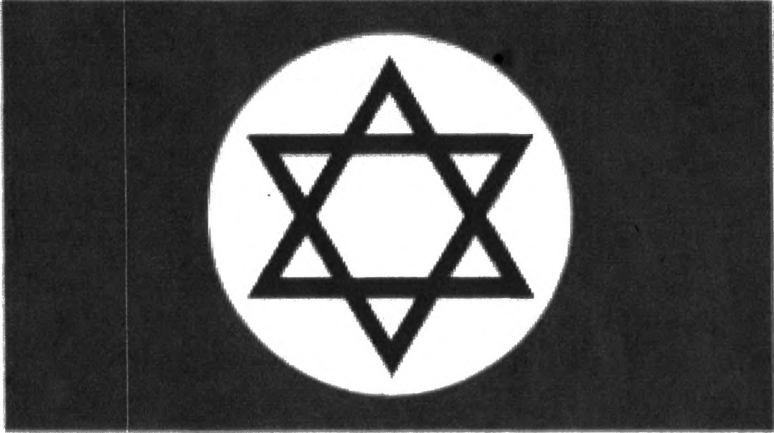
Here’s where the crux of Jewish sickness becomes most apparent. To elite Zionists like the Rothschilds and Theodor Herzl, any Jew not willing to support their cause of Palestinian emigration were therefore no use to them whatsoever. As such, with WW II raging throughout Europe, these Jews would ultimately be abandoned—hung out to dry, so to speak—and the Zionists atop the control pyramid would turn a blind eye as Hitler’s forces rounded them up to use as laborers in their work camps.

by transforming the remaining European Jews into scapegoats and forfeiting them to concentration camps where thousands would ultimately die from starvation and disease. Of course, after the war, they would then claim that Hitler's henchmen had horribly executed the deceased in abominable concentration camps. Only evil geniuses could hatch such a plot.

But when the truth is told, Jewish rabbis were most certainly able to negotiate with Nazi guards to have Jewish prisoners released from their work camps. They chose, however, not to do so because these Jewish "betrayers" needed to be the sacrificial lambs on the altar of their Zionist cause.

While rabbis refused to assist captured Jews, many Jewish policemen assisted in rounding up fellow Jews and placing them in work encampments. At these facilities, another dirty secret is that many of the guards were also Jewish [i.e. *The Sonderkommandos*].

In closing, the actual mass murderers that incited WW II and led thousands of their own people to die in Nazi work camps were Jews themselves such as Chaim Weizmann, Israel's first president, David Ben-Gurion, and elite European Jewish families such as the Rothschilds. If a Jew balked at being harshly relocated to Palestine, they were cut off like branches from a tree. Their fate was one of worms or dust being trampled underfoot of a much larger Zionist cause.

Only the secret elite shall survive, using as their pawns other unwitting Jews that forsook their lives in Europe to build a new Israeli state in the Middle East. All the rest . . . let them die, the Zionists concluded, washing their hands of them.

Or, as Ben Hecht wrote in *Perfidy*, "There was a strong similarity between our attitudes in the SS and the viewpoint of these immensely idealistic Zionist leaders. I believe that [Rudolf] Kastner [an associate of David Ben-Gurion] would have sacrificed a thousand or a hundred thousand of his blood to achieve his political goal. 'You can have the others,' he would say, 'but let me have this group here' [the elite Jews]. Because Kastner rendered us a great service by helping keep the deportation camps peaceful, I would let his group [the elite] escape. After all, I was not concerned with small groups of a thousand or so Jews . . . that was the 'gentlemen's agreement' I had with Kastner."

Despite decades of propaganda, the Jews that perished in these camps didn't do so at the hands of some inhuman SS extermination machine. Rather, they starved and died of diseases orchestrated by the handiwork of their own diabolical Zionist leaders that allowed Allied forces to bomb German supply lines.
