Br. Ryan,

Firstly, congratulations on passing your CDL test. And it is good that you are going to start paying off your debt, which is about \$100,000 dollars: \$85,000 to Sr. Marylou, \$8,500 to Br Phil on the Credit Card, and \$5000 from Br. Alex. If the debt is not paid off on Br. Phil's Credit Card, they will come after him for the money.

If you were keeping your records properly and running your business the right way, you would have never got into such a mess. And once you knew you were in trouble, you should have cut your losses before it got worse. The worse thing is that you did not ask counsel from me when you knew you were in trouble. And that is a sin of pride. When people give you counsel, you do not take it well. You tend to rebel against it:

“Pride goeth before destruction and the spirit is lifted up before a fall.” (Prv. 16:18)

And even worse, you did not take counsel from me regarding the job you took, which is also a sin of pride. So all in one day, I learnt that your business went bust and you took a job that will separate you from us Catholics for at least one year. You could have found a job close to home so you would not be separated from us for such a long time. Even if you did not make as much money, you still could have paid off your debt but slower, and at least, you would be around your Catholic brothers. Instead, you placed yourself, by your own choice, around unbelievers, when the Antichrist is on the verge of coming to power. It is one thing if you have no choice, but you chose this path. You are now stuck in it. If you sincerely confess your sins of pride and the sinful way you handled your business, this job at Prime Trucking will be a penance for you. If not, this job will be your downfall, as you will become more-and-more worldly and distant from us good Catholics until you completely fall away.

You do not seem to realize that the Catholic faith and Church is way more important than anything. One example is the when MLH had problem with the solar batteries. I asked for your help, and you could not even come for one day to help. I had to turn on the pole. I cannot help but think that one of your motives for moving away from us is that you do not really want to help us out at the ranch, and worse to not help out your parents who are old. You, by your own choice, moved so far away from your parents so that you could not even help them if you wanted to.


You must now prove yourself by making enough money pay off your debts and to support yourself.

**Declaratory Sentence of Excommunication of Ryan, Bruce, and Laura Gott
(12/7/2026)**

By Richard Joseph Michael Ibranyi (the Sole Ruler of the Catholic Church)

Ryan Gregory Gott, Bruce Edward Gott, and Laura Lynn Gott, led by the Devil, having abandoned through schism the promise they had made in the *Profession of Faith for the Days of the Great Apostasy*, have not feared to explicitly disobey and leave the Catholic Church of God. Ryan left the Church on 12/1/2025; and his parents, Bruce and Laura, followed him in schism on 12/4/2025. Consequently, they have incurred ipso-facto (automatic) excommunication.¹

Ryan has shown himself to be rebellious, disobedient (even to the point of not accepting or seeking good counsel), spoiled, irresponsible, wasteful, undisciplined, selfish, greedy, disrespectful, and cowardly. On 12/1/2025, I admonished him for not communicating with me (his spiritual father) or the other brothers in any way (except for his parents) for some time, and thus I told him that he was suspect of schism. And I told him that I suspected he was not sufficiently doing the three pillars of prayer, studying the Catholic faith, and penance. Instead of heeding my admonishment he rebelled and left the Catholic Church on 12/1/2025. And on 12/4/2025, instead of condemning their son, his parents, Bruce and Laura, defended him in his schism and laid some, if not most, of the blame on me. Therefore, they share equally in the schismatic guilt of their son and thus have incurred ipso-facto excommunication from the Catholic Church for the mortal sin of schism:

Pope St. Gregory the Great, Book 9, *Epistle 110*, To Theoderic and Theodebert, Kings of the Franks, 6th century: “Since he who neglects to amend what he is able to correct, undoubtedly has the guilt of the doer.”²

Pope St. Gregory the Great, Book 10, *Epistle 42*, to Eusebius, Archbishop of Thessalonica, 6th century: “For he who does not correct things that should be cut off commits them.”

Second Council of Constantinople, 553, confirmed by Pope St. Leo II in 683: “It is clear to all believers that when a problem about the faith [or schism] comes up, it is not only the heretical [schismatic] person who is condemned but also the person who is in a position to correct the heresy [schism] of others and fails to do so.”

Therefore, in my concern over this, I do not desire that I perish because of any pastoral neglect of my own. For before the dreaded Judgment seat, I will have to render an account to the Prince of Shepherds, Our Lord Jesus Christ, in accordance with the terrible warning the Lord himself addresses to us with these words: “If thou dost not speak to warn the wicked from his wicked way, to save his life; the same wicked man shall die in his iniquity; but his blood will I require at thy hand” (Ez 3: 18) Therefore, reprehending Ryan, Bruce, and Laura Gott with paternal affection, I have warned them so that they might conquer their malice and not fall into schism. But they—O woe!—despising the salutary admonitions of the Catholic Church of God, which they have offended, and led by the spirit of pride, have left the Catholic Church and fell into schism of their own accord. And this is yet another fulfillment of St. John’s words,

“They went out from us, but they were not of us. For if they had been of us, they would no doubt have remained with us; but that they may be manifest, that they are not all of us.” (1 Jn. 2:19)

And in their case, since they have been in the Catholic Church for so long, God’s following words, spoken by the holy Prophet Ezechiel, applies to them:

“Yea, if I shall say to the just that he shall surely live, and he, trusting in his justice, commit iniquity, all his justices shall be forgotten, and in his iniquity which he hath committed, in the same shall he die.” (Ez. 33:13)

And Jesus says, only “he that shall persevere to the end, he shall be saved.” (Mt. 24:13)

The precepts of the Lord and of the Apostles speak clearly about what to do with such prevaricators. For the Lord says, “But if thy brother shall offend... and...will not hear the Church, let him be to thee as the heathen and publican.” (Mt. 18:15-17) And the Lord says, “Wherefore if thy hand or thy foot offends thee, cut them off and cast them from thee.” (Mt 8:18)

Therefore, carrying out the precepts of the Lord and of the Apostles, I declare that Ryan, Bruce, and Laura Gott have taken themselves from the body of the Catholic Church with the iron tongs of ipso-facto excommunication. They are putrid and incurable and refuse to accept the remedy. Hence, I make this declaratory sentence so that the members of the body may not be poisoned by such a pestiferous disease and to prevent scandal and protect the reputation of the Catholic Church and faith. Ryan, Bruce, and Laura have despised my admonitions and my exhortations; having been warned, according to the precept of the Lord, they would not amend themselves. Instead, they fell into schism like the Children of Core. And with their hearts hardened by the Devil, they persevered in evil, according to the words of the Apostle: “The impenitent heart stores up to itself wrath for the day of wrath.” (Rom 2:5)

Wherefore, by the judgment of God Almighty, the Father, the Son and Holy Spirit, of St. Peter, Prince of the Apostles, and of all the Saints, and by virtue of the power which has been given me as the sole ruler of the Catholic Church of binding and loosing in heaven and on earth, I declare that Ryan, Bruce, and Laura Gott (with all their accomplices and all their abettors) have been deprived of the Communion of the Body and Blood of Our Lord. I declare them to be separated from the society of all Christians. I declare them to be excluded from the bosom of our Holy Mother the Church in heaven and on earth. And I declare them to be automatically excommunicated and anathematized, as well as judge them condemned to everlasting fire with Satan and his angels and all the reprobates. So long as they will not burst the fetters of the Devil, abjure from their pride and schism, confess their sins, and make reparation to the Catholic Church

and Catholic God whom they have offended, I deliver them to Satan for the perdition of their flesh, with the hope that they repent and their souls may be saved on their day of judgment.

Anathema to Ryan, Bruce, and Laura Gott and to those who give credence to them. He who does not anathematize them is a schismatic. He who is in religious communion with them or performs religious acts with them, let him be anathema. He who is in unnecessary secular communion with them, let him be anathema.

All the faithful here present and those online, say with one voice:

So be it, so be it, so be it.

Praise be to Jesus, Mary & Joseph!

Dear Bro. Richard,

This letter is our response to the situation of our family being excommunicated.

We have several points to address. Here are the main points expressed in as general terms as possible to make this letter as brief as possible. We do not agree with either the accusation to Ryan of schism or our family's excommunication. Our opinion is that Ryan left MLR under the burden of rash oppression caused by RJMI.

222. Catholics Must Judge Sinners including Mortally Sinful Superiors In order to condemn sin and denounce sinners; Catholics must make judgments as to what is sin and who is a sinner. Hence when obliged to, Catholics must condemn sin and judge and denounce sinners, including mortally sinful superiors. Regardless of the fact that we detest having to admonish you, it is our spiritual duty to your soul as well as ours. We have been under duress ever since Nov. 4th when you made your false accusations to and about Ryan.

1. We think you are wrong in telling Ryan that he was sinning because he wanted to be a truck driver. Ryan's reasons for getting a job as a truck driver were correct, especially under the circumstances of his large debt. How is that a sin? Where is the rule that says a member of MLR must accept whatever vocation that Richard, the sole leader of the Catholic Church says you must do. No priest or bishop would tell someone what their vocation must be, unless the person was choosing a sinful vocation. He is a 31-year-old man now and is capable of making his own decisions. Because his source of income from the business had dried up, as well as the market garden income, it seemed wise to us as his parents, that he wanted to make as much money as he could as fast as he could and get out of debt as soon as possible. He has the opportunity with Prime to make up to \$100,000 gross per year. Even though we like you, did not like the fact it meant he would be away from us for extended periods, we felt this was a reality we all had to face and accept. The fact that you took it upon yourself to override our counsel in this matter was not your privy. Ryan did get counsel. He got counsel from us, his parents. Another reason Ryan wanted to make more money by selling year-round was for Alex to be paid a decent wage... In addition, he wanted to help MLR with \$.

2. Bro. Richard, your authority encompasses only religious matters. This was a secular matter. Ryan has the right to choose the job and vocation he wants and sees as necessary. You have sinned against the Holy Spirit by usurping His direction with a soul regarding his vocation. You also usurped our parental rights to counsel our son by demanding your will over Ryan's desire for his future. St. Paul teaches that the Holy Spirit directs the desire for each vocation into the heart of a person. 1 Cor 12:7-11: "And the manifestation of the Spirit is given to every man unto profit. 8) To one indeed, by the Spirit, is given the word of wisdom: and to another the word of knowledge, according to the same Spirit; 11) But all these things one and the same Spirit worketh, dividing to everyone according as he will. 25) That there might be no schism in the body; but the members might be mutually careful one for another." 28) And God indeed hath set some in the church; first apostles, secondly prophets, thirdly doctors; after that, miracles; then the graces of healings, helps, governments (secular employments)". Bro. Richard, we agree that we

must do what you say regarding spiritual matters, but your authority does not extend into the secular personal life realm unless you know of something sinful that needs to be addressed. Especially when there are parents present to do the job God that gave them to advise their son. This is a grave sin you have committed along with other sins we will point out in this letter for the good of your soul. We are shocked and hurt by you as well as Ryan being hurt to the point of crying. Our hearts are very heavy having to write this.

3. Why did you do a180 approx. a month after he was already at Prime in training? The day Ryan left to go to Prime you gave him a blessing and after he was gone you posted congratulations on Discord for his passing each stage of the training and you gave another congratulations on getting his CDL with your 11/4 letter. It looked like you approved of or at least accepted Ryan's new endeavor and decision for about a month. But by 11/4 he is "sinful" for his decision to get a CDL to make good money to repay his debts by driving truck. You allowed Sal to drive truck, and when he got a different job, it still took him away from the MLR home base for long periods of time. When Ryan was travelling to California, Colorado, Arizona and Utah to procure fruit and produce with the new truck, he was away from Bruce and I and his Catholic family for about a year. He usually saw us only a ½ day per week. You approved of his absence then. But you object to it when he wants to be a Prime driver. Why did it take at least a month for you to decide this trucking job was a **sinful** endeavor? Was someone twisting your ear convincing you to change your mind, by calumniating Ryan? My Bible reading on 12/1 was Proverbs 24: vs. 9) "The thought of a fool is sin; and the detractor is the abomination of men." 21) My son, fear the Lord and the king: and have nothing to do with detractors." "And a false calumny, all are more grievous than death." Eccus. 26:7 This inconsistent contradictory behavior by you is confusing to us.

3. [sic] As soon as you heard about the fruit business going bad, you blamed Ryan for it and calumniated him by calling him a bad and sinful businessman, "rebellious, disobedient (even to the point of not accepting or seeking good counsel), spoiled, irresponsible, wasteful, undisciplined, selfish, greedy, disrespectful," etc. The following sentences illustrate how you wrongly accused Ryan of the fact he wants to be around pagans over Catholics: "Instead, you placed yourself, by your own choice, around unbelievers. I always say that if a so-called Catholic has a chance to be around good Catholics and make less money or be around pagans and make more money and he chooses to be around the pagans, then he is either a bad Catholic or he is a fallen away Catholic either by heresy or schism." Here you also calumniate Ryan by implying he is a so-called Catholic, fallen away either by heresy or schism. He believes in NO heresies. AFTER his CDL training he will have his own truck and will be by himself with his laptop and phone, he will not be with any pagans. He would have the ability to call anyone he wants and go on Discord when he has time off. During training, Prime monitors his sleep hours, driving hours, and off duty hours. Ryan and his trainer have been trying to rack up as many miles as they can so Ryan can get into his own truck sooner. He will make more money once he is out of training. After Ryan's apology, you did not care to find out the reason(s) why he was not able to get online for the 10-12 day period from the last post he made. You just swiftly and rashly judged him as a schismatic. As if that is what you wanted him to be. Many people in MLR have not been on Discord for a period of 2 weeks, but you did not oust them as schismatics. Ryan did tell you at the time of his apology, that he would be very busy and so he did not know how it would go. You did not have any understanding of the circumstances, nor did you care to ask him or warn him again. Bro. Sal has been working directly with pagans in his job, but you do not call him a schismatic. It would be one thing if Ryan wanted pagans as friends, but it was only a consequence of the job that he'd be with outsiders for a time. Any person who has a job in this world is associated with pagans, whether they want to be or not. Just going to the grocery store

puts one in proximity to pagans. That is different from being or **wanting** to be in association with them, religiously or secularly. Your statements here are so off-based it is hard to believe you even said them Bro. Richard.

4. You also accused Ryan of abusing MLR's charity. --"Many have refused to lend, as they were afraid to be defrauded without cause." (Eccus. 29:10) "Evil suretyship hath undone many of good estate. . ." (Eccus. 29:23-25) How was Ryan in an evil suretyship and abusing MLR's charity when he was paying Marylou a payment every month as agreed upon, and paid off the credit card every month, until the business did not produce enough income. Then he paid the minimum amount on the card so that he could buy time until he would be paid by Prime and then he could pay it off. He got permission from Marylou also at this time to have a few months leeway until his income from Prime came in. She agreed to it. How was this being an evil sinful business man or abusing charity? You, without knowing the circumstances, leave the impression that Ryan squandered the money and defrauded Marylou of \$ from the business. (calumny again) On the contrary, sadly, you are the one who has sinned against charity by calumniating our son by putting out to ALL of MLR's members your rash and erroneous accusations without anything to back them up. You give one example, the power pole example in which you lied. Quote: "One example is when MLH had a problem with the solar batteries. I asked for your help, and you could not even come for one day to help. I had to turn on the pole." BUT you left out the part that Ryan was 414 miles away selling in Phoenix. And you sinfully lied by omission to make it sound worse than it was. No one that we know of would ask that, just to save \$25 on the pole connection. That was an inconsiderate and selfish request. The \$2,000 tithes he gave MLR was an overblown amount as the business did not have that much money, and he gave it anyway. Is that being uncharitable?

5. The church rule for admonishments is to first go to the person in private and question him; if he will not hear you, bring a witness and question him again. If he is still obstinate, then bring him to the Church to be judged. You skipped the first two steps and proclaimed your inaccurate and rash judgments without knowing anything. I am so surprised at this behavior as you teach us this rule but you do the opposite. It saddens us Bro. Richard. We do forgive you in our hearts though, as we know emotions can get the best of any of us at times. We believe that you were reacting out of emotions being upset that Ryan would be gone for 2 years. Yes, we were sad about this as well. His plan was to pay his debts the first year and the second year to save for his future, his parents old age and for MLR. He wanted marriage in his future. You gave the sinful impression that Ryan did not love his parents but was abandoning them. We can still function now, but maybe not so a few years from now. If he waited on his CDL, maybe it would be too late by then.

6. Before you gave Ryan or us a chance to respond, it was "END OF DISCUSSION". We had less than 3 days to respond, whereas, you gave Jane and Marie a couple of months. Ryan did not want to leave MLR. I thought a fair trial was that each side got a chance to testify in their own behalf. Instead, almost instantly without any investigation by you, you implicated Ryan as a schismatic BEFORE he left MLR, then shortly after we were accused. So, this proves that you rashly judged and calumniated Ryan. Please give us examples (evidence) of when he was a bad Catholic, a sinful businessman, irresponsible, wasteful, undisciplined, selfish, and greedy. Ryan is one of the most responsible people in MLR. He's done everything you ever asked him to do, out of the goodness of his heart. You have lectured on how one must have evidence before making judgements. If you do not have evidence, then you have calumniated Ryan, a grave sin. And we know you love our son, so why?? (Jn. 7:24) "[Jesus says,] Judge just judgments." On the contrary, sadly, you are the one who has sinned against charity by calumniating our son several

times and by quickly putting out to ALL of MLR's members your rash and erroneous accusations without having anything to back them up; except for the power pole example in which you lied. This is what you said: "One example is when MLH had problem with the solar batteries. I asked for your help, and you could not even come for one day to help. I had to turn on the pole." BUT, , to make it look worse you left out that Ryan was in Phoenix selling, 414 miles away. No one I know would make a request like that just to save a \$25 connection fee. And when he got home the correct solution to the batteries getting charged evenly was done. You were not thinking of Ryan's circumstances, just as you did not want to know the circumstances of the business failure, which were beyond Ryan's control. In summary, these are your sins:

1. Sins against the Holy Spirit.
2. Not abiding by the rules of the Catholic Church regarding admonishments.
3. Lying by omission.
4. Rash judgements without knowledge of circumstances.
5. Not asking or investigating the situation before you made accusations. Jumping to conclusions.
6. Calumny, not once, but several times.
7. Accepting Ryan's (coerced) apology from the 11/4 admonishment then ignoring his apology by accusing him again of schism without knowing the circumstances or asking about reasons.
8. Being harsh, cruel and hurting your faithful followers.
9. Abusing your power.
10. Being selfish, overbearing and inconsiderate.

It is quite possible, that because of all these sinful errors in your thinking and behavior that your admonishments of Ryan and his excommunication are invalid. I would think they would be when the admonishments and excommunication are based on false information. I would think that Our Lord would throw them out as they are based on unjust judgments. But again, I cannot speak for Christ. This is scary to think you are capable of all the above actions as the "Sole Leader of the Catholic Church".

RJMI's response to the Schismatics Bruce and Laura Gott (12/10/2025)

Bruce and Laura,

Laura, this is my response to your letter dated 12/2 and 6, 2025, which you sent to me by email on 12/7/2025.

The Crux of the Matter (His insincere confession and leaving the Church without giving the reason)

First and foremost I am going to cut through the fog screen, the fairy dust, your excuses, evasions, lies, and false accusations and get to the crux of the matter. And then I will deal with your other comments.

After I admonished your son, Ryan, on 11/5/2025, he confessed his sins to me on the same day. Here is what he said:

Ryan Gregory Gott 11/5/2025 2:08 PM

Praise be Jesus Mary and Joseph!

Thank you Brother Richard for your admonishment. I accept your admonishment and I will confess my sins. Yes that is my goal to pay off my debts as quickly as possible. And I'm sorry for not asking you for counsel. Please forgive me and pray for me. I'm getting ready to go on my truck with my new trainer this afternoon. I'll try and be online more when I can but I'm going to be very busy I'll be team driving so I don't know how that's going to go just yet. Sorry about all this mess! God bless you! You're Brother in Christ Ryan.

I did not coerce his confession, as you said I did:

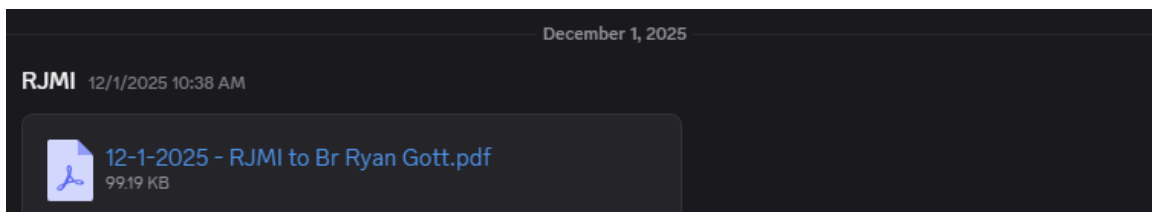
Laura to RJMI, 12/7: "In summary, these are your sins: ... Accepting Ryan's (coerced) apology from the 11/4 (11/5) admonishment then ignoring his apology by accusing him again of schism without knowing the circumstances or asking about reasons."

I did not put a gun to his head. Who are you to undo his confession, you murderer of your son's soul. This applies to Bruce also. You would both have him not confess at all. That his confession was insincere is another matter, which proved to be true, and maybe because of your influence. And I did not accuse him of schism but of being suspect of schism.

After Ryan's confession, I never heard from him again at all, not even regarding this very, very serious matter. He did not message me on the Discord or email asking for counsel, guidance, or prayers. And after his confession and about two or three weeks before he left the Church, he did not communicate with the brothers on the chat site other than to say he could not attend Mass prayers. And the last week before he left the Catholic Church, he did not send any message to any of us brothers. But at the same time, he was in constant communication with both of you. Well, that is when I strongly suspected him of schism. I knew he was drawing away from me and the rest of the brothers, and more importantly, from me, his spiritual father. Yet he was conversing with both of you, if not daily, at least quite often.

I remind you, that when it comes to spiritual matters (such as sins, near or proximate occasions of sin, and of counsel and guidance regarding the spiritual welfare of my flock), I am over you in authority, as much as the heavens are above the earth, the soul over the body. (See my lecture *A Spiritual Father Is above a Biological Father*). You are subject to the Catholic Church, the Catholic Church is not subject to you. And Ryan's problems and sins are not only secular, as you pretend, but they are also spiritual, as it involved sin and the spiritual welfare of his soul.

Well, after that last week before he left the Church, I strongly suspected him of schism, and I suspected he was not sufficiently doing the three pillars of prayer, studying the Catholic faith, and penance. So I sent him this following message. Take special care when you read this message, that I did not say anything about his trucking job or anything about his debt. It was all about his lack of communication with me, his spiritual father, in very important matters that involved the spiritual welfare of his soul, and my suspicion that he was not sufficiently doing the three pillars:



12/1/2025

Br. Ryan,

I, nor any of the brothers (other than your parents), have heard from you. You should have at least been in contact with me, your spiritual father, to ask for prayers and counsel.

“My son, do thou nothing without counsel, and thou shalt not repent when thou hast done.” (Eccus. 32:24)

“The prudent man doth all things with counsel: but he that is a fool, layeth open his folly.” (Prv. 13:16)

“Give ear, my son, and take wise counsel, and cast not away my advice.” (Eccus. 6:24)

“A frame of wood bound together in the foundation of a building, shall not be loosed: so neither shall the heart that is established by advised counsel.” (Eccus. 22:19)

This, you have not done. You have not asked for counsel from me, your spiritual fathers. Instead, you disrespect and ignore me. This is one proof you are puffed up with mortally sinful pride and rebellion. All the brothers (except maybe your parents) know that your behaviour is very strange and not right.

It seems you have no idea of how great a sin you committed and the sins you are now committing by not communicating with us, especially with me. You have no idea of the danger you are in. Your lack of communication with us is one proof that you are in a state of obstinate mortal sin and suspect of schism. If you die as such, you will be damned to Gehenna.

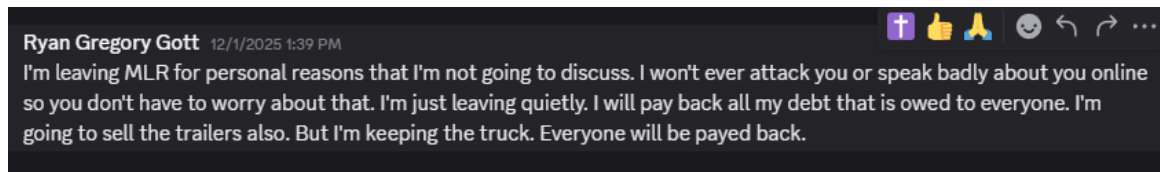
I suspect you are not sufficiently doing the three pillars, nor are you coming online with us with prayers when you can.

BTW: You should sell the truck and containers and give the money from the sale to Sr. Mary Lou. This way, some of your debt will be paid off. I remind you that if you had this kind of debt with a bank, it would confiscate enough of your things to pay off the debt, even your house if need be.

Instead of heeding my admonishment or even talking to me about it, he just left the Catholic Church and said he will not even tell me why. Here is what he said:



It was Ryan, not me, who refused to discuss the matter. He could have called or wrote me about his problems (as he was calling and speaking to both of you at this same time), but he did not. I cannot force him to talk if he does not want to. And he can still contact me and abjure from his schism, but he has not. Yet, you put the blame on me. Woe to you, you wretched and accursed parents.

So by his own words, your son left the Catholic Church and thus fell into schism. Therefore, my suspicion of him being in schism turned out to be true. And even if my suspicion turned out to be wrong, which I hoped it is was wrong, that is not a sin on my part. Instead, it is my duty as his ultimate spiritual father to make such accusations when certain actions appear to be sinful or leading to serious sin.

So, now let me throw some more of your many lies in your face. You said,

Laura Gott, to RJMI, 12/7/2025: “After Ryan’s apology, you did not care to find out the reason(s) why he was not able to get online for the 10-12 day period from the last post he made. You just swiftly and rashly judged him as a schismatic.

Firstly, I did not judge him as a schismatic but as suspect of schism:

RJMI to Ryan, 12/1: “Your lack of communication with us is one proof that you are in a state of obstinate mortal sin and suspect of schism.”

Secondly, it is he who did not give me the reasons why he left the Church. I would have been more than glad to hear his reasons and discuss them with him. I remind you, he said, “I’m leaving MLR for personal reasons that I’m not going to discuss.”

And then you said that in my letter to Ryan on 11/5/2025 I called Ryan a so-called Catholic. Well, that is a lie. You clearly took my words out of context. My following statement was a warning to him so that if it applied to him, then let the shoe fit. Here is what I said.

RJMI to Ryan, 11/5: “I always say that if a so-called Catholic has a chance to be around good Catholics and make less money or be around pagans and make more money and he chooses to be around the pagans, then he is either a bad Catholic or he is a fallen away Catholic either by heresy or schism.”

Here is what you said regarding by above statement,

Laura to RJMI, 12/7: “Here you also calumniate Ryan by implying he is a so-called Catholic, fallen away either by heresy or schism. He believes in NO heresies.”

So, you lied again. I did not say he was guilty of these things but only that if he was, then he is guilty. My suspicion was that he was guilty of one of these things, schism, but not heresy. I never said he was guilty of heresy or even suspect of heresy.

Well, that is the crux of the matter, regardless of anything else. Now onto your other excuses, false accusation, lies, and evasions.

You lied when you said Ryan’s situation is only secular and thus not also spiritual

You and Bruce bury your heads in the sand and lie regarding the situation with Ryan. You pretend it is only a secular matter and thus not also spiritual. I agree that in purely secular matters, I have no authority. But even in these matters, I can give counsel. Yet, this matter regarding Ryan is also spiritual, as it involves sins and the welfare of his soul. Here is what you said,

Laura to RJMI, 12/7: “Where is the rule that says a member of MLR must accept whatever vocation that Richard, the sole leader of the Catholic Church says you must do. No priest or bishop would tell someone what their vocation must be, unless the person was choosing a sinful vocation. He is a 31-year-old man now and is capable of making his own decisions... The fact that you took it upon yourself to override our counsel in this matter was not your privy. Ryan did get counsel. He got counsel from us, his parents... Bro. Richard, your authority encompasses only religious matters. This was a secular matter. Ryan has the right to choose the job and vocation he wants and sees as necessary. You have sinned against the Holy Spirit by usurping His direction with a soul regarding his vocation... Bro. Richard, we agree that we must do what you say regarding spiritual matters, but your authority does not extend into the secular personal life realm unless you know of something sinful that needs to be addressed. Especially when there are parents present to do the job God that gave them to advise their son. This is a grave sin you have committed.”

As Ryan’s ultimate spiritual father, I take precedence over your counsel in spiritual matters. You said you agree with this. The job Ryan took turned out to be what I suspected, a detriment to his soul in several ways. This job, which he took by his own choice, separated him from Catholics for a long time, for at least 1 ½ years, and thus I suspected that he was running away from good Catholics. And because of the long hours and very few days off that his job entails, I suspected that he was not going to sufficiently be able to do the three pillars. That is beside the fact that I suspected he was not sufficiently doing the three pillars even before he took the truck job. These are spiritual matters. Do you agree! If you did not at least suspect the same of him, then you are bad and sinful parents in this regard. And I suspect you and Bruce are also not sufficiently doing the three pillars or else you would have never fallen out of the Church by schism. The sinful spiritual counsel you gave to your son and your lack of admonishing him has helped to lead him out of the Church, in which you then followed.

The reason I did not at first admonish Ryan

You said,

Laura to RJMI, 12/7: “3. Why did you do a180 approx. a month after he was already at Prime in training? The day Ryan left to go to Prime you gave him a blessing and after he was gone you posted congratulations on Discord for his passing each stage of the training and you gave another congratulations on getting his CDL with your 11/4 letter. It looked like you approved of or at least accepted Ryan’s new endeavor and decision for about a month. But by 11/4 he is ‘sinful’ for his decision to get a CDL.”

To avoid rash judgments, one must look at all the evidence and then pray to God before judgment. To do otherwise, would be a scandal. That is why I did not first say anything until I investigated what Ryan’s job would entail. When I discovered he would be gone for at least 1 ½ years and work long hours and have few days off, I suspected that things I mentioned above. But I did not yet say anything until I had more proof. I wanted to see how he behaved on the job in relation to us Catholics. When I saw that he was communicating with me and us Catholics less and less (which he was also doing three weeks before he got that truck job), then I made my suspicions known to him. And his leaving the Catholic Church proved my suspicions to be true, and proved your counsel to your son be sinful and evil for placing cushions under his elbows so he can rest comfortably in his sins and now his schism.

Also, the problem was not getting a CDL. I never opposed that. It was the way he went about getting it. He could have gotten a CDL in New Mexico and be close to home instead of getting it in Missouri. And his truck job would not have been a problem but a penance for him if he remained in sufficient communication with me and sought counsel from me and not left the Church. Here is what I told him:

11/5/2025

Ss. Zachary and Elizabeth, pray for us

Br. Ryan,

Firstly, congratulations on passing your CDL test. And it is good that you are going to start paying off your debt...

Another thing is that you never or hardly ever attend the Holy Hour or Exorcism Prayer, either in person or online. I know you could not make it many times, but not all the time. I sense you are not sufficiently doing the three pillars...

If you sincerely confess your sins of pride and the sinful way you handled your business, this job at Prime Trucking will be a penance for you. If not, this job will be your downfall, as you will become more-and-more worldly and distant from us good Catholics until you completely fall away...

So I leave you with this. Sincerely confess your sins, do the three pillars sufficiently, and be online with us for prayers whenever you can. If you do, then this job will be a penance, a punishment, for your sins.

So you see, the trucking job was not the main problem but only a symptom of his sins. So you lied when you pretend that my main problem with Ryan was the job he took. That was one problem for sure, but not the main one. His main problems were his lack of sufficient communication with me and of taking counsel from me in very important matters, and of not

sufficiently doing the three pillars. If he was sufficiently doing the three pillars, he would have never committed these mortal sins.

I suspected Ryan about the last three or four weeks before he got the truck job

You said the following,

Laura to RJMI, 12/7: “When Ryan was travelling to California, Colorado, Arizona and Utah to procure fruit and produce with the new truck, he was away from Bruce and I and his Catholic family for about a year. He usually saw us only a ½ day per week. You approved of his absence then. But you object to it when he wants to be a Prime driver. Why did it take at least a month for you to decide this trucking job was a sinful endeavor?”

When Ryan was working the fruit job, he was home one or more days a week. But in his truck job, he will be away from home and us for at least 1 ½ years. But in the last three or four weeks of his fruit job, he was not home at all or only briefly. And during this time, he began to communicate with me and the brothers less and less. That is when I first suspected he had problems. But I did not want to make this public until I had more evidence, which eventually came when he got the truck job and then left the Church.

Take the example of a wife who has become distant to her husband. At first the husband hopes it will pass. If it does not, he accuses her of being distant. If she denies it, there is nothing he can do to prove it. She may even accuse him of a rash and false judgment. But when his wife leaves him, then he has absolute proof. Well, this is what happened with Ryan. I felt his distance from us Catholics and thus the Church for some time, at least about three weeks before he took the truck job. I hoped it would pass. Then he took the truck job and become more distant. When I admonished him, he did confess his guilt. But after that, he remained distant. And when I told him again that he was distant, he left the Church and us Catholics to make his distance manifest for all to see.

Again, Ryan’s leaving the Catholic Church is proof that all my suspicions were true. If you are going to accuse me of a sin, then it could be for me not admonishing him sooner. But I eventually did. And when I did, he left the Church. That should be your main concern. That is the crux of the matter.

He developed a certain lust for money and entitlement mentality

Ryan got so used to getting gifts from MLH members to the point that he felt entitled to them. And I had to exhort him, at times, to pay tithes. And this is a form of greed. And you and Bruce both have this problem also.

I did not say he defrauded Mary Lou but he did squander money

Here is yet another of your lies:

Laura to RJMI, 12/7: “You, without knowing the circumstances, leave the impression that Ryan squandered the money and defrauded Marylou of \$ from the business. (calumny again).”

I never said Ryan defrauded Mary Lou. But I did say he squandered money, which he certainly did. In running his business, he was irresponsible, wasteful, undisciplined, and, a bit selfish in the money that he paid his workers. And when he was given counsel that he was doing something wrong or he could have done something better, he did not take it and many times got angry. For example, Br Will gave him one such counsel, and Ryan got angry at Will and said, "I know how to run my business. Do you think I am an idiot?" Well, it turns out that Ryan was an idiot, not because he did some things wrong, but because he did not seek counsel; and when good counsel was given, he did not take it and correct the things he was doing wrong. That is a definition of not only an idiot but also a fool.

Ryan is known to start a project, given money (mostly as gifts) for it, and then it fails or he quits and then goes to his next project. Take his farm (vegetable) business, in which he was given a good amount of money as gifts to help him. And that failed also. Ryan needs to understand that he can never any more run a business nor be over people. He needs to work for people and be told what to do, as he is doing now with the truck job. It is a gift and takes humility to know what gifts one has and what gifts they do not have. The wrong vocation or job can lead one into sin if they pridefully overestimate their abilities and do not acknowledge their short comings.

On the solar batteries

Here is another lie:

Laura to RJMI, 12/7: "Quote: "One example is when MLH had a problem with the solar batteries. I asked for your help, and you could not even come for one day to help. I had to turn on the pole." BUT you left out the part that Ryan was 414 miles away selling in Phoenix."

The solar batter problem on Mary's Little Ranch was on-going for about one month or more, not just one day when Ryan was in on the road. He was home one or more days during the week during this period of time and would not come out to help with the batteries. He did not realize how important this is to Mary's Little House and the work and prayers done here regarding the Catholic Church. He put his secular business over God and the Catholic Church. His help with the batteries would not have taken him away from his business for more than half a day. And in this, he was also selfish.

He could have arranged his time so that he would be present for at least some of the Lord's Days and been online for a few Holy Hours and Exorcisms

Ryan was the boss of his fruit business, so he could have at least arranged to be present at the ranch for a few Lord's Day. Instead, he was not present for even one. And he was not present at the ranch or even online for a holy hour or the exorcism prayer for about one year or more. Thus he put his business and money over God. I suspected this but did not want to say anything until I had proof of his intentions. The more-and-more distant he got from me and other Catholics, his actions in this regard proved to be sinful. While he was hell bent on making money, he was ignoring God. So God cursed him and his business. If he put God first and was sufficiently doing the three pillars, his fruit business would have been what is should have been, a great success and a great benefit to him, the brothers, and the Catholic Church.

His mortal sins for not seeking counsel when he should have

For Ryan's mortal sins of not seeking counsel and rejecting good counsel when it is given, and getting angry when it is given, see my letters to him from 11/5 and 12/1.

He was admonished and did not listen to the Church but instead left the Church

You said,

Laura to RJMI, 12/7: "The church rule for admonishments is to first go to the person in private and question him; if he will not hear you, bring a witness and question him again. If he is still obstinate, then bring him to the Church to be judged."

I did go to him in private, and he confessed. Right after he confessed, he again became distant to me and other Catholics. Hence, I admonished him again. And that is when he left the Catholic Church. Consequently, I did not even have to make a judgment in this regard because he left the Church on his own accord. And, by-the-way, I am the head of the Catholic Church. Hence I could have passed a condemnatory sentence against him even if he did not leave the Church but continued in his schismatic ways. But he ended up leaving on his own. Therefore, he excommunicated himself. All I had to do was pronounce a declaratory sentence that he had been ipso-facto (automatically) excommunicated from the Catholic Church for schism.

A ruler in the Catholic Church only loses his office by heresy

After you had given a list of my supposed sins, you said this:

"This is *scary* to think you are capable of all the above actions as the 'Sole Leader of the Catholic Church.'"

Well, a true pope, and thus any ruler in the Catholic Church, only loses his office for sins of heresy. So even if I had commit the sins you accused me of, I would still be the sole ruler of the Catholic Church. But if I did not commit those sins, and I did not, then you are the one guilty of lying and calumny.

Also, how come I was not so scary for the 25 or more years that you were under my leadership? You had no problem with me for all those years, even when I admonished and condemned many others, and I kicked them or they left. Yet, when I admonished your son and condemned him for leaving the Church and then admonished you and Bruce and condemned both of you for leaving the Church, I, all of a sudden, turned into an unjust, vile, sinful monster. You and TJ and others that were once with us Catholics have a lot in common. Why did you not condemn me and take TJ's side when he accused me of the things you are now accusing me of? God will choose between me and you wretched schismatics. Every one of the brothers concurs with my judgments and some have much more to add. But in this letter I only referred to your sins regarding this case with Ryan.

I do not care if you believe what I am going to say, but I say for the record. God has confirmed in numerous ways your guilt, all three of you. And Bruce, who is supposed to be the head of the

family but is not, takes the brunt of the blame, then you Laura, and then Ryan. You and Bruce could have been a big help toward Ryan's repentance and abjuration if you also condemned him. But instead, you justified him in his sins, and you all justify one another in your sins and condemn me instead:

“He that justifieth the wicked, and he that condemneth the just, both are abominable before God.” (Prv. 17:15)

“Woe to you that call evil good and good evil, that put darkness for light and light for darkness.” (Isa. 5:20)

“The man that with a stiff neck despiseth him that reproveth him, shall suddenly be destroyed; and health shall not follow him.” (Prv. 29:1)

On, 12/11/2025, Br. Phil McCabe sent me Ryan Gott's Credit Card expenses. I was shocked at Ryan's very excessive spending on meals, motels, haircuts, and some other things. Here is an example of some meals and a haircut:

I will list the hotel and some other expenses below. This is just one more example that Ryan is irresponsible, irrational, and plain stupid, and that he squandered money that he owed to others. When I say stupid, I do not mean he was invincible ignorant. He was not. He knew what he was doing, he knew it was wrong, and he did it anyway, over-and-over again.

And because he owed money to others, his excessive spending was akin to stealing. Even if he paid it back. It is akin to stealing for wastefully using the money instead of using it to pay off some of his debt. For example, if I loan a friend \$1000 for his business, and then he goes out and buys a \$1000 fur coat for his wife or spends it on excessive business expenses, then that is akin to stealing, and also irresponsible and dishonest.

And because Ryan paid his workers so little while he was living high on the hog, it was like stealing from them. He was living high on the hog when he owed money to others and was paying his workers a very, very low wage.

William Norris: "Ryan offered \$50 a day. I took it for a couple days. Brother Alex took it for a couple weeks. And then we decided to go back to \$20 a day because we weren't making that much money. However when Br. Teo was here I would give him \$20 and I would take \$20. So that was \$40. When Sister Cat worked with me I gave her \$10 a day."

His workers would have endured it if his business succeeded; but instead, Ryan was running his business into the ground while living high on the hog, way above his means (spending \$176 on some hotels, \$40 to \$60 dollars on some meals, up to \$222 on oil changes, and \$50 on a haircut). He was like the prodigal son who squandered his inheritance, and worse, because it was at the expense of others. "Make not thyself poor by borrowing to contribute to feasts when thou hast nothing in thy purse, for thou shalt be an enemy to thy own life." (Ecclus. 18:33)

To clarify any misunderstanding, I am not saying spending a lot on meals, hotels, and other items is intrinsically sinful. It is only sinful when you cannot afford it. I am not against rich people spending a lot of money on meals and other things, as long as it is within their means to do so.

Even if Ryan was not given almost \$100,000 but instead used his own money, it would be sinful because he used it irresponsibly and squandered it, and thus he would have still lost his business by his own fault. But, in this case, it would not be akin to stealing because he lost his own money. But when you irresponsibly squander other peoples' money, then that is akin to stealing.

If Ryan just kept a basic income and expense record (as I taught him to do), he would have seen that his business was doomed to fail unless he lowered his expenses.

On top of all this, Ryan was eventually not able to fully pay his credit card debt at the end of the month so as to not incur interest payments.³ Hence he fell into the usurious hands of Jewish and Masonic bankers. The first month he knew that he could not make full payment, he should have adjusted his credit card spending so that he could make full payment at the end of the month. Instead, he went hog wild and kept using the card and getting into more-and-more debt. Since he left the Church, Br. Phil has canceled his credit cards.

And because Ryan is now only paying the minimum payment, he will never get out of debt and it will keep increasing. With the money he is making now (at least \$4000 per month on the trucking job), he can pay his \$9,600 debt off within 4 to 5 months. But if he stops paying, then Phil McCabe incurs the debt.

Here is one example in which Ryan rejected my good counsel. I told him that if he slept in motels (even low cost motels) when he was going to buy his fruit and when he was selling it away from home, his business would fail because the expenses would be too high. He already had to pay a lot for gas and truck insurance and maintenance so that motel expenses would only add to that expense. He agreed and fixed up the back of his truck to sleep in when he was on the road. But this only lasted for awhile. He eventually stopped⁴ and started sleeping on motels, hotels, and Airbnbs. And many of them were not low cost ones but were high priced. For example,

In the 9th month, Ryan spent \$2000 on motels, hotels, and Airbnbs.

I never knew he was sleeping in motels, hotels, and Airbnbs until the day he told me his business went bust and he was leaving us for the trucking job.

Here is another example of good counsel I gave Ryan but he rejected. I told him that if the gas and maintenance expenses would be too high for certain trips, then he should not take those trips but limit them to the ones that would make the most money and incur lower expenses. He did not listen to that. It went right over his head and out the window. Instead, he was going on very long

trips to California, Utah, and Arizona in which he was losing a huge amount of money on expenses in comparison to the money he was making from such trips. It would have been better for less trips with a good net income, than more trips with a loss of income. It is that simple.

Another good counsel I and other brothers gave Ryan was to not buy products that would make less profit and thus to only buy products that made the best profit. The product that does not make as much profit would take up space in his trailer that could be used for the product that makes a better profit. But he rejected this good counsel, which was another major reason his business failed.

And even worse, Ryan bought bad product and tried to sell it to his customers and thus started to lose customers. He should have checked his products before he brought them. But even at that, a bad product can be brought without fault; and if so, it should, as the saying goes, “Be eaten”; that is, not sold and thus swallow the loss rather than lose your customer base and thus lose your whole business. It is not worth losing your business over one batch of bad product. Only a greedy or irresponsible or dishonest businessman would do that. Well, Ryan did this one too many times and lost his customer base, not to mention the scandal it caused. He was told by some of the brothers not to sell bad product, but instead of taking their good counsel, he got angry at them and said to one of them “I know how to run a business. Do you think I am an idiot?” Well, it turns out that Ryan was an idiot, not because he did some things wrong, but because he did not seek counsel; and when good counsel was given, he did not take it and correct the things he was doing wrong. That is a definition of not only an idiot but also a fool.

Here is another example of good counsel I gave Ryan but he did not take it. I told him that the fruit that is beyond its time to sell because it was overripe or not good for selling for some other reason should not be thrown out but should be turned into fruit juice with a press. This way he can sell the fruit juice. I even brought a fruit press for him to use. But he rejected it. And this was a sinful waste of product and a detriment to his business’ net profit.

Here is another squandering and irresponsible act of Ryan. Instead of changing the oil himself on his truck, he paid to get it done. Now, if the price was not too high, that would be acceptable. But he paid up to \$222 to get it done.



This is also sin of lack of frugality. Many times Ryan never checks prices to see the best deal but just jumps in and pays a higher price.

After he rejected my good counsels, I stopped giving it, and he never asked for it. I hoped that he would learn by his mistakes and make corrections in the way he was running his business so that it would eventually succeed. But that did not happen.

Ryan was so stubborn in not asking for counsel that none of us knew his business was in serious trouble until the day he told us that his business went bust and he was leaving for a truck driving job. He, no doubt, knew his business was in trouble several weeks or even months before it failed but never said a word about it or asked for counsel regarding it. And that is pride. He did not want to admit he was wrong for not asking for counsel or taking good counsel when it was given.

Now, for the most serious charge against Ryan. Upon reflection of the high prices he paid for some meals, it did not seem that one person could eat that much at a meal. So my suspicion was that he was eating them with someone else, and most probably a woman. I say that because at the same time he rented out a very expensive Airbnb, he also incurred very high expenses for meals, all or most of which were delivered to the Airbnb. Here is the list of those expenses, all of which were incurred from 9/27/2025 to 9/28/2025:

Hence Ryan spent \$153.28 on an Airbnb and then \$325.04 that day and the next on food—\$478.32 in two days. And all or most of the meals were delivered to the Airbnb. It is not likely all the food was for him. And the fact that he rented a high priced Airbnb, all lead to the grave suspicion that Ryan may have committed fornication with a woman. And this is when he was already very spiritually distant to me and the other brothers, so he was already in deep mortal sin. Ryan’s possible sin of fornication also explains his being in AZ for long periods of time, as he may have been courting this woman before he took her to the Airbnb. And only six days after his possible rendezvous with this woman, Ryan told all of us on 10/4/2025, the seventh weekday, that his business went bust and he was leaving for a truck driving job. And he then left for the job on 10/9. Either the woman spurned him or he got a pang of conscience. But running away as he did without confessing his sins was only running further into Satan’s camp. So in this Ryan is also like the prodigal son who lived riotously. But there is another difference, Ryan’s father and mother are as evil as he is for making excuses for his sins. But if Ryan sincerely repents, abjures, and confesses his sins, I will open my arms like the father of the prodigal son and receive him back into the Catholic Church with great joy.

Ryan, if this gave suspicion is not true, then please explain. Know that if you lie, you will only fall deeper into mortal sin. You cannot hide from God.

RJMI to the Gotts on No Answer, Nothing Paid Yet to Mary Lou, and the Money Ryan Owes (2/10/2026)

To Ryan, Bruce, and Laura Gott,

Firstly, none of you responded to my last admonishment: (See RJMI on Ryan's Very Excessive Spending, Gross Mismanagement of Business, and Grave Suspicion of Fornication (12/13/2025)," p. 28.) Hence your silence indicts all of you. And Ryan's silence indicts him on the grave suspicion that he committed fornication, and thus it is presumed to be true. And you, his parents, do not seem to care about his silence in this matter.

Secondly, Ryan has been working on the truck job for several months and makes at least \$900 a week. Yet, he has not paid a penny to Mary Lou to pay off his debt to her. And, worse, he has not even contacted her to tell when and if he intends to pay anything. So he is guilty of yet another mortal sin of stealing. I remind you of the seventh commandment:

“Thou shalt not steal.” (Ex. 20:15) (Rom. 13:9)

Ryan is like Judas who stole money from Christ and Christ's apostolate:

But Will had \$621 of Ryan's money from the fruit business in Ryan's money box. So that is deducted from the \$77,025.40 to get \$76,404.40. Therefore, Ryan owes Mary Lou **\$76,404.40**.

Lastly, if you do not abjure your schism and confess your sins by Resurrection Day 2026, I will make public on my website these letters and the excommunication decree against all of you.

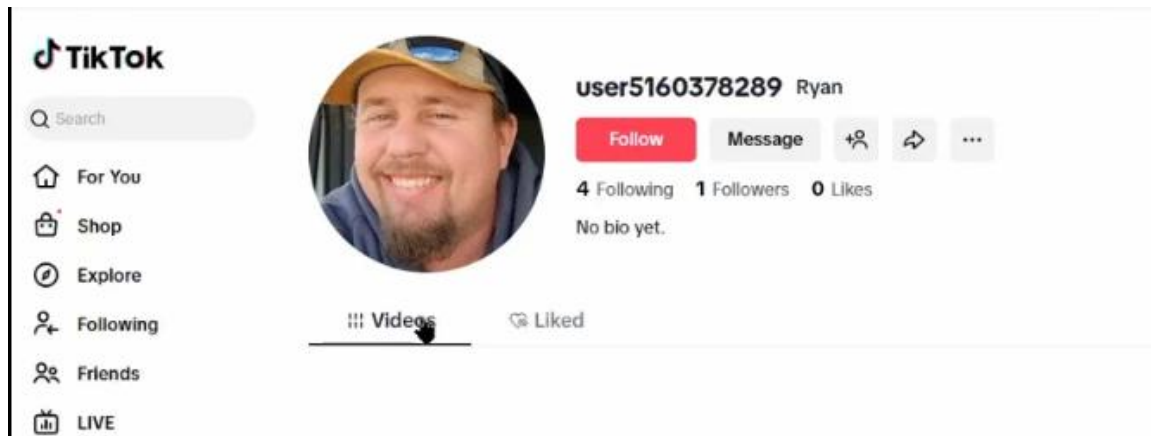
