Originally constructed as part of the Work Progress Administration's local development projects in 1938, what is

now recognized as the Lee Bell Johnson building in downtown Truth or Consequences was initially designated to serve as the then-Hot Springs City Hall and library. Reflecting a Spanish-Pueblo Revival style construction, the building was named in honor of local Cowboy Poet Lee Belle Johnson. With a large auditorium and ample office space, the facility has served the city in numerous capacities. After first housing the municipality's offices and the library, the building would later be utilized as a community center, hosting a wide range of events and ac-
